The Planning Board of the City of Cambridge will hold a public hearing on March 29, 2021 at 6:30 p.m., conducted remotely (see below for directions) on a Zoning Petition by the City Council to amend Article 22.000 of the Zoning Ordinance of the City of Cambridge to add a new section 22.24.4 Emissions Accounting.

The proposed amendments would require applicants of most Green Building Projects to provide, as part of their compliance with the Net Zero Narrative in Zoning section 22.25.1(c)2, an accounting of greenhouse gas emissions generated by construction, the expected annual emissions generated by routine building operations, lifetime expected emissions until the year 2050, and total expected emissions. This requirement would not apply to any residential buildings that include affordable units. The Zoning Petition identifies specific types of emissions that shall and shall not be included in each of these calculations.
