The Planning Board of the City of Cambridge

will hold a public hearing on **Tuesday, August 31, 2021 at 7:30 p.m.**
located at Remote participation on Zoom (see details below)
on special permit application case PB-381
for the property located at **544 – 550 Massachusetts Avenue**
for which the Applicant is Central Square Redevelopment LLC
seeking special permits pursuant to Exclusion of basement GFA from total GFA calculation (2.000); Additional height in Central Square Sq. Overlay (20.304.2.2(a)); Additional FAR for residential uses(20.304.3); FAR Exemption for Rooftop Spaces (20.304.3.6); Waiver of yard setback requirements (20.304.4.1); Waiver of private open space requirements (20.304.4.2); and Waiver of parking and loading requirements (20.304.63(b))
for a proposal to Construct a residential addition of 29 dwelling units to the existing commercial building footprint. The final gross floor area proposed would be 20,082 square feet with exemptions allowed by the special permits.
