Additionally there will be four sections of stair railing. We will be matching the paint exactly. The turned sections, rails, and posts will be indistinguishable from wood and will be detailed to look as closely as possible as existing.

Existing fences are made of wood and PVC. The short fence is all wood, the taller fence (not in our scope of work) has all the vertical T&G members made of Versatex.

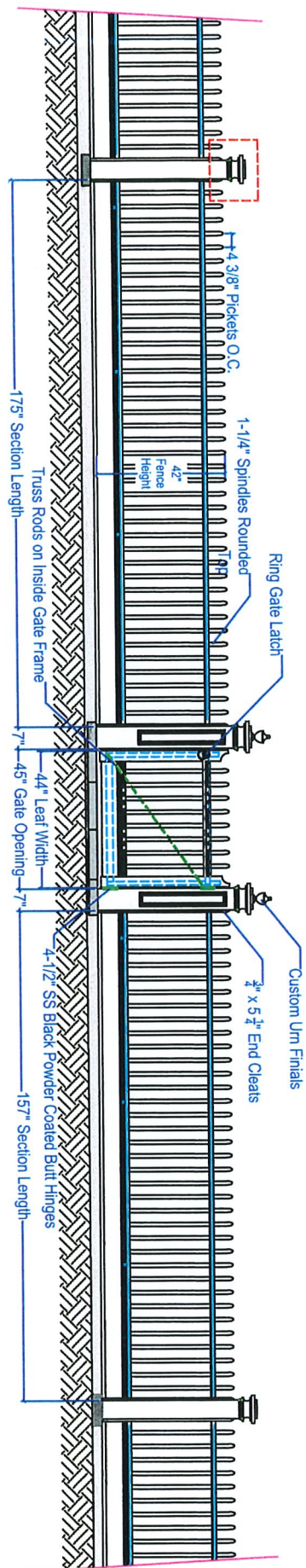

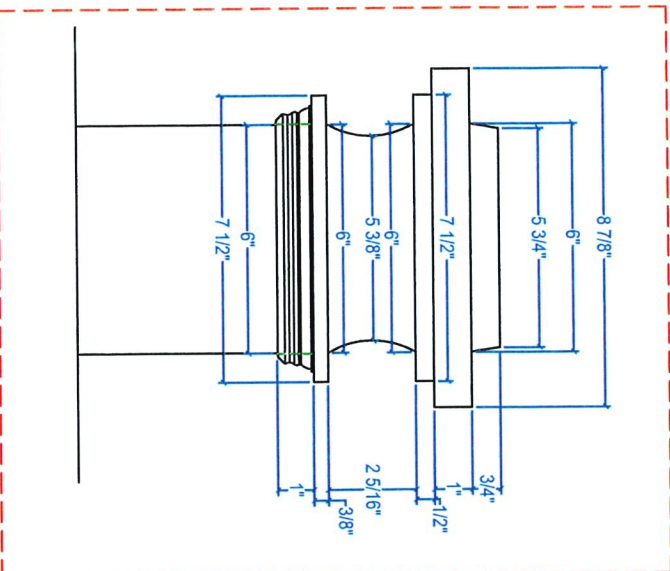

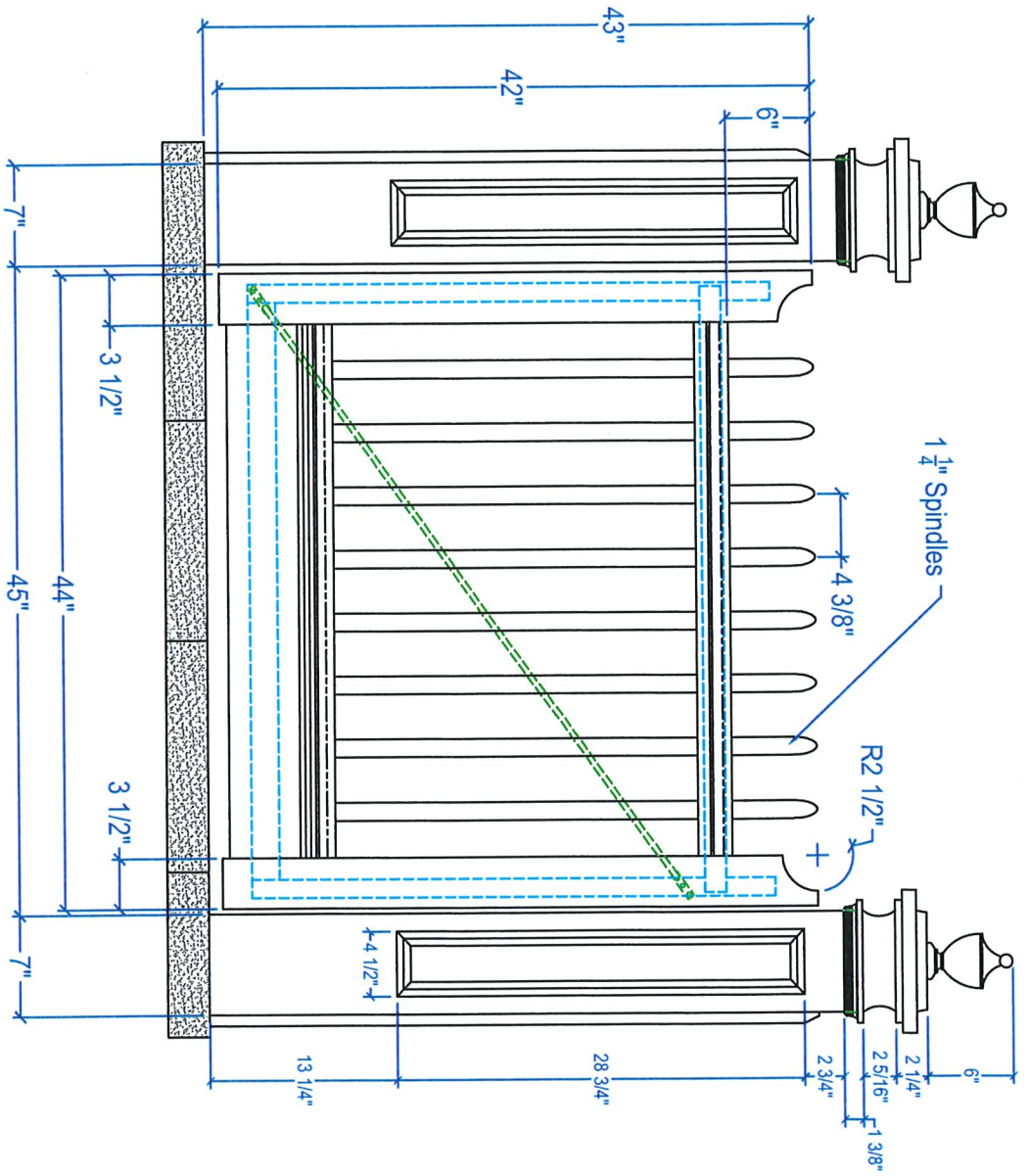

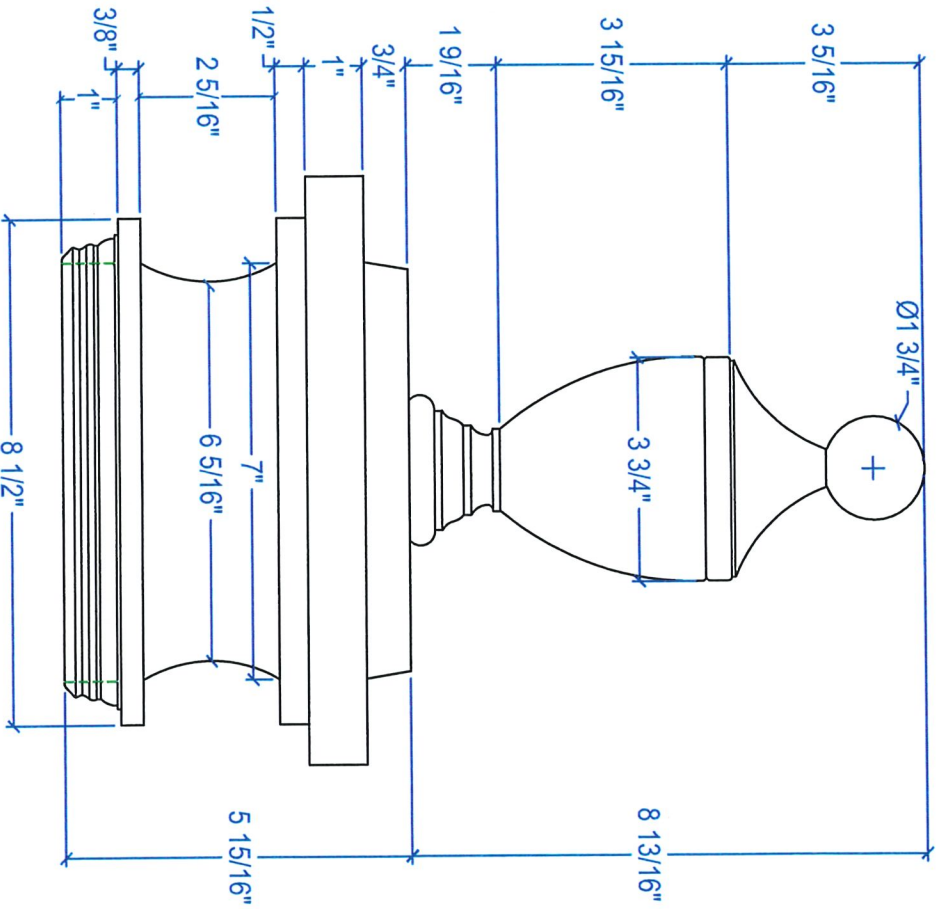

Walpole Outdoors Standard Urn Finial

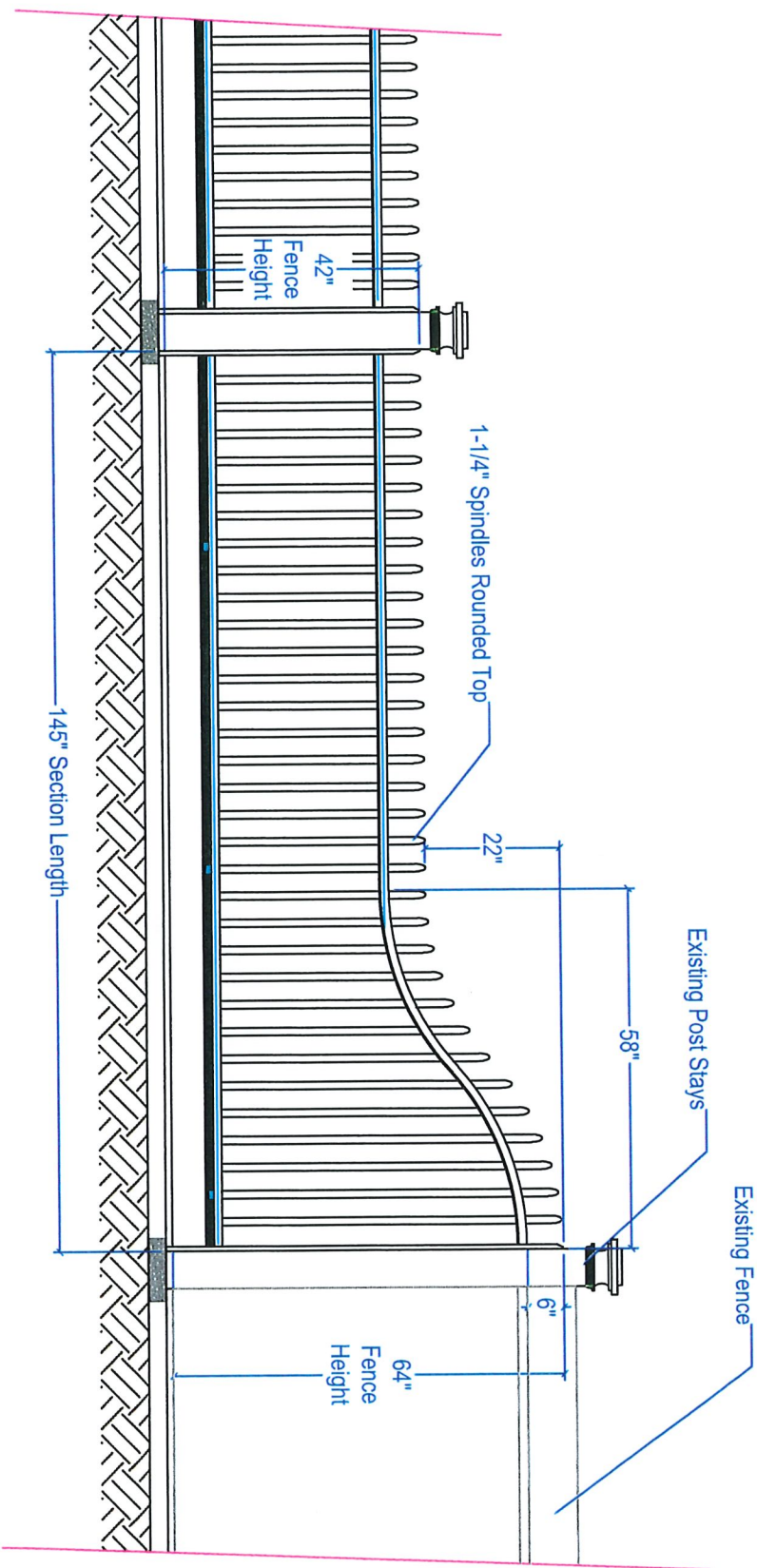

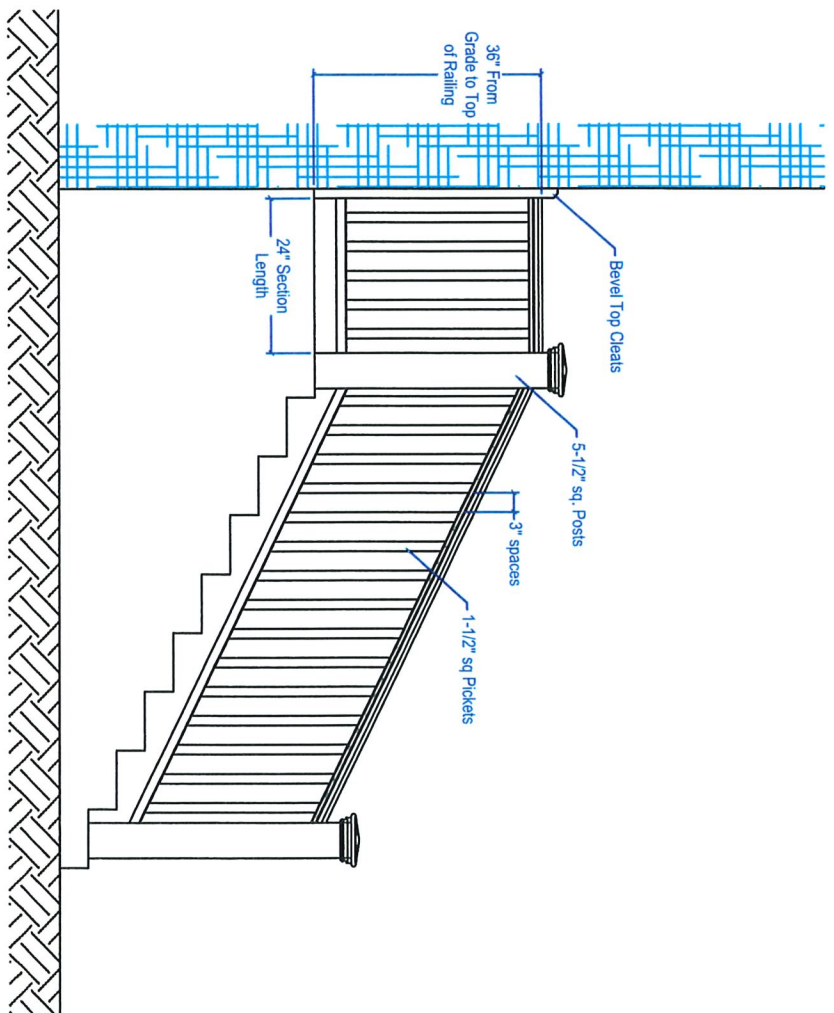
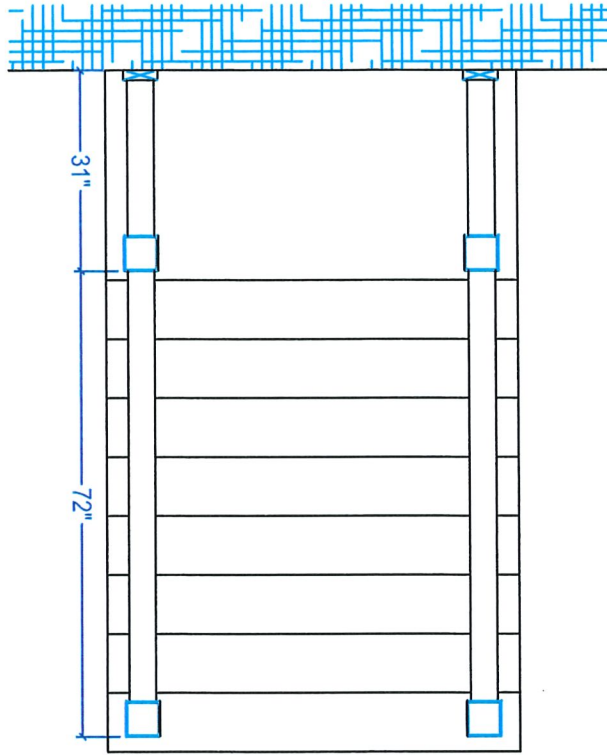


4 Custom Curved Spindle Picket Section
