I. Agenda review, Approval of Minutes, Introductions

II. Committee Planning

Event planning:

a. May Bike Ride (RS), theme creates sites, sites create route. Parks? Sustainability? Movies and books? Cambridge in fiction? Cambridge in politics. Old movie theaters (and current: http://movie-theatre.org/usa/ma/boston/main.html, see p 115). Ride the old coastline.

AQ: Storymaps application, longer term, map of Cambridge, click through photos, and it tells a story. Good way to put the bike rides and ped walks online.

b. SRTS (JS), five schools signed up, each school celebrates bike/walk to school day, 4/5 have had bike training, logo created, working with school district on walking maps. Always looking for volunteers for bike/walk to school days. On-bike training this fall with MassBike. High school bike group formed, training, Hubway memberships for older students. Committee member comment: Kids don't ride because they don't have a bike or parents say it's not safe. Potential for group ride with CPD (not every morning but a special event). Bike Committee can help with routes. AW, MP and RR will coordinate with JS.

MP: How do routes work? JS: Routes will work with current crossing guard locations, informative for parents.

MR: Meeting re: drivers dropping kids off at Tobin School.

- c. RiverFest (June 4): network of small bicycle-related businesses. Something expanded at Riverfest about all things bicycling. MR: would demonstrate separated bike lane if in Central Square.
- d. Parking Day. Third Friday in September (or thereabouts). Should we do something more park-like? CJ: her lab group near Dwell Time, microgardens in parking spaces. Partner with Media Lab?

III Updates and Projects

a. DPW Updates

5 year plan update shortly, discuss at April meeting. Alewife will soon restart. Huron will be rebuilt this summer. Sherman and Amory will resume. Pearl and some sidewalks in Central Square, and the new bathroom there. Several other contracts upcoming in the spring; details attached. Main Street in Kendall done by September. Finalizing design for Newport/Roseland in Agassiz. Finish landscaping on Cambridge Common (early fall; no formal ballfields), Grand Junction for CRA, King Upper School, lots of activity on Cambridge St, how do we best design this so it's not a de facto parking lane.

Community meeting for path between Russell Field and Alewife MBTA Station. Rindge Upper School, 6 PM meeting, Feb 24. Path can't be widened (environmental issues). Area behind fence owned by WR Grace, MBTA easement, contamination issues and conservation easements. Surface maintenance and drainage. Confluence of multiple uses. Mini-rotary draft shown. MR: Madison has a rotary, wayfinding in the center. People asked for current markings after the original "free-for-all" state.

b. MIT PUD

Hearing in January, comments from bike and ped committees. Next meeting before planning board not yet scheduled.

c. Development

Binney St/Movie Theater

Ensure space would be there for Grand Junction path, project proponents have made this change for future path development. Will move parking entrance towards Grand Jct and replace with a plaza, raised crossing on Little Binney.

Ped Cmte: likes the idea of creating a space with additional retail. Plaza is squeezed by planter, sidewalks narrow, active ground floor.

Bike parking: in garage, through garage entrance (?) or through plaza. Consider better access in to the parking garage. AW: theater needs more bike parking. MR: bike parking very convenient: feels "first class" and there is some bike parking outside, do we want more? Can't really use bikes by lobby; but force bikes to go through plaza which may be busy at times. Make the whole street a raised intersection as people walk diagonally across. Bicycle parking requirement for movie theater: 10% of seats, need to look up (mostly short term).

Is Little Binney on the bike network plan? Too narrow for lanes, shared bike markings? Or does the short street and raised crosswalk keep it pretty tolerable.

Auburn Court BZA: Parking >300 feet from entrance, several buildings away. For an appeal they must demonstrate a hardship to meet the zoning requirement. Would it be better for bike racks to be built closer to the building? Can they add to existing buildings? Hardship is that they don't want to give up too much space in the building for bike parking? Comments due by 16th. "New building there is no hardship demonstrated regarding nearby bike parking; there is plenty of car parking nearby and no reason that bike parking can not be accommodated in this manner."

- c. Legislative forum. See link. Short presentations from Boston & Cambridge, food, Motor Transport Assoc, 589. Focus on large vehicles and cycling. Breakout sessions as well (speed limits, etc). CPD planning to attend. Sen Brownsberger wants legislative action coming out of this.
- d. multitown advocate meeting (Saturday Feb 6). Productive, notes sent out. Collaboration on projects and resources.
