Minutes of prior meeting - approved

Cambridge Bicycle Plan (Cara)

- First created in 2015 then updated in 2020
- Plan Vision streets available to everyone
- Numerous city policies support biking VTRO, PTDM, VZ, CSO, etc.
- Many benefits to cycling climate, health, air quality, safety to pedestrians
- More social connections on streets with lighter vehicle traffic
- People shopping shop locally, and by bike spend more than those driving
- Equity Biking is affordable
- Cyclists and peds are happiest commuters
- Cambridge surveys 85% of people who have biked in the past year want to bike more, and 53% of those that did not bike want to bike more
- Lack of safe facilities is #1 barrier to people biking, even more so for women than men
 - Also bike parking, programs/policies
- Bicyclist level of comfort vast majority of people comfortable only in separated bike lane, both for cyclists and those that would like to ride more
- Bicycle Network Vision
 - Every street is part of the network
 - High priority streets need either greater separation (on main routes) or traffic calming to slow speeds (on smaller streets)
- From Vision to reality
 - o 5-year plan for Sidewalk and Street Reconstruction
 - o development mitigation
 - o capital projects (e.g., Western Ave, River St, Inman Square)
 - o quick-build projects (e.g. Cambridge St, Brattle St, South Mass Ave, etc)
- More/better facilities, # people biking has been going up year over year (bike counts)

- In last 15 years, 23% increase in Cambridge people commuting by bike, Bluebikes ridership constantly increasing (over 23 million trips taken systemwide)
- Crash rate has gone down from 2003 to 2020 from 30 to 10 per some million bicycle miles traveled
- Crash severity has also gone way down from 50% in 2004-2012 to 3% more recently

CSO Economic Impact Study (Pardis Saffari/CDD)

- Volpe National Transportation Systems Center partnered with CDD in 2023, completed in January 2024
- Business survey (sent to 1600 businesses, and staff followed up with reminders to 900 businesses) pre/post installation of SBLs
 - Opt-in survey response rate 17%
 - Q How many businesses filled out the survey? A Around 300.
 - Q- Business did report decrease in revenue Biased towards complainers? Yes, but some responders were positive on bike lanes (less than half)
 - Q Can we realistically get more objective data? A Not very confident, but hope
 - Businesses wanted more communication
- Customer survey (214 responses) done in commercial corridors on mode of transit
- Could not get objective credit card date or tax data (but will try to get this in the future?)
- No difference in employment before after
- On average, not change in vacancy rate
- SafeGraph data to estimate number of visits to businesses but too many gaps in data
- Recommendations/future plans from Volpe
 - Note Data did not show direct impact from separated bike lanes on businesses
 - Build in evaluation in advance of projects (obtain better before/after data)
 - o Get tax and employment data
 - Parking utilization studies
 - Increase communication (city staff have met with over 200 businesses)
- Q Vacancy data from city may be useful A Volpe did not use that info because reason for closing unclear (e.g. pandemic vs bike lanes). Maybe more useful in future more stable business climate.
- Q Is there access to rental cost data? A yes, city has averages, but crude, for East/Mid/West Cambridge, reported in Co Star real estate database average rents have not changed in the past 2 years

- Q Can you look at Toast, e.g. by street? A no, they won't share data
- Q Have you asked business who say business has changed to open their books?
- Q Can you stand in front of one business all day? A good idea
- Q Can the city count cyclists going into shops? A labor intensive, plus you can't really tell how someone got there unless customers were asked directly

Charlie Creagh - will be interim Bike Committee CDD staff liaison

Bike/ped crossing over Fitchburg line at Danehy to Rindge Ave (Charlie)

- City awarded \$2.4M to design crossing/bridge
- Asks for Letter of support from Bike Committee to get funding up to \$3.5M for construction for path to approach the bridge
 - Need the letter Friday morning!
- Q Great project. Can proposed path to Alewife be extended to Minuteman? A that is a separate project to be negotiated with the city and the MBTA, who plans to change the station at some point.
- Q Can the proposal reference equity/environment justice for local residents? A-Y.
- Q timing for funding? A 2025, most likely, but need to investigate.
- Q Can copies of the letter be provided to the whole committee? A Yes.

The Committee officially voted to endorse the project with a letter of support.
