The Planning Board of the City of Cambridge will hold a public hearing on **August 16, 2022 at 6:30 p.m.**, held remotely (see below for instructions to participate) on a Zoning Petition by the City Council to amend section 6.36, entitled "Schedule of Parking and Loading Requirements," of Article 6.000, entitled "Off Street Parking and Loading Requirements and Nighttime Curfew on Large Commercial Through Trucks," of the Zoning Ordinance of the City of Cambridge by inserting text that reads "Minimum accessory parking required for all uses shall be 0 parking spaces" and by inserting the numeral "0" in place of all current accessory parking requirements for all uses in all zoning districts.
