for which the Applicant is Massachusetts Institute of Technology
seeking special permits pursuant to Planned Unit Development 7 (Section 13.90) and
Project Review Special Permit (Section 19.20)
for a proposal to Redevelop the Volpe Exchange Parcel into a mixed-use
center including residential, retail, office and
laboratory buildings, as well as a Community Center.
