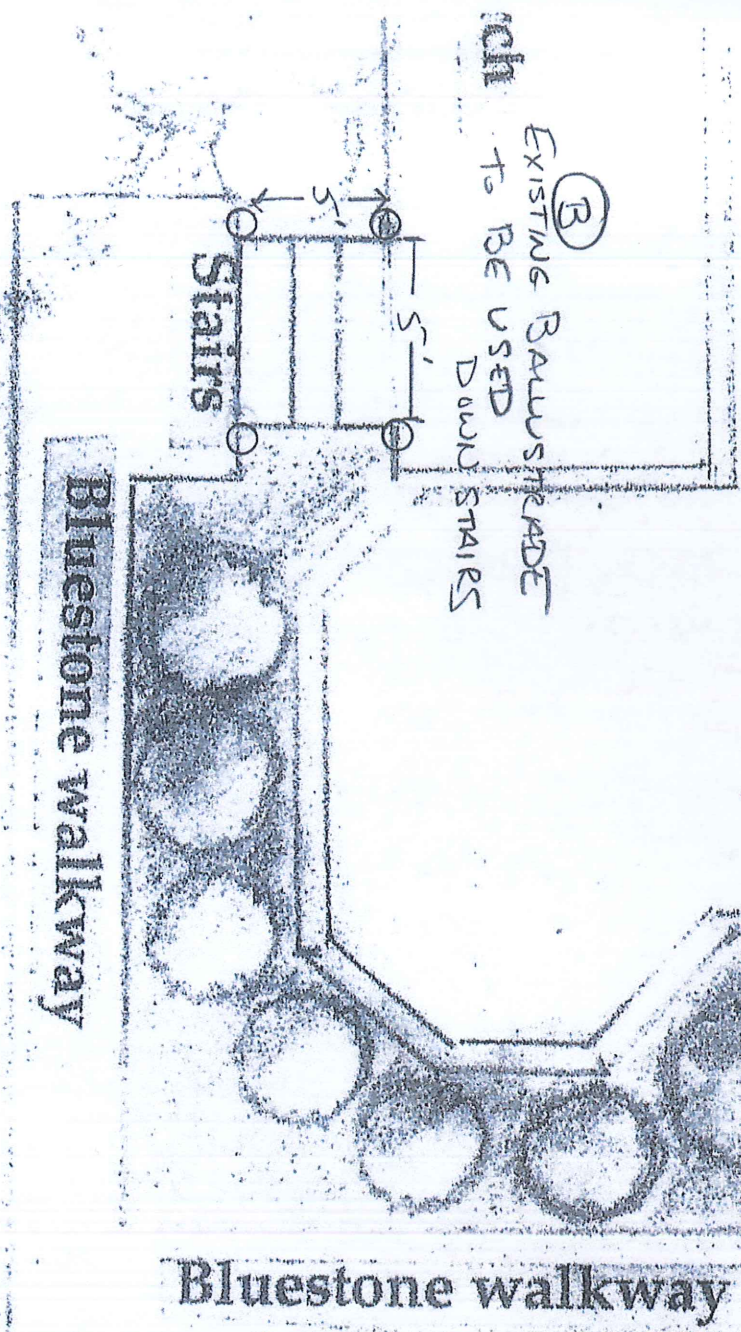
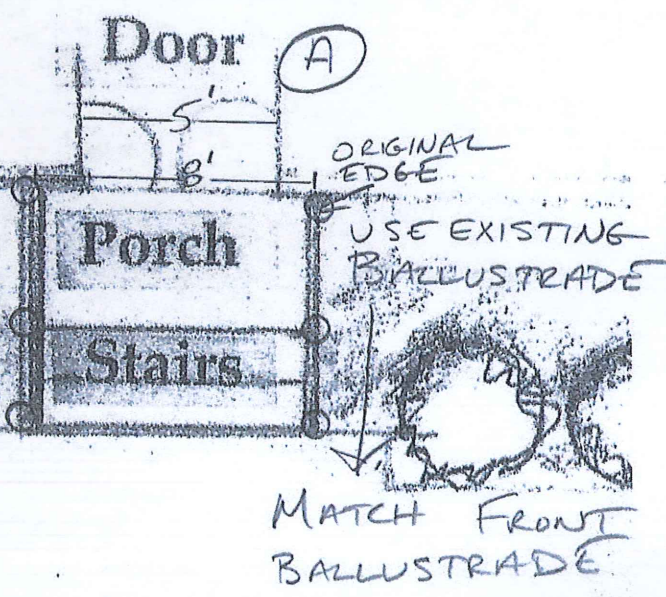

- ③ CONNECT STAIR + PARKING W/ BLUESTONE WALKWAYS - ACCESS TO BRATTLE STREET DOOR



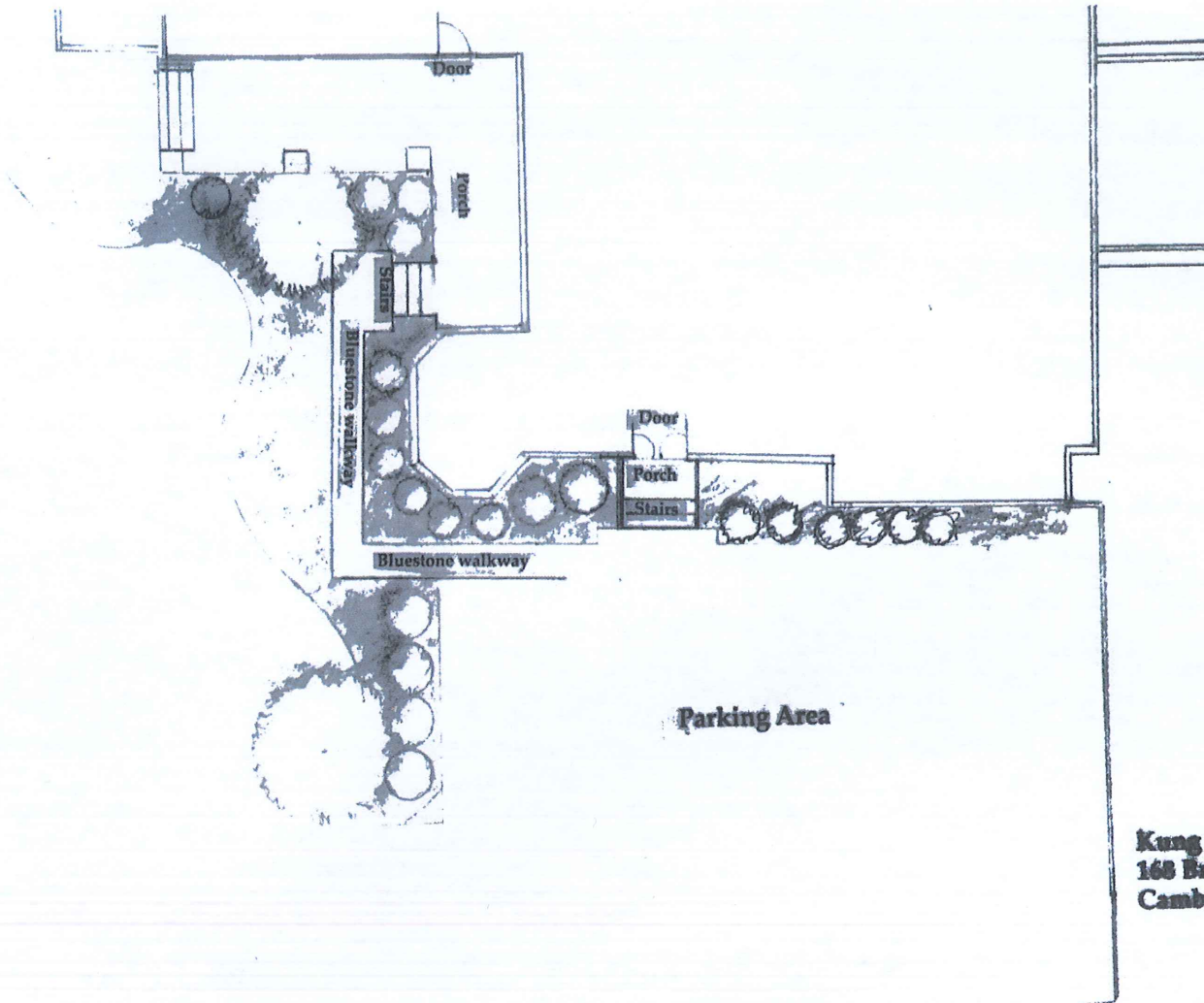

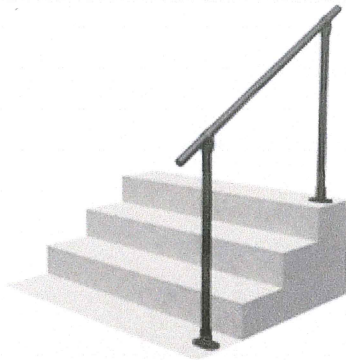

These images are not perfect, nor have they been approved by Patricia, but they are along the line I am thinking.

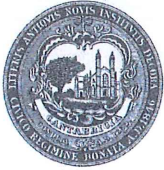

The Cambridge Historical Commission hereby certifies, pursuant to the Massachusetts Historic Districts Act (MGL Ch. 40C) and the Cambridge Historical Buildings and Landmarks Ordinance (Cambridge City Code, Ch. 2.78), that the work described below is not incongruous to the historic aspects or architectural character of the building or district:

1. Restore the existing porch and deck areas. Replace wood skirt at base, replicating existing details.
2. Construct an extension of the deck connecting the areas at the front of the house, around the Poet's Corner.
3. Restore grass strip along Brattle Street. Add two bluestone paths to the front and side entrances.
4. Repave driveway with dark colored exposed aggregate concrete pavement with snow melt system.
5. Pave parking court with dark colored exposed aggregate concrete. Install 5' high stockade fence and gate to match the design of the existing fence on the property. Construct walkway and stairs to north side entrance.
6. Remove paving, regrade and restore lawn in rear yard. Improve drainage and add a low granite seat wall.
7. Install bluestone patio, path and improve east entrance on east side of building.
8. Remove deck and replace with bluestone and stairs at rear yard.

9. Reconstruct the wood storage sheds and install bluestone path on east side yard.
10. Install low level lighting at driveway, parking court and limited stair entrance locations to replace existing lighting. Install tree lighting for 3-5 trees in the rear yard.

Work is to be carried out as indicated on the drawings by Halvorson Design Partnership titled, "Kung Residence 168 Brattle Street Cambridge MA," and dated June 18, 2019.

Approval was granted on the condition that construction details, including the fence and balustrade intersection, be reviewed and approved by CHC staff.

All improvements shall be carried out as shown on the plans and specifications submitted by the applicant, except as modified above. Approved plans and specifications are incorporated by reference into this certificate.

This certificate is granted upon the condition that the work authorized herein is commenced within six months after the date of issue. If the work authorized by this certificate is not commenced within six months after the date of issue, or if such work is suspended in significant part for a period of one year after the time the work is commenced, then this certificate shall expire and be of no further effect; provided that, for cause, one or more extensions of time, for periods not exceeding six months each, may be allowed in writing by the Chair.

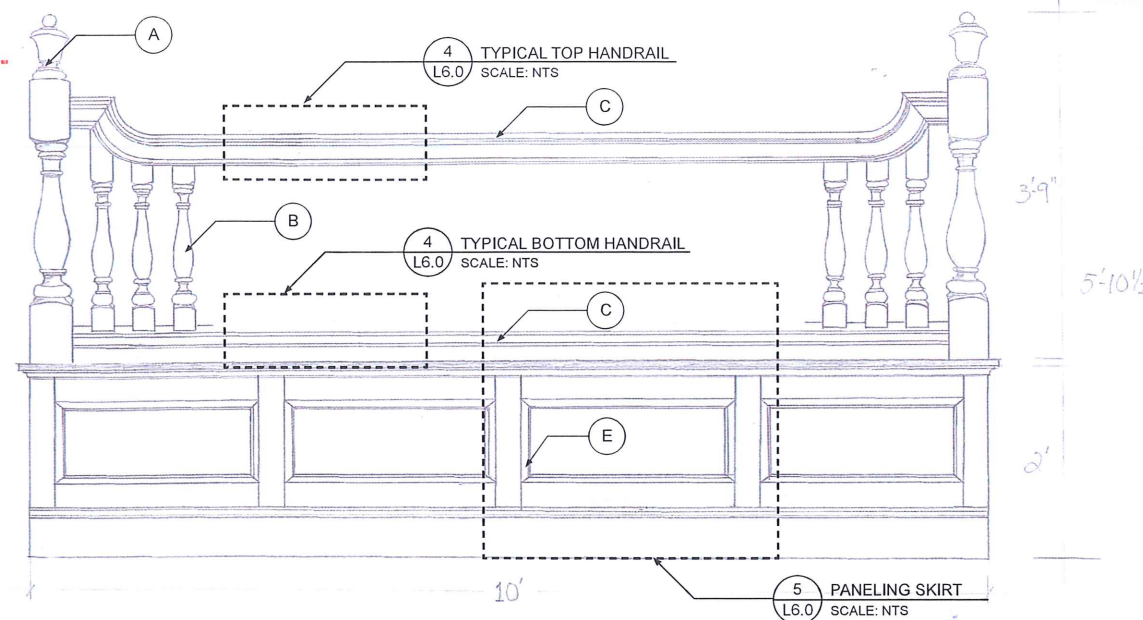

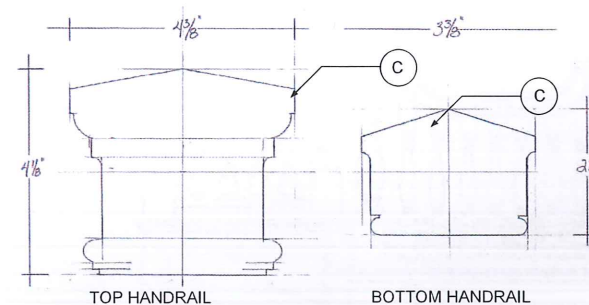
1 EXISTING CONDITION - VIEW FROM BRATTLE STREET

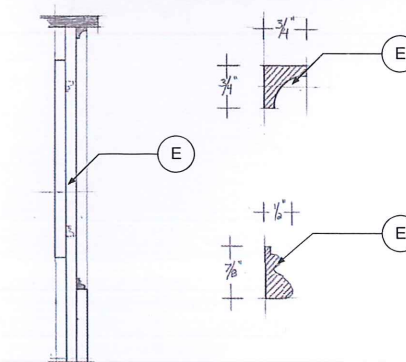
2 PROPOSED DECK PLAN / KEY PLAN

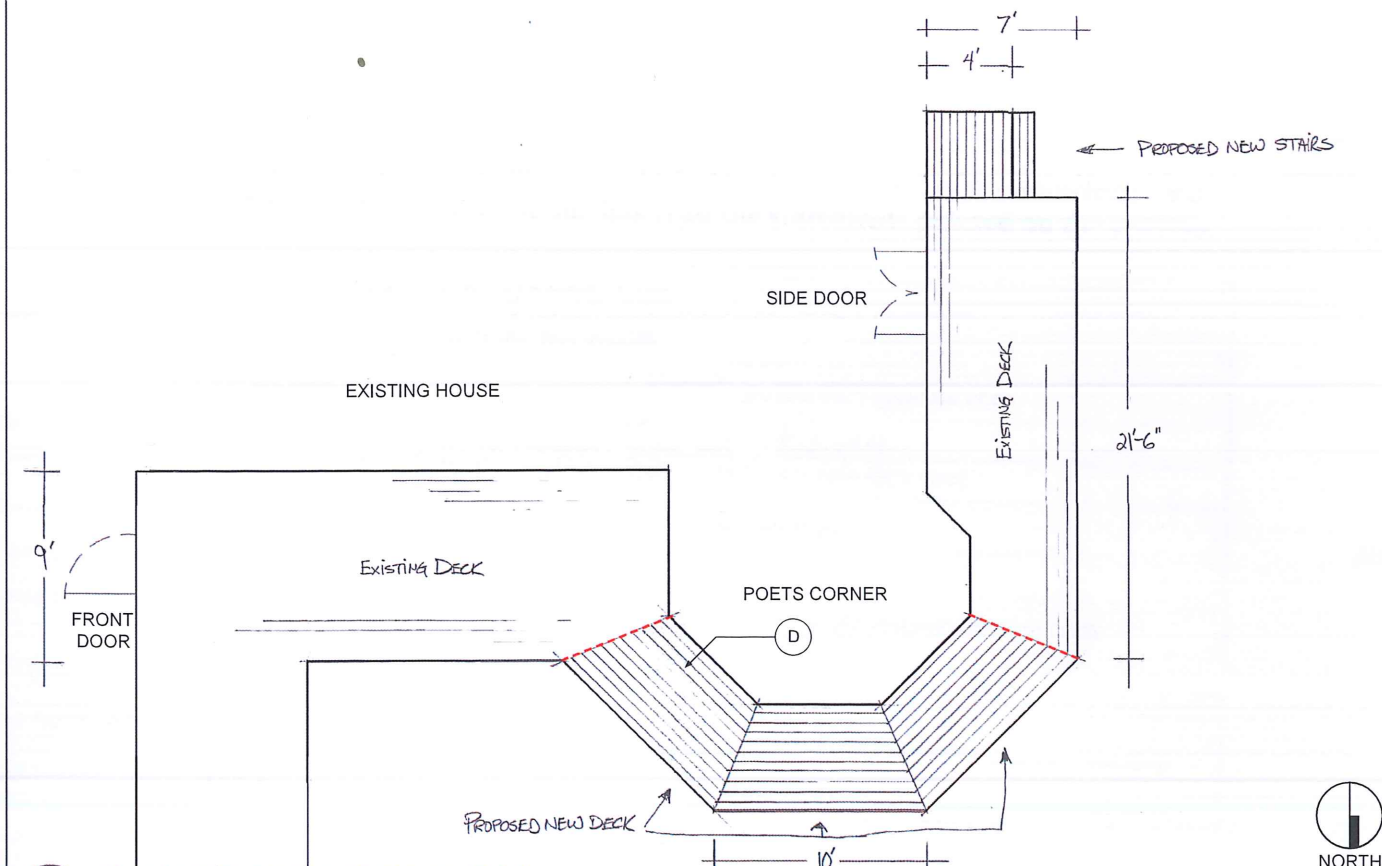

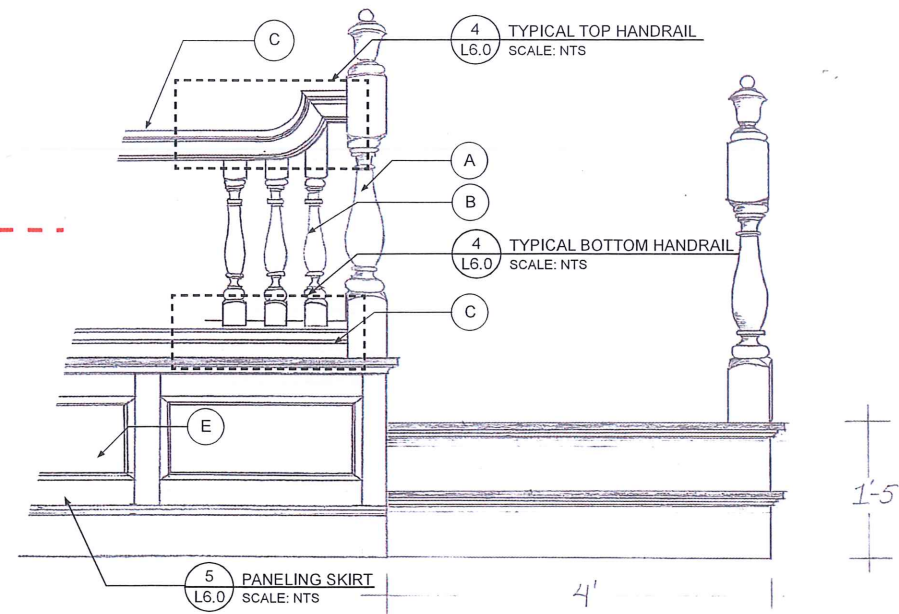

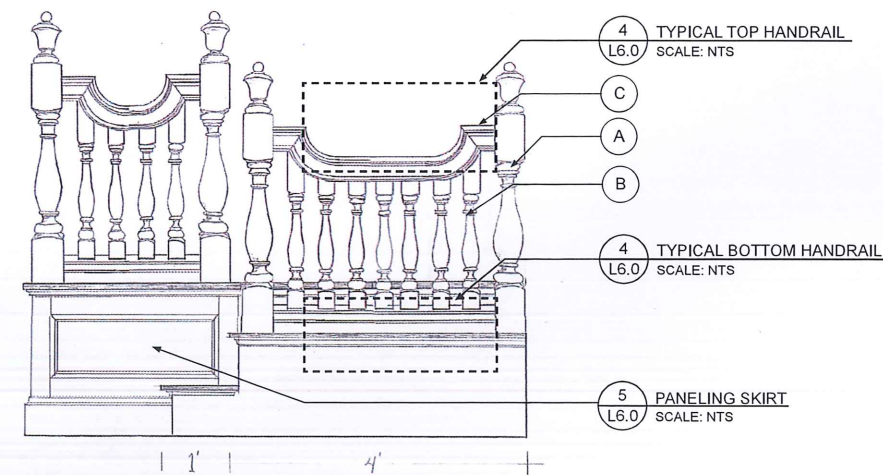
1 EXISTING CONDITION - SIDE PORCH
