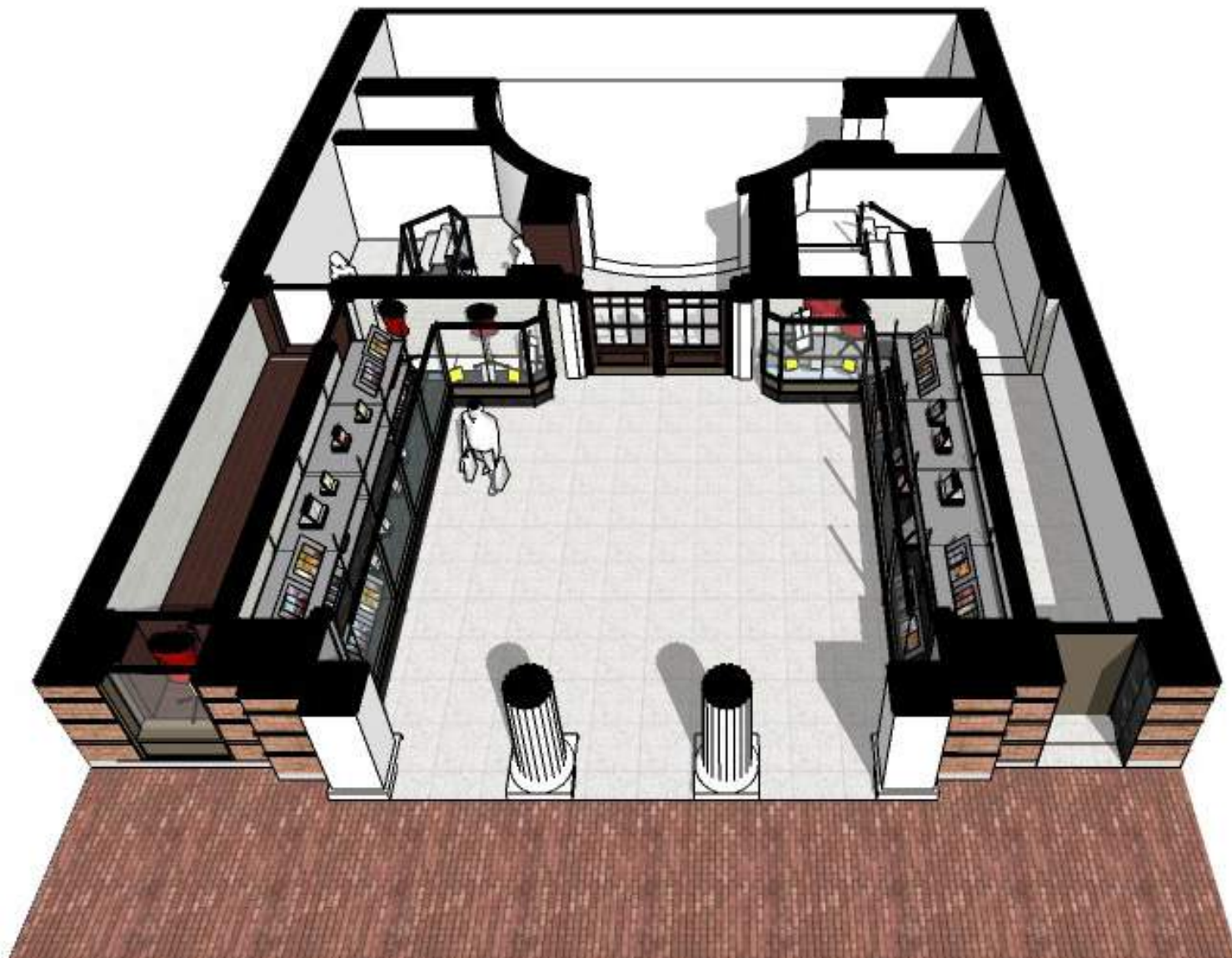




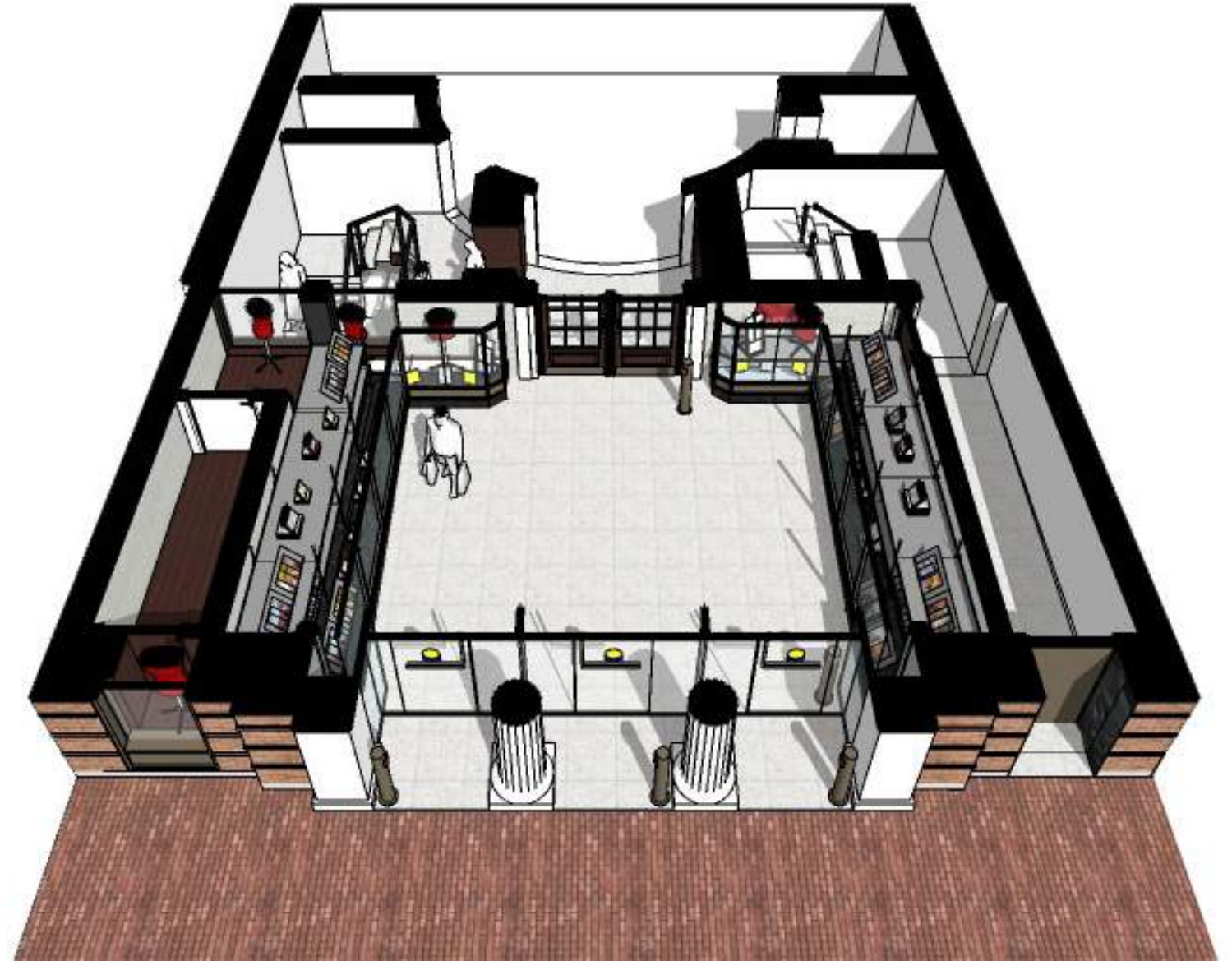

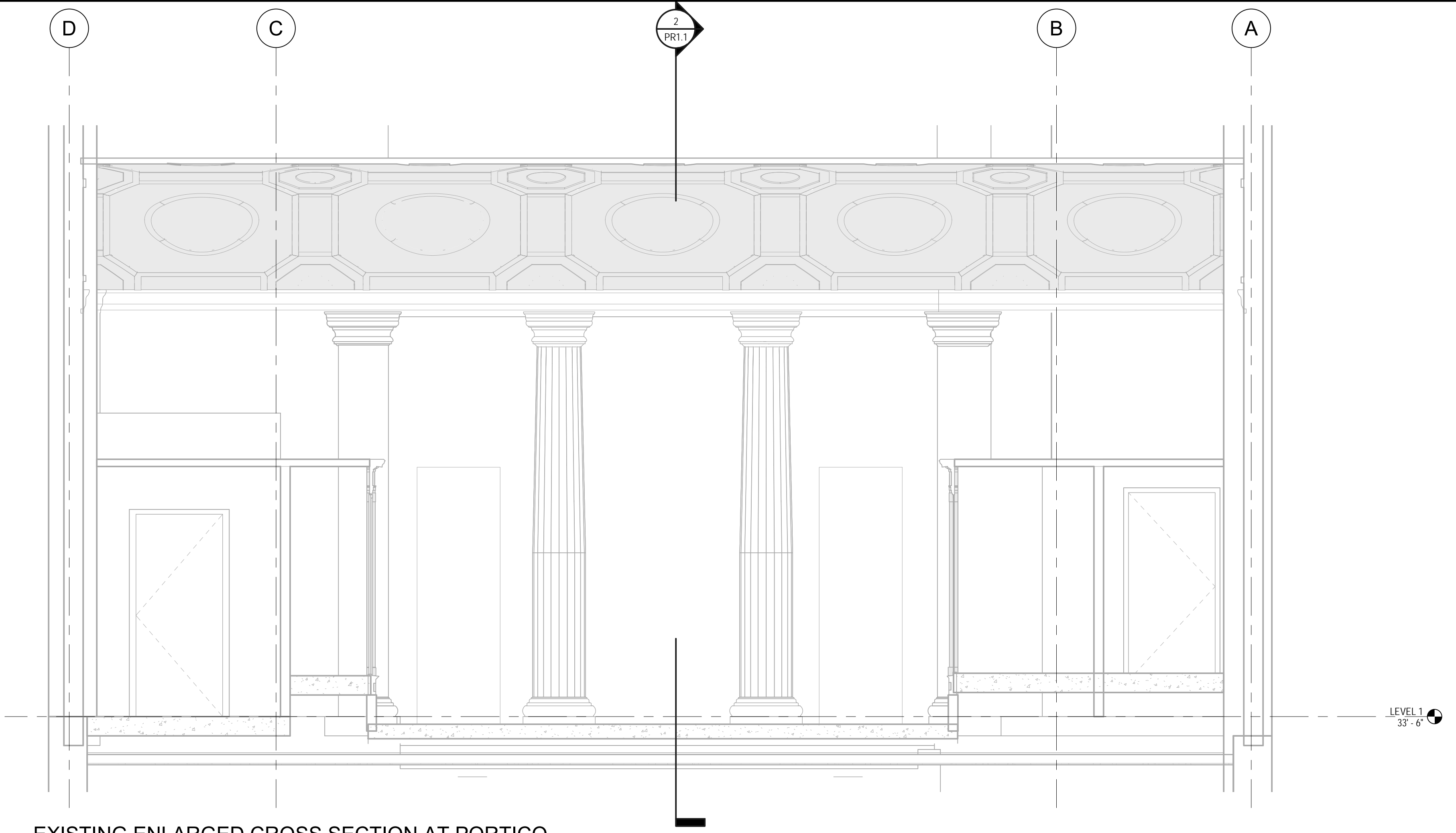

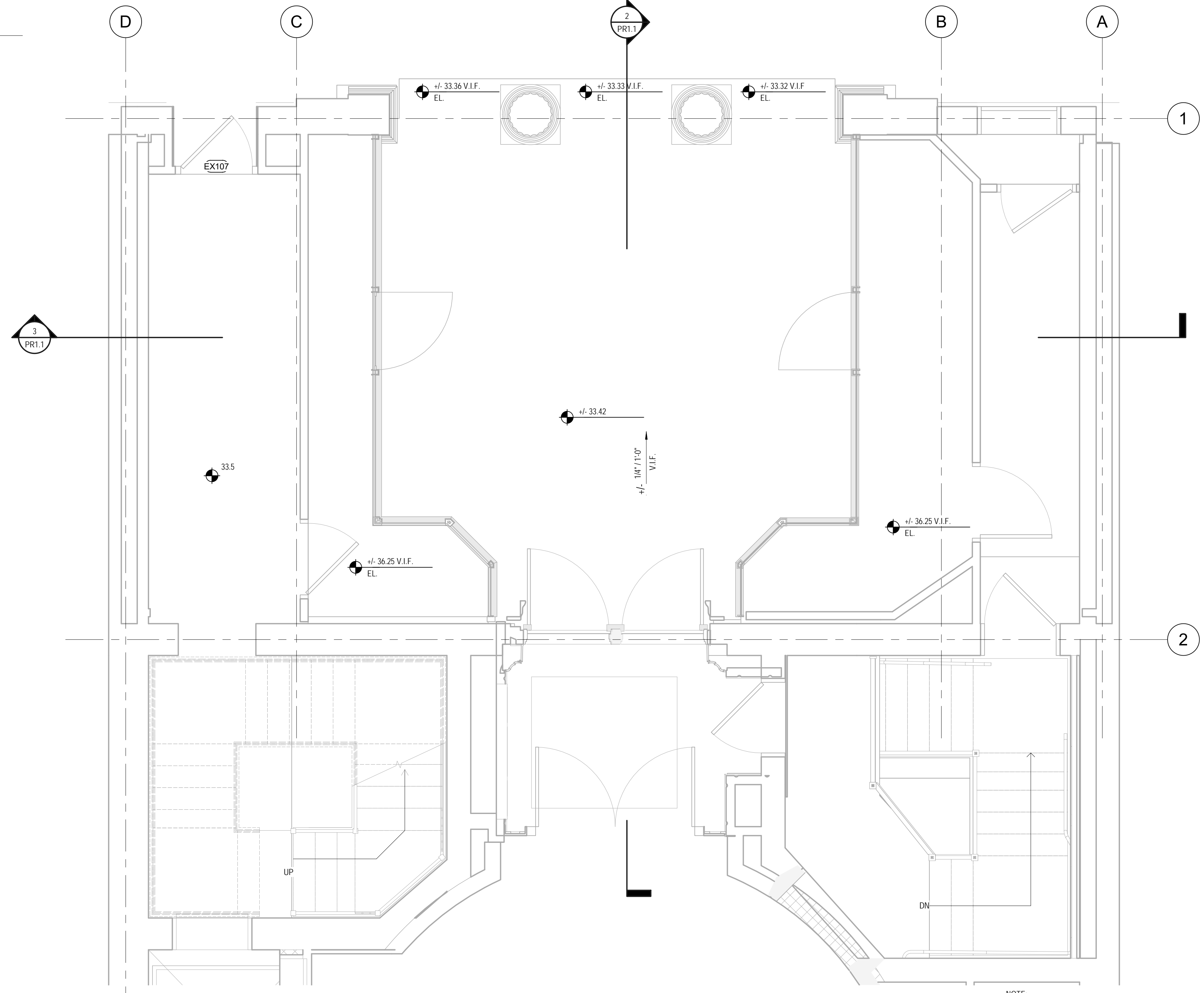

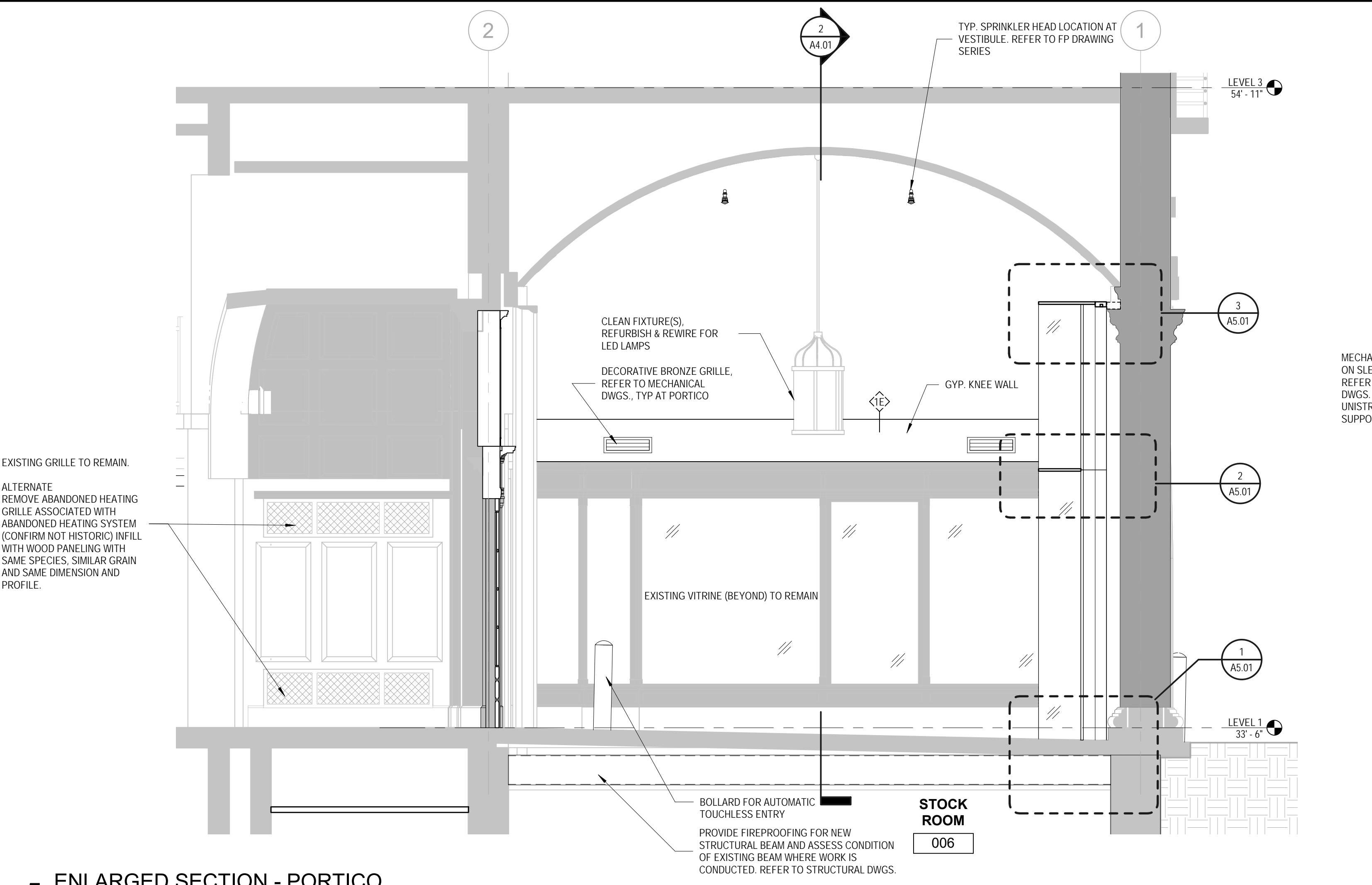

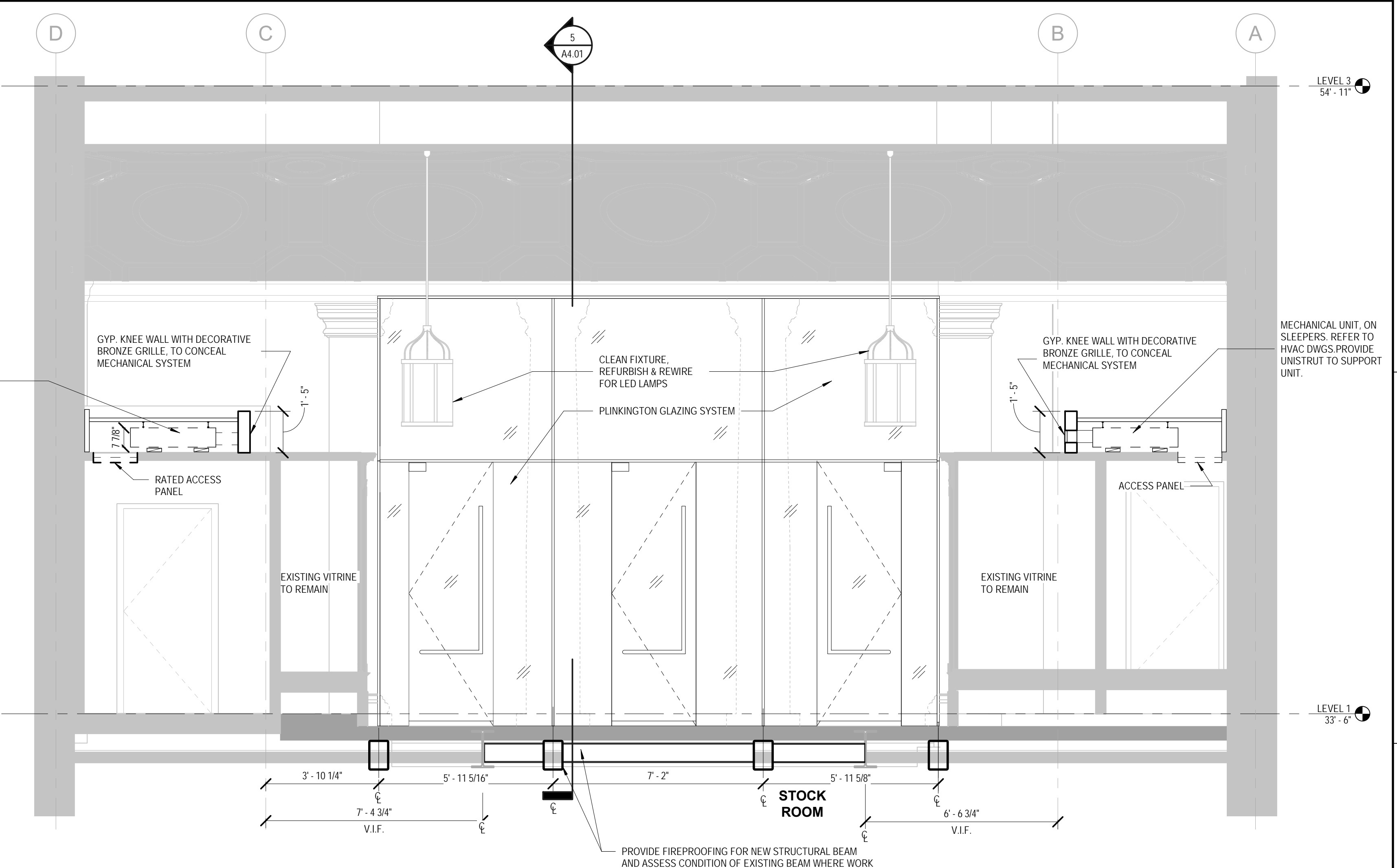

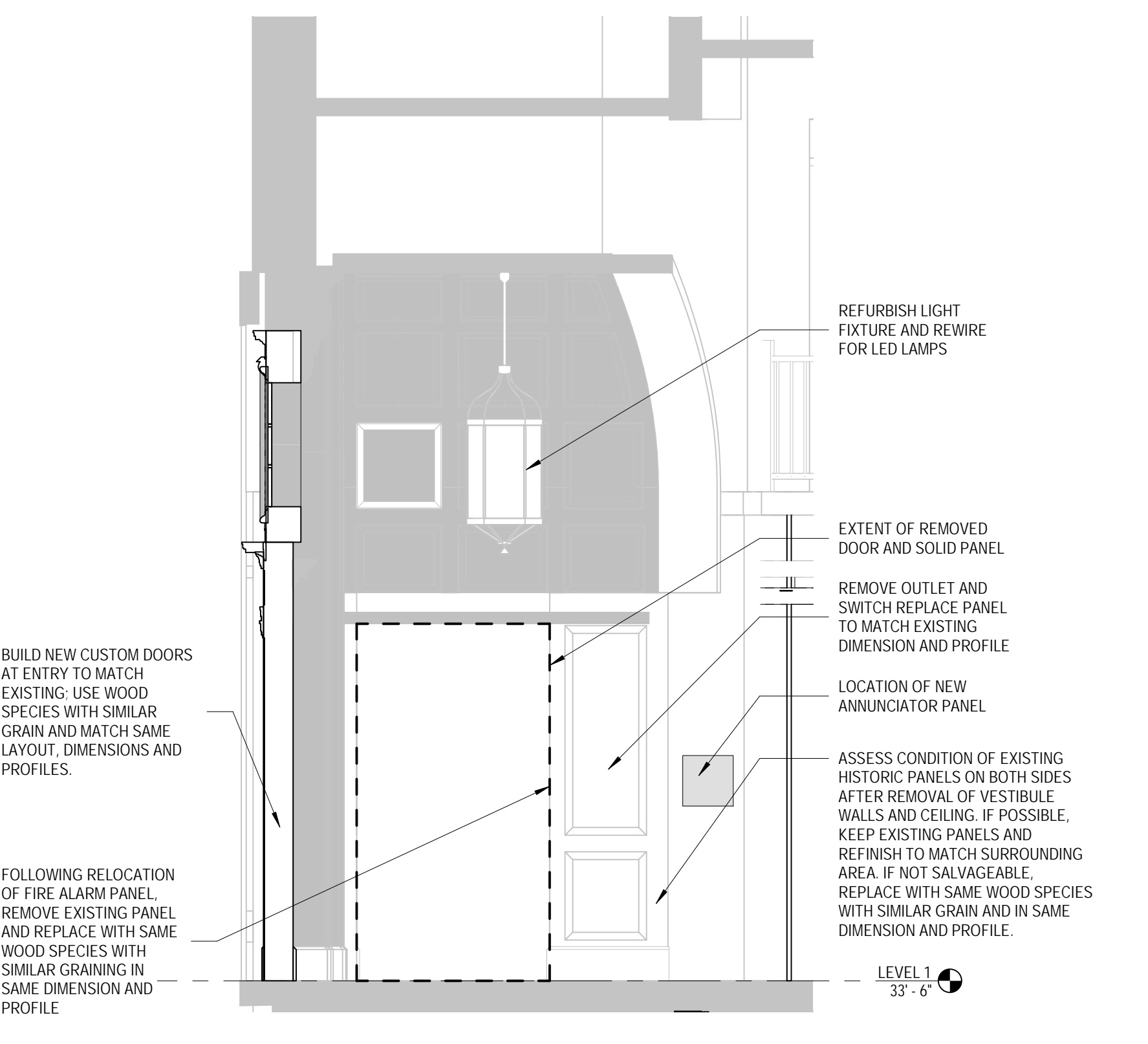

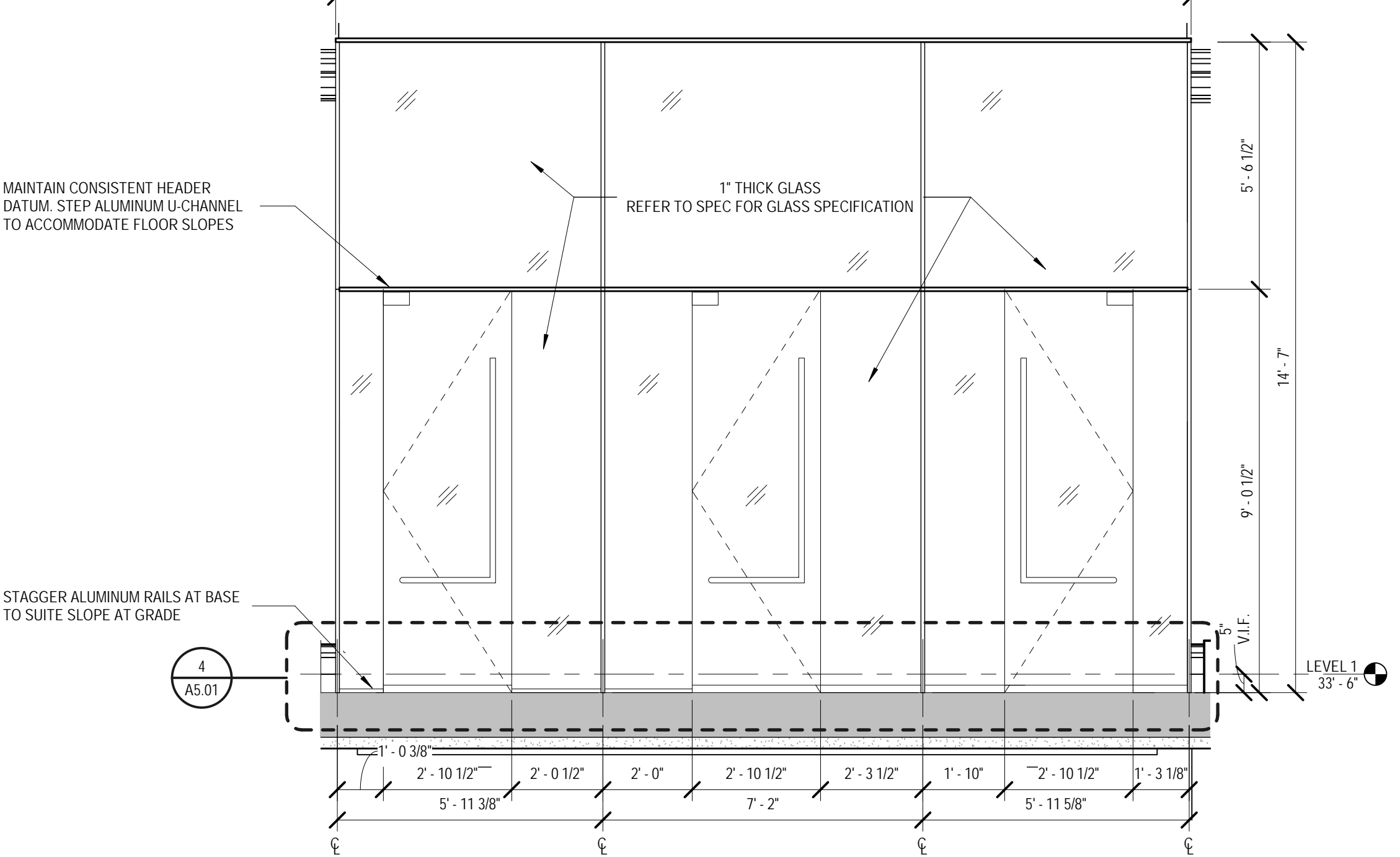
5 ENLARGED SECTION - PORTICO

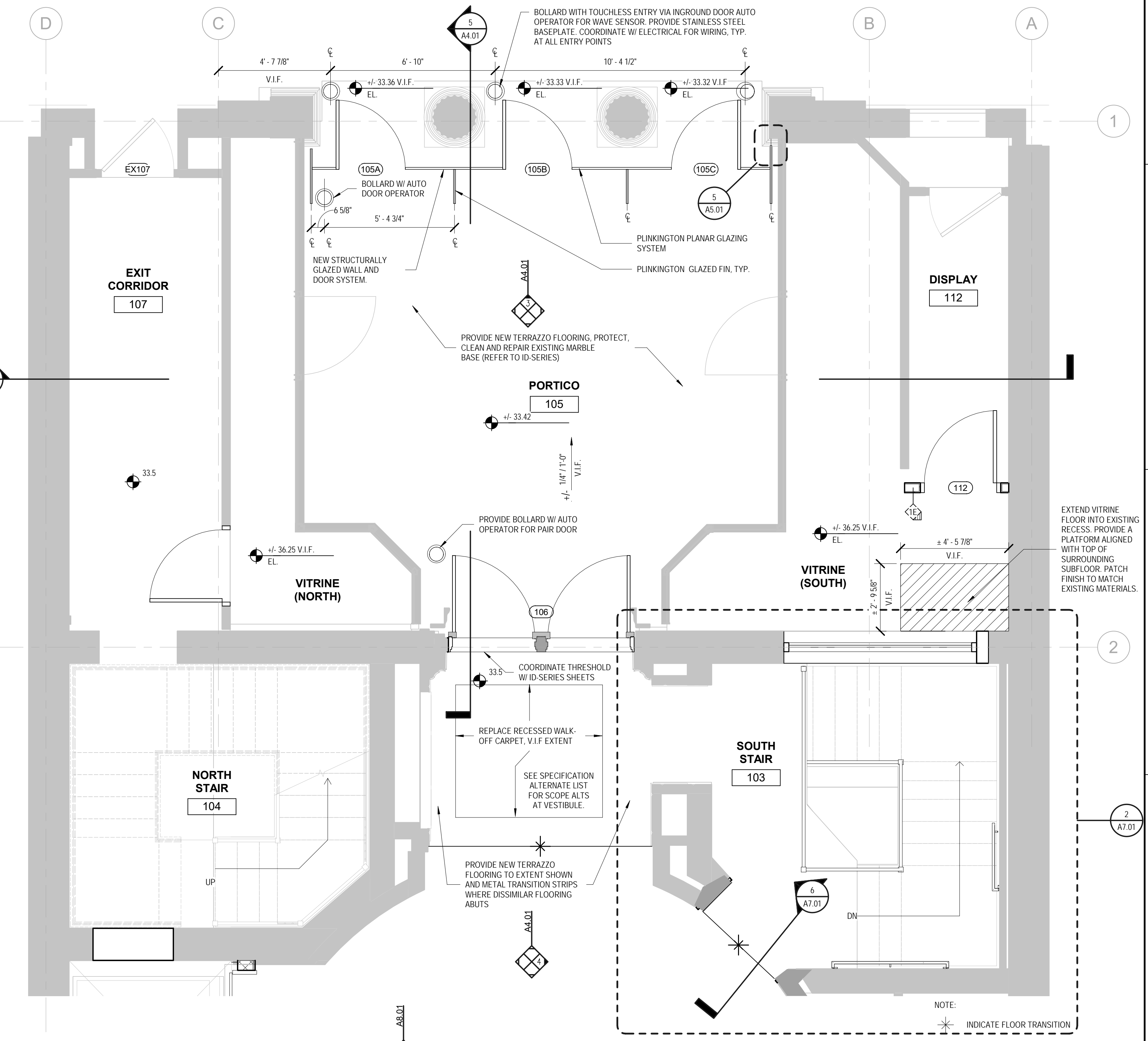
2 ENLARGED CROSS SECTION AT PORTICO

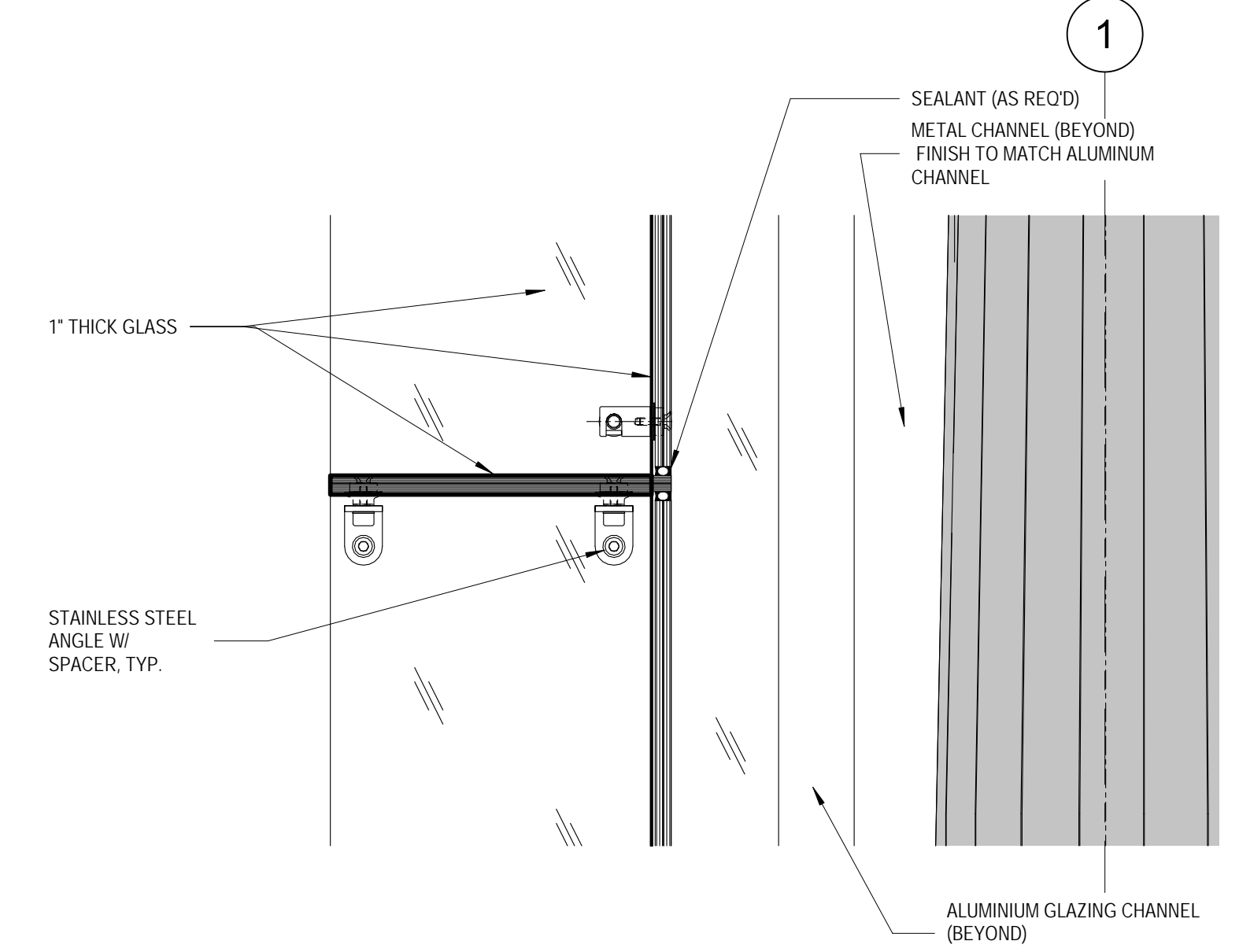
7 SECTION DETAIL - INGROUND DOOR OPERATOR

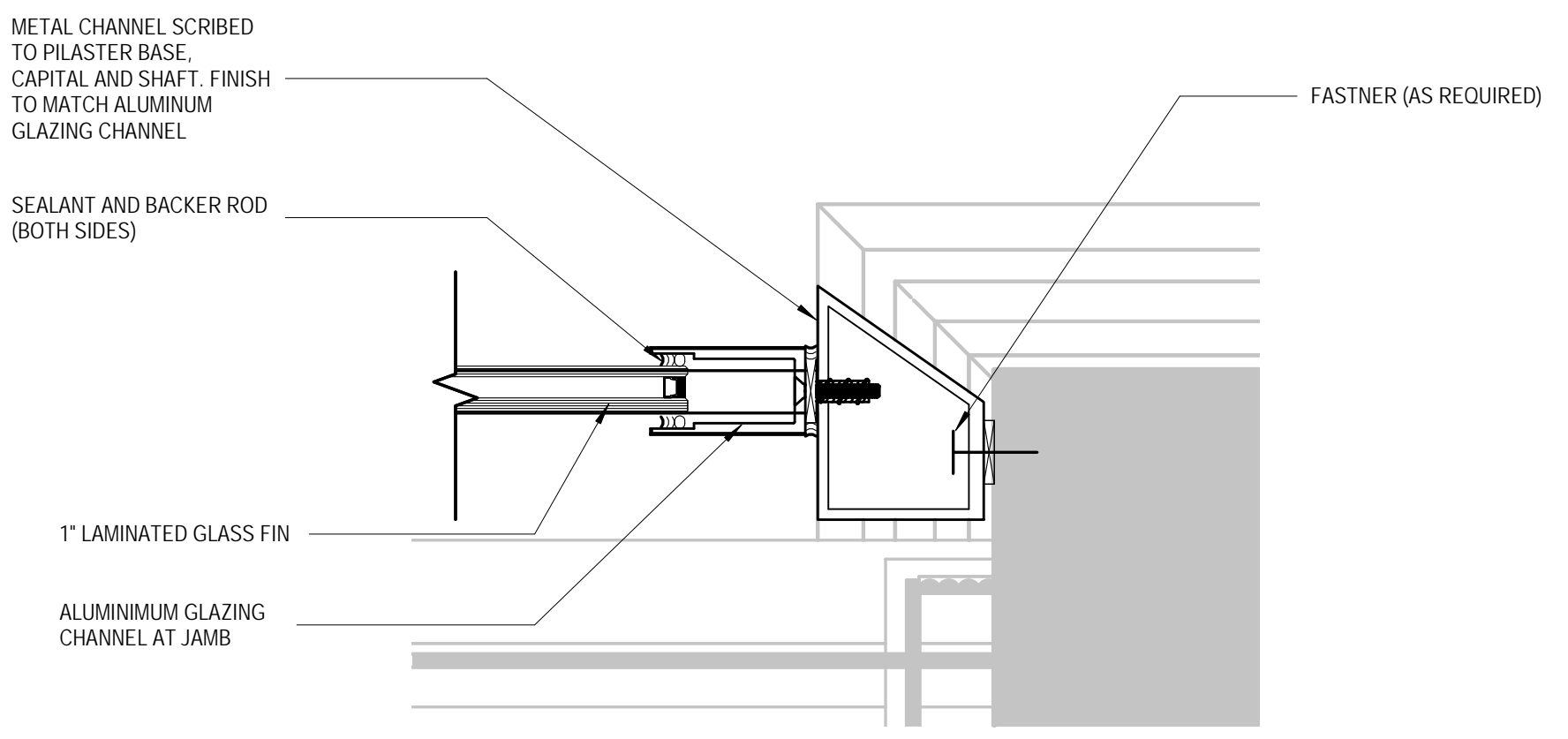
3 SECTION DETAIL AT HEAD CONNECTION OF GLASS FIN

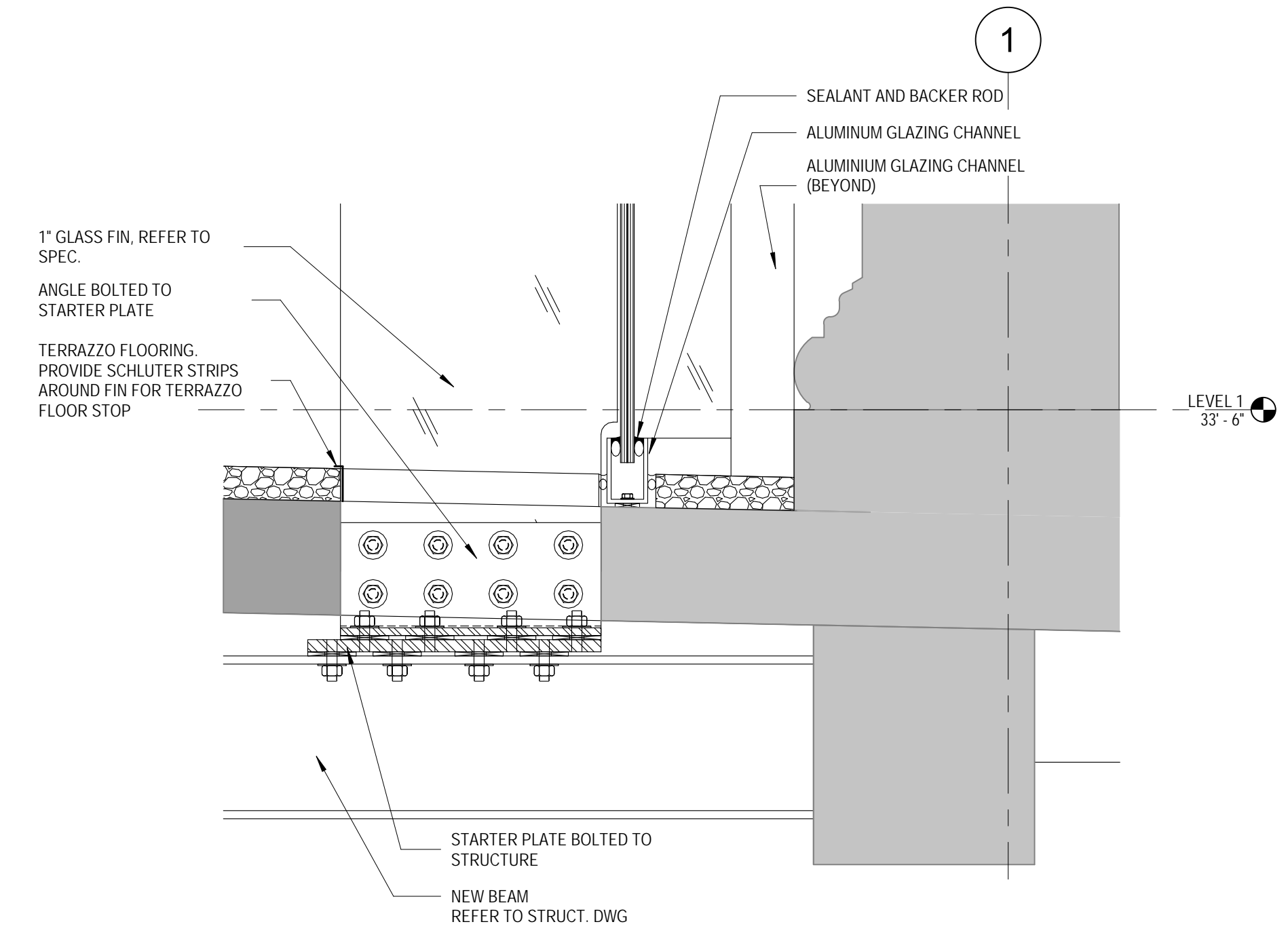
6 TYPICAL SECTION DETAIL AT BASE OF BOLLARD

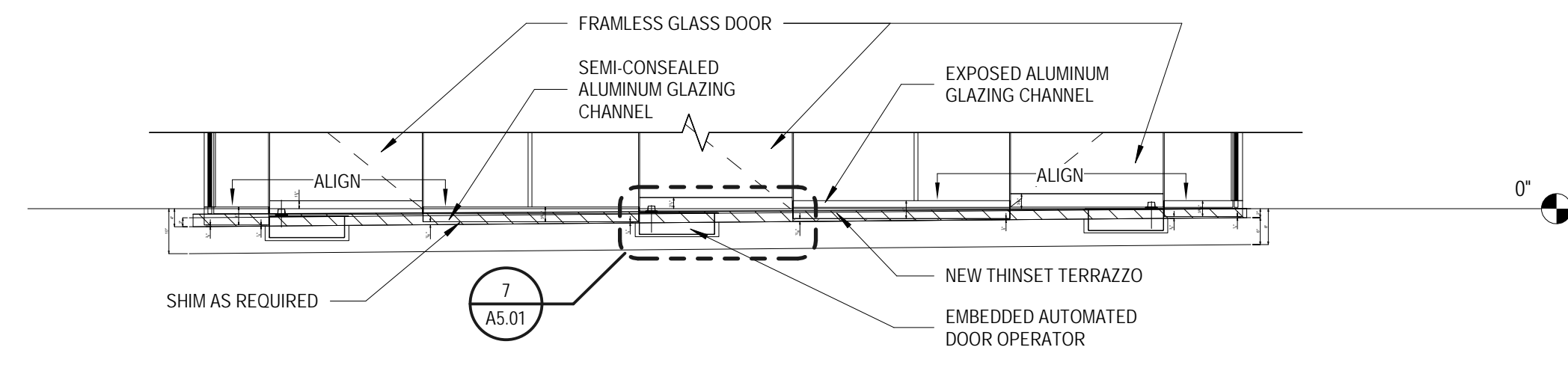

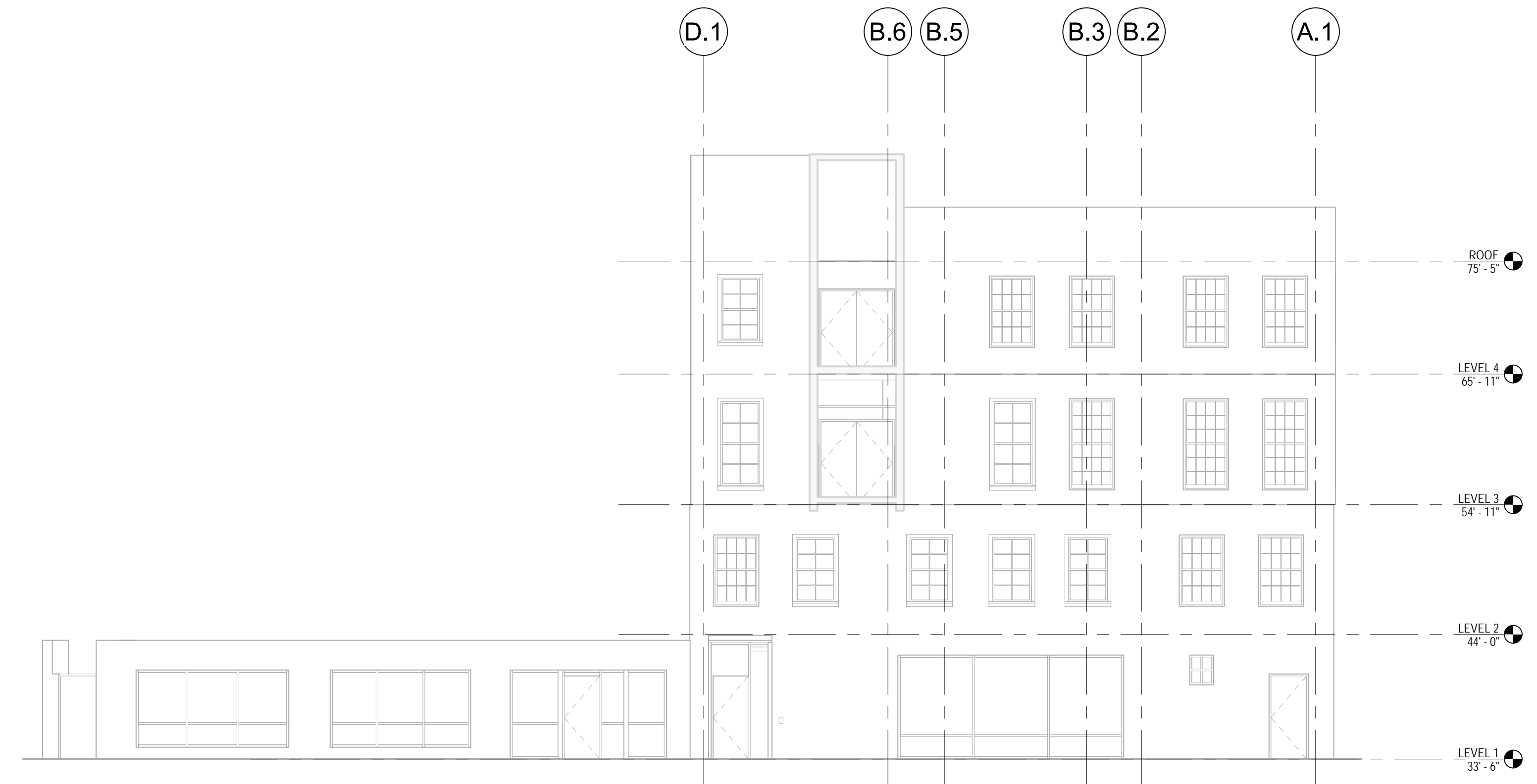

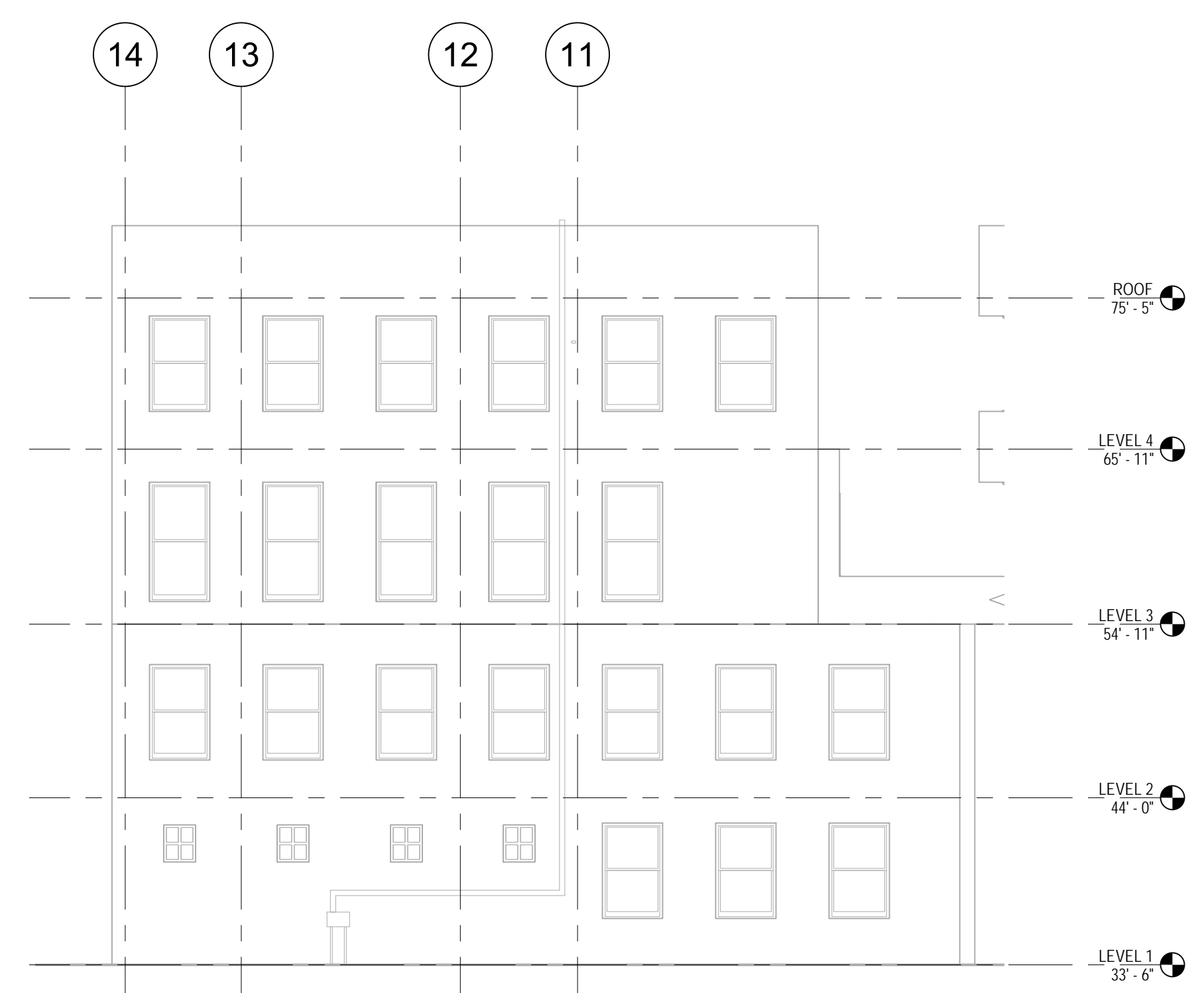

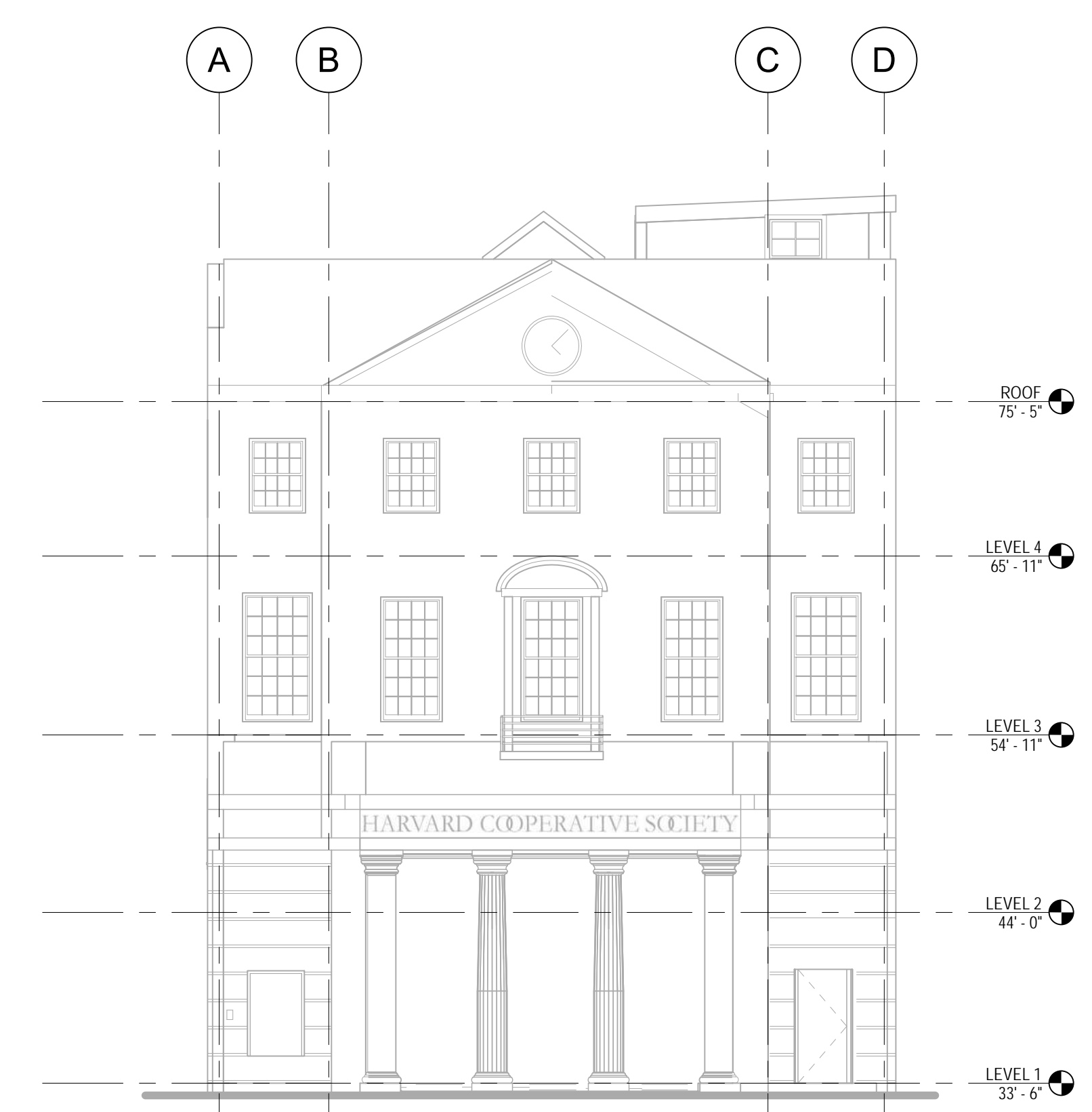

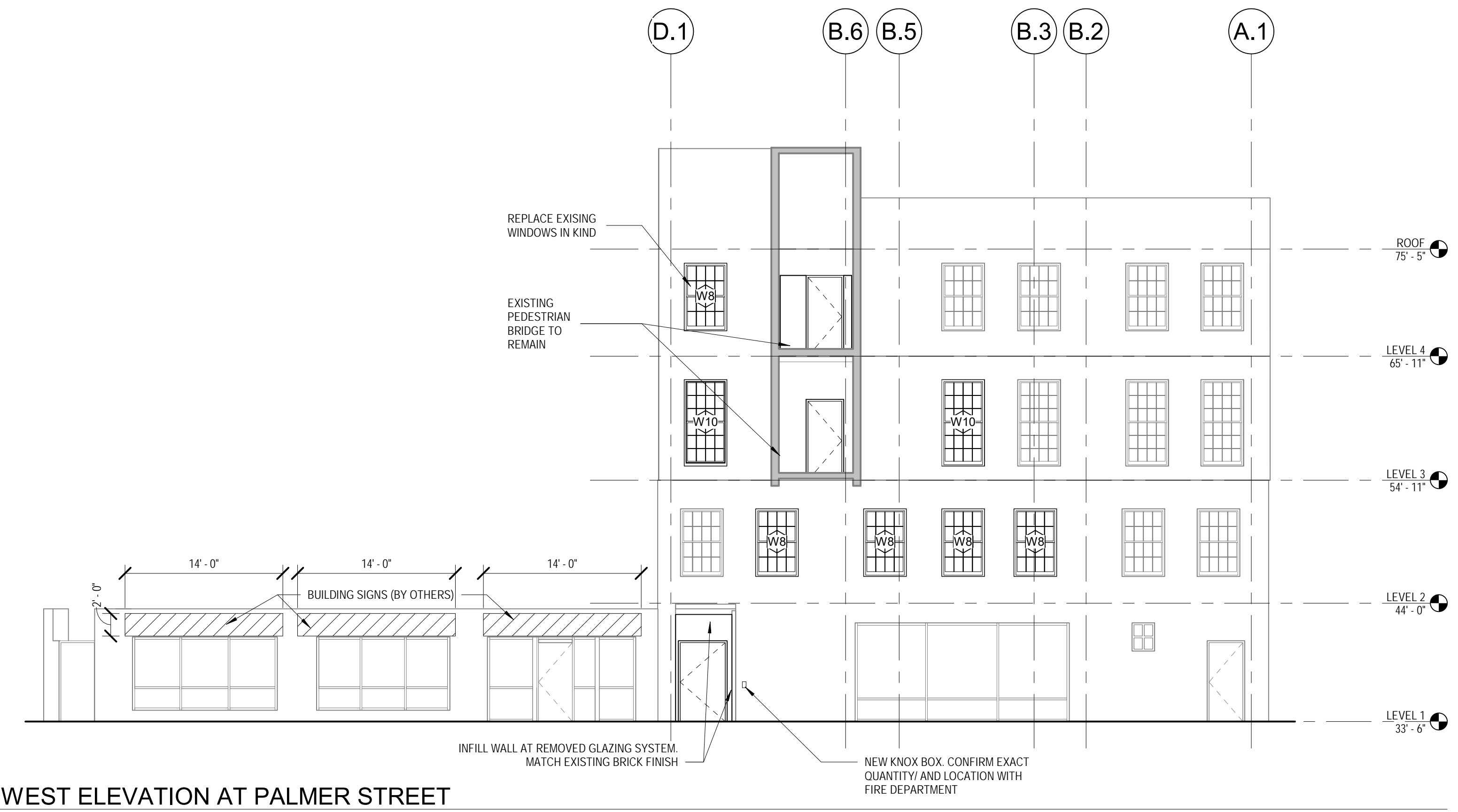

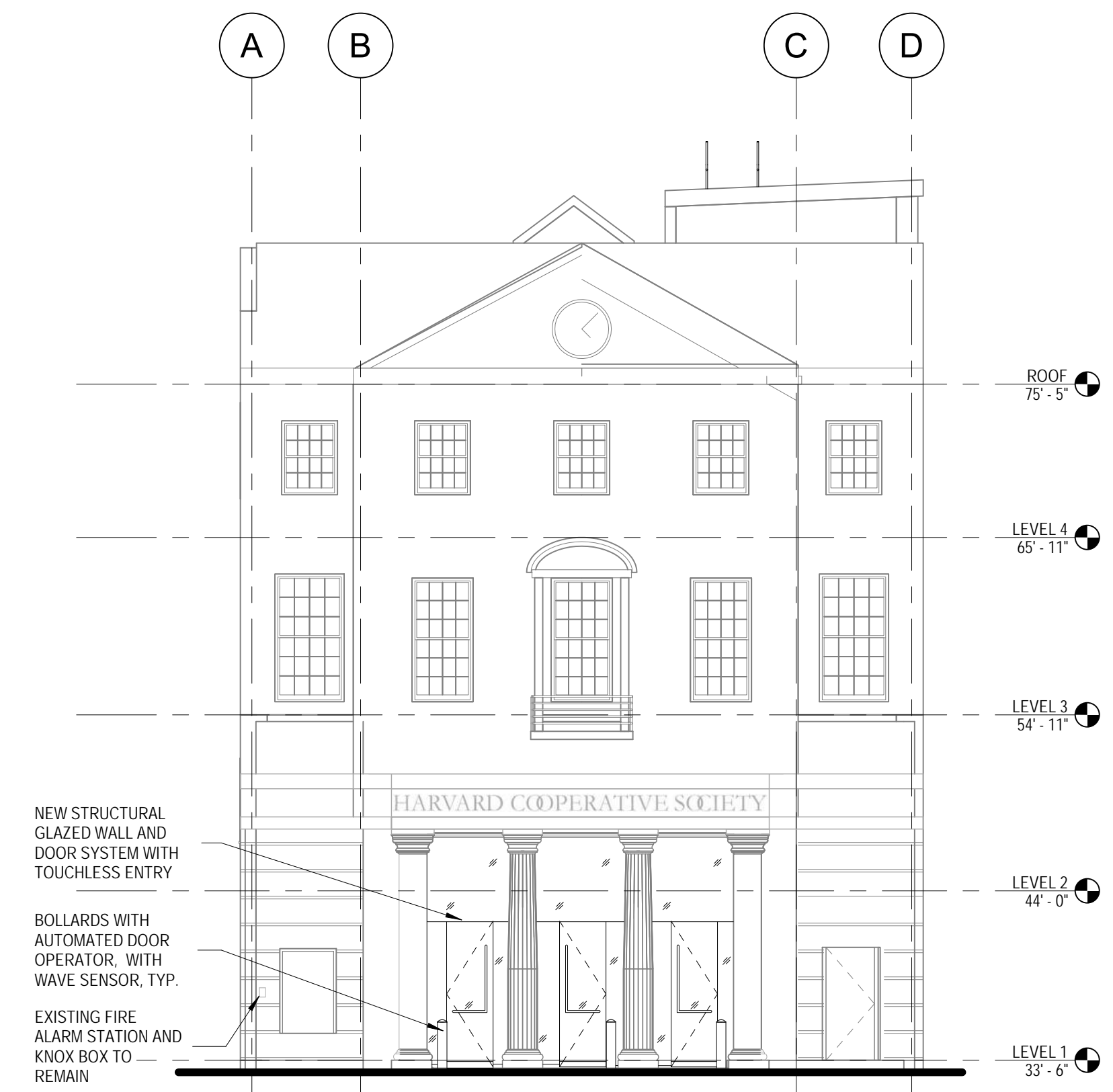

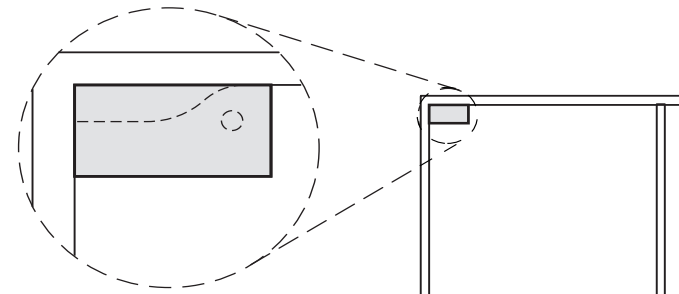

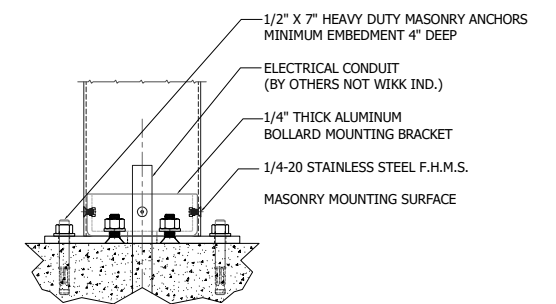
