1. ETP Director's Report- Susanne Rasmussen

- October 3 Solar Potential Event, solar map web tool
- September 21 Parking Day
 - o Spaces converted, shows how much space used by parked cars.
 - Have sent invites to take over space.
 - o 18 devoted including East Cambridge Dogs and 3 for Cambridge
 - Option for long term conversion currently cost prohibitive but will look at again
 - Call for committee members to staff 3 Cambridge spots, 8a-3pm, Porter Sq City

 - City Smart
 - CEA
 - CDD games
- Introduced Jen Lawrence, Sustainability Planner Running Parking Day
- Urban Forest Canopy Report on CDD website
- Hubway
 - Number of stations increasing; usage report available on 15th.
 - Cambridge has 15% of the bikes in the system -> will increase to about 20%.
 - Spotcycle app has lots of info.
 - Interest in business community wanting to invest
 - Some complaints about bad riders
 - Corporate memberships 100% of the money will go back into the Cambridge system
- Vulnerability Assessment is close to contract; start in Oct and done by 2013
- MAPC Regional Adaptation Study John and Sam attending
- LED streetlights \$2m for first 1/3 of changing
- Planner position posted

2. Motion for Approval on Meeting minutes- Minutes of 6/14/12 and 7/12/12 approved

3. Sam Lipson, Environmental Health Director, Cambridge Public Health Department

- Talked about experience of the process of interviewing firms and tossing out ideas for the vulnerability assessment.
- Mosquito Control climate changes seen as a driver; public health challenge
- Modeling public health impacts, difficulties predicting
- Interviews firm hired by city to do assessment; Sam was there representing the Public Health Department
- Three areas climate change impacts public health response
 - o Programs of public health, skill set, staff mix to address problems
 - Capacity of healthcare system (handle health crisis, includes fire, police, etc) ex.
 heat wave
 - Epidemiology using what we understand about disease models; vectors, impacts of heat; bridge vectors (increase rate via reservoir)
 - Ex. West Nile Virus outbreak in US (MA relatively spared)
 - Cases increased quickly
 - States had taken away monitoring resources
 - Challenged ability to look for patterns
 - MA slightly (not radically like some of the most impacted states) defunded surveillance
 - Mild winter gave mosquitoes a head start
 - Tend not to be working on vaccine not priority
 - Unpredictable nature of problem hard to predict reservoirs
 - Mosquito Control District Dave Henley (recommend as possible speaker)
 - Fears about EEE (Tiger Mosquito example)
 - Climate Health Program CDC
- Assessment = better prepared, better decision making, assessment of organizational capacity
 - o Firms brought in for engineering; gap in knowledge of urban public health
 - 2-3 good firms
 - Epidemiological, emergency response (different ways of looking at)
- Climate Change through public health lens graspable, not yet politicized, friendly vehicle, not yet able to get specific on impacts, frustration when used poorly in an argument
- Larvacide (BTI) temp applicator license, in 2005, state changed regs so municipalities cannot do currently a bill to change
- Different reactions to spraying outer ring happy and want more, inner core people do not like/are concerned
- Sam sending info on bill to address larviciding issue
- Public health ask budget for surveillance (state) -> more sophisticated

4. July 12 CPAC Meeting follow-up - Alternative Fuels

- Suggest schedule 2-3 meetings to address piece by piece, avoid having 25 people do draft
- John to schedule one meeting between each upcoming CPAC meeting
 - Alt fuels
 - o Entrepreneurship and schools

5. Report on 8/2 Climate Change Entrepreneurship Roundtable

- Roundtable hosted at One Broadway, 20 people, mostly energy related, start-ups, innovation center, city staff
- Asked people to respond to questions, thoughts on what clean energy sector needs.
- Issues
 - Space to support start-ups (especially clean energy need for garage space to develop products; lab space expensive)
 - Funding firms need funding (\$10K-150K) at later stage for data and to ask investors
 - State funding? Clean Energy Center
 - Web-based platforms
 - o Proximity to redline space just not in Kendall
 - Communication between city and start-ups
- Test bed fleshing out notion of what a test bed is
 - Pecan St, Austin good model (<u>http://www.pecanstreet.org/</u>)
- Piloting products at businesses invite local businesses to present ideas (more info on this being sent)
