- Assistant Director Waxman, stated that there's flexibility with Scytl's timeline.
- Commissioner Harris will reach out to Calvin to discuss recording a few training modules and report back to the Board at our July 26, 2023 meeting.
- The Board had a general conversation about staffing the Polls for early voting. Commissioner Harris referenced MIT Data Science Lab (MEDSL) review of Cambridge's 2021 Municipal Election, and the 2022 State Primary Election early in-person voting activity. Based on the results that showed low utilization of early in-person voting, Commissioner Harris asked what staffing levels we should use for the Municipal Election early voting sites? The Board, with input from the Executive Director and the Assistant Director, agreed that the Early Voting locations should have two supervisors and two inspectors for a total of four.
