- 1. Executive Director's Report No report was provided.
- 2. Assistant Director's Report The Assistant Director reported on Early/Absentee activity through October 31, 2023, which includes:
  - 14,010 Early Voting (including 553 in person) and 160 Absentee Voting (including the DCHFs)
  - Received back (accepted): 4,472 Early Voting (including 553 in person) and 39 Absentee Voting

Assistant Director Waxman reported that the School Committee finance reports were due on October 30. Only one is missing, and she is in discussion with two candidates regarding incomplete information.

## **Commissioners' Reports**

- Commissioner King reported conducting DHCF voting on November 1, 2023, with four votes cast.
- Commissioner Marquardt reported that 175 School Street is a valid address.
- He also conducted DHCF facility voting at Santa Maria, with seven votes cast.
- Commissioner Marquardt and Commissioner Harris conducted in-person Inspector training and ballot box training on October 26, 2023.
- Commissioner Ward and Commissioner King conducted in-person Inspector training and ballot box training on October 28, 2023.
- Commissioner Harris reported conducting DHCF voting at Neville Center on October 30.
- Commissioner Harris reported conducting DHCF voting at Neville Place on November 1, 2023.
- She also reported that there are two additional students who will be working.
