- 2. Buildings at risk (preferably preserved or not, still standing, and situation unresolved, with dates of required landmark hearing and expiration of demolition delay):
 - D-1402 (amendment): 146-148 Pearl St., by Campbell Ellsworth (12/1/16; 1/5/17). CHC waived the remainder of the demolition delay until the applicant receives approvals for the construction of the replacement. BZA granted relief for the driveway and tandem parking 11/17/16. CHC permission extended to 10/5/17. **Permit under review by ISD.**
 - Case D-1447: 221-223 Concord Ave., by 227 Concord Nominee Trust c/o Lauren Harder (10/4/17; 11/4/17). Demolish retail buildings (1925). Preferably preserved but delay waived. Revised plan removes a not-significant portion of the commercial building and eliminates the rooftop addition. Under construction.
 - Case D-1456: 411 Massachusetts Ave., by Watermark Central Venture LLC. Demolish and reconstruct building (1887) as part of larger Mass+Main project. Not preferably-preserved subject to staff review of masonry. Demolished; brick un salvagable.
- 3. Board of Survey proceedings: Vail Court, 137 Bishop Allen Drive (2 buildings, 1917): ordered demolished as structurally unsafe, a fire hazard, and unfit for habitation. Supposed to have been razed in July, but still standing due to a TRO granted to the former owners. The City has requested new bids for the project.

III. Neighborhood Conservation Districts (not all cases described).

1. Mid Cambridge NCD (Samantha Elliott). February 5:

- MC-5338: 1500 Cambridge Street, by Renie Realty, LLC. Demolish one-story commercial structure and construct three new residential units. Binding, approved as proposed.
- MC-5371: 19-19 ½ Fayette Street, by Mariana Ibanez and Simon Kim o/b/o 19 Fayette Street Nominee Trust. 19 Fayette Street Nominee Trust. Remove chimneys and bays, construct roof deck, alter windows and doors, replace siding, and alter front elevation as part of a larger renovation project. Non-binding; revised plan that preserves original façade approved with recommendation to use wood siding and submit a complete landscaping plan.

The original plan in case MC-5371 would have destroyed the façade of a significant Italianate house. Only unanimous neighborhood opposition, and promised support of an extra curb cut by abutters, averted a ruinous outcome. Fayette Street neighbors are now considering funding a National Register nomination to ensure that future reviews will be binding.

2. Avon Hill NCD (Charles Sullivan). Feb. 26, no meeting; March 26, no meeting; April 23, no meeting.

HCM-406: 12-14 Dinsmore Court, by Gus Souki o/b/o Valerie T. D'Amore 2012 Irrevocable Trust. Construct rear additions and dormer, replace windows, replace trim and siding, and other fenestration changes as part of a larger renovation project. Approved as proposed.

Max Frank of 9 Brewer Street and Rory O'Connor of 9 Foster Street have replaced Deb Masterson and Judith Dortz, while Jo Solet has replaced Bill King as CHC representative.

- 4. Harvard Square Conservation District Study. Initiated 3/2/2017. Monthly meetings began in October. The next meeting will be at 9:15 AM on May 23 at 1414 Mass. Ave.
- IV. Landmarks and Preservation Restrictions
 - 1. Designation proceedings, with date of expiration of one-year hold (if applicable):
 - L-119: 135 Western Avenue. See City Council agenda for April 30.
 - L-121: Harvard Square Kiosk. City of Cambridge, owner. The City Manager has appointed a 17-member committee to oversee improvements to the kiosk and the plaza. Touloukian Touloukian is the designer, working with Halvorson for the plaza and Partners for Public Spaces. **Design development underway.**
 - L-122: 101 Rogers St., Foundry Building (1/5/2018). The CRA has designated Cambridge Seven as the architects for the renovation. See City Council agenda for April 30.
 - L-124: 227 Cambridge St., Lechmere National Bank (12/1/17). The City Council approved the designation without debate on February 12.
 - L-127: 44 Cottage Street. (2/2/2018). The City Council approved the designation on March 5.
 - 2 Potential Landmarks and NCDs:

L-110: 37 Brookline St. fence. Designation request tabled. The owner has asked for further consideration of his designation request.

3. Preservation Restrictions.

Shady Hill Square (expires 2040). A requirement for public posting of park rules needs to be fulfilled. Attorney Stefan Nagel, an easement specialist, has offered advice indication that the restriction may not expire after all. We will pursue with the Law Department.

Public projects: Longfellow Bridge **bronze doors, finish approved**; City Hall woodwork restoration postponed until 2018; Harvard Square kiosk/plaza study; Magazine Beach powderhouse interior fit-out with public toilets and provision for commercial tenant under construction (CPA); Magazine Beach landscape plan (CPA); Magazine Beach signage under development (CPA); Lowell Park restoration, DCR approved matching grant for master plan (CPA); Fresh Pond intake structure (CWD) beyond economic repair, no obvious resolution; 859 Massachusetts Avenue (former Chamber of Commerce building) reuse by city; Foundry Building reuse; Brattle Street bluestone sidewalk restoration; **Longfellow Park stair replacement under way (DPW)**; bike lanes; Sparks-Craigie-Brattle intersection signalization or roundabout plan; Boardman School reuse (CRA); Kingsley Park overlooks (CWD); Gore Street sewer upgrade; Inman Square redesign (MCNCDC); **the revived Green Line Extension (GLX) project has requested approval of a modified trestle preservation scheme (mitigation for removal of NR eligible elevated structure)**.

b. Private projects: E&R Laundry adaptive reuse (Novartis) under construction; Twining Properties redevelopment at Lafayette Square; Alexandria Corp. adaptive reuse of former New England Maple Syrup Co. building at Second and Linsky being revised; affordable housing at 1791 Massachusetts Avenue and 1-2 Frost Terrace approved by BZA; adaptive reuse of 893-907 Main Street (Toscanini's) as hotel; Cambridge Gas-Light Co. building, 719 Mass. Ave. under consideration for additional stories; Harvard Square theater replacement preliminary plans reviewed; 17 Fresh Pond Parkway (1832, remodeled by former Harvard President Charles Eliot in 1909 with its 41,000 s.f. lot is under agreement with a broker; wholesale residential gas meter relocations on Berkeley Street averted; a restoration-minded owner has a signed P&S for the six-house St. John's Road property.

c. Institutional projects: Kendall Square Initiative (MIT), including buildings 1, 3 (238 Main), 4 (Hammett and MIT Press) and 5 (MIT Museum) under construction, **reviewed high-rise exterior mockups**; Lowell House renewal (HU NR) under construction; Sackler Museum renovation (HU) under construction; Eaton and Goffe plaques in Massachusetts Avenue opposite Holyoke Center to be replaced in 2018; 139 Main St masonry repairs (MIT); **Adams House renewal preliminary scoping, to begin 2019** (HU); First Korean Church, 35 Magazine St. belfry destroyed; Met Storage reuse by architecture department (MIT); Cooper-Frost-Austin house planning (HNE); Massachusetts Hall renovations; St. John's Road & 4 Berkeley Street property sales (EDS); Green Building reno (MIT); **Claverly Hall renovations (HU).**

- VI. National Register/Preservation Planning.
 - 1. Orchard Street NRD. This nomination will be finalized as staff becomes available.
 - 2. Harvard 106 agreement. No developments.
 - 3. MIT 106 agreement. No developments.
 - 4. Digitizing Inventory. The Commission's inventory of all 13,000 buildings in Cambridge exists only in paper form and occupies 31 file drawers. We have a \$30,000 CPA appropriation on hand. We are designing a demonstration project with input from Cambridge assessing and GIS departments and digitizing survey files for a single block in East Cambridge. **The next step is a scanning sample. We're waiting for additional funding from the IT department or CPA.**
- VII. Publications
 - 1. Building Old Cambridge. Four thousand copies were printed; as of April 1, 1,829 had left the warehouse, and net sales totaled \$48,809.

- 2. Oral history publications. We are considering reprinting *Crossroads: Stories of Central Square* (2001), and *Cambridge City Hall* (1990), which have gone out of print.
- 3. *Cambridge Street Names.* Volunteer Michael Kenney has updated a catalogue of city streets originally compiled by City Engineer Lewis Hastings in the 19th century. Michael has completed his project. After hard copies have been on the market for a while we'll post it on the CHC website.
- 4. *Cambridge Mayors*. Kit and Michael Kenney are preparing longer biographies of the mayors and other city officials whose portraits hang in City Hall. These will be published as a booklet.
- 5. Out of print publications. The MIT Press is exploring the possibility of digitizing *Report Two: Mid Cambridge* (1967), *Report Five: Northwest Cambridge* (1977), and *East Cambridge* (1988) and releasing them as open access PDFs to be hosted on archive.org.

VIII. Archives and Collections (Emily Gonzalez)

- 1. Survey Files Database Project: Survey Files Database Project (now designated C-DASH): Began contacting potential scanning vendors to view survey files. Boston Computer Scanning will meet with us on April 30. We submitted an E-Gov funding request in January, but may need to re-submit. Susan Maycock has been going through the East Cambridge survey files to prepare them for Phase 2 of our project.
- 2. Library: Archives Assistant Emily Magagnosc continues adding call numbers to our library books, as well as performing preservation storage and repairs on books as needed. Becky Shea, our Simmons LIS intern, has been assisting Emily with cataloging. Debuted the library catalog to the public. IT will place a TinyCat (library catalog) search bar on our webpage.
- 3. Collections: Our winter Simmons archives interns finished up their internships. Jacky processed and digitized a photograph collection of Cambridge buildings, and made phase boxes for some of our fragile library books. Elise processed and digitized the Charles Cogswell photograph album. Both collections are available to view on our Flickr page. Volunteer Kathleen Fox continued to work on processing the Ellis & Andrews real estate collection. Digitization Assistant Meta Partenheimer cataloged and rehoused several objects into our Object Collection. Meta also processed new additions to the Cambridge Ephemera Collection. New acquisitions and donations: Carter's Ink ephemera from Missouri collector John Hinkel, 1922 pamphlets describing Kendall Square businesses.
- 4. Social Media Outreach: Weekly Instagram posts and semi-weekly blog posts, highlighting interesting collections and newly digitized items. In April we highlighted local architecture, baseball in Cambridge, and new donations.
- 5. Additional Activities: Solidified list of participants and other details for this year's Cambridge Open Archives, which marks the event's 10th anniversary. It will be held over two weeks, June 11-15 and June 18-22, with 15 archives and libraries participating. Created a registration form, which goes live May 11. Sarah Burks created a webpage for Open Archives: <u>https://www.cambridgema.gov/historic/researchaids/openarchives</u>. Brought several boxes of our Newspaper Photograph Morgue collection to Digital Commonwealth at the BPL for digitization. With Kit Rawlins worked on a special exhibition for the Mayor's office on items made in Cambridge.

- XI. Grants: Community Preservation Act Projects and Preservation Grants
 - 1. FY 2018 Community Preservation Act Historic Preservation Appropriations. A one-time transfer from reserves (enabled by recapturing unexpended funds from prior years) allowed the appropriation for the Preservation Grant program to be increased from \$600,000 to \$700,000.

- 11. Digital permits. The Energov online building permit system requires a major commitment from both Sarah and Sam, limiting staff time for other activities.

We sent a report to the City Manager outlining measures to establish a Light Cambridge advisory committee that could carry out such a program. Updated the Manager on 9/13/17.
- 16. African American Trail. In FY2016, the City Council appropriated money to the Commission for expansion of the African American Heritage Trail. We hired Christle Rawlins-Jackson as project consultant; she has met with the Heritage Trail Alliance and staff at the commission and the historical society, and is compiling an initial list of possible new marker subjects. We have asked the Mayor to form an advisory committee to guide the choice of new marker candidates.
- 17. Solar policy. CDD staff and consultants have advised on a solar installation policy that staff will recommend for adoption by all commissions.
