## Meeting Minutes

**Board of License Commissioners Board Members Present:** Nicole Murati Ferrer, Gerard Mahoney and Branville Bard.

**Staff Present:** Elizabeth Y. Lint, Executive Director.

### Public Testimony Matters:

- 1) Application John Pugh, on behalf of Consigli Construction, has applied for a special noise variance from November 15, 2017 through June 30, 2018 from 6PM to 12AM at 1350 Mass. Ave. for: Installation of steel, concrete repairs and concrete demolition at the Dunster Pavilion, Mount Auburn Plaza, and Arcade areas of the building.

Matter was continued upon request of the applicant as they are still working with the businesses in the area to come up with a schedule that is least disruptive to all.

- 2) Application M&R Hospitality Group, Inc. d/b/a Pita, has applied for a Common Victualler License at 12 Springfield Street with a seating capacity of 7 inside and 10 outside on a patio on private property and proposed hours of 7:00 a.m. to 2:00 a.m. seven days per week. Mohamed El Zein as proposed manager of record of a premise described as: approximately 1000 SF on one floor. Kitchen in back and service counter and seating in front.

**Present:** Radoun Ouassaddi and Mohammed El Zein, applicants.

**Documents Considered by the Board:** Application and documents attached thereto, and letter in support from the East Cambridge Business Association.

**Summary:** The applicants explained that this will be a fast food Mediterranean restaurant. All food will be made from scratch at the location. They are remodeling the space so that the door will not hit patrons sitting at the counter. The application calls for seven seats, but ISD limits it to 6. The applicant is fine with decreasing the number

to 4, 5 or 6 but are looking for a total of 10-12 additional people standing in a space of 92 sq. ft.

**Decision:** Granted (3-0), the seating capacity will be limited to 6, the standing capacity will be administratively decided by the Board after consultation with the Fire Prevention Unit.

### **Administrative Matters:**

Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda.*

- 3) Jen Tran, on behalf of Far From the Tree Cider, has applied for a license to sell at a Farmer's Market at 5 Callender Street from January 6, 2018 through April 7, 2018 from 10:00 AM until 2:00 PM.

**Summary & Decision:** The application improperly states that the license is being sought for 2017. We confirmed with the applicant they intended to apply for 2018, and the Agricultural approval letter also confirms the market is intended to run in 2018. Granted (3-0), a note of the corrected year will be made when the approval is sent to the ABCC.

- 4) Walter Sousa, holder of license number ACH10121, has applied to open from 10:00 AM until 11:00 PM on Christmas Eve.

**Summary & Decision:** This request was to open at 10:00 a.m. on Sunday of Christmas Eve and close at 11:00 p.m. Granted (3-0).

- 5) Application Deferred from December 13, 2017, Sheger Café and Ethiopian Restaurant, LLC has applied for a new Common Victualler Wine & Malt Beverages License at 2376 Massachusetts Avenue. Misrak Gandhi as Proposed Manager of Record of a premise described as: approximately 1500 SF on the street level of Massachusetts Avenue with a bathroom, kitchen, and storage and 32 SF patio on public property. Proposed hours of operation are: 9:00 a.m. to 10:00 p.m. Monday through Saturday and 11:00 a.m. to 9:00 p.m. Sunday with a seating capacity of 44 inside and 8 outside on a seasonal public patio.

**Summary:** This was deferred because the application was incomplete – the application continues to be incomplete. The applicant has submitted the bank statements but has failed to submit the loan documents as well as a document clarifying the proposed beneficial interest holders in the license and the percentages to be held by each.

**Decision:** Deferred (3-0).

- 6) Patrick Martin, on behalf of Phoenix Communications, has applied for a Special Noise Variance at Fulkerson Street, Allston Street, River Street and Pleasant Street on December 13, 2017 through December 15, 2017 from 8:00 PM until 6:00 AM for fiber optic splicing.

**Decision:** Granted (3-0).

- 7) Approval of Renewals submitted, Requests for Extension of Hours on New Year's Eve and Administrative Acknowledgements/Changes/Corrections based on information submitted with renewal applications. (list will be presented at the hearing).

**Summary:** Board considered all matters. Board also acknowledged that some of the lists may have overlaps with previous lists due to the reporting features of the new licensing system.

**Decision:** Changes Granted/Board Acknowledged/Renewals Approved (3-0) (see attached lists/documents).

#### **One Day License Applications:**

- 8) Samyra Miller has applied for an entertainment license to be exercised at Harvard University, SOCH Event Hall, 59 Shepard Street on 1/27/18 from 10:00 p.m. – 2:00 a.m. for a party with patrons dancing and amplification system. Expected attendance – 300 people.

**Decision:** Granted (3-0).

- 9) Alexander Maciel has applied for an all alcohol license with entertainment to be exercised at St. Anthony's Parish, 400 Cardinal Medeiros Avenue on 1/14/18 from 1:00

p.m. – 5:00 p.m. for a family lunch with patrons dancing and recorded/live music.  
Expected attendance – 200 people.

**Decision:** Granted (3-0).

- 10) Alexander Maciel has applied for an all alcohol license with entertainment to be exercised at St. Anthony's Parish, 400 Cardinal Medeiros Avenue on 2/3/18 from 6:00 p.m. – 12:00 a.m. for a dinner dance with patrons dancing, recorded/live music and amplification system. Expected attendance – 250 people.

**Decision:** Granted (3-0).

- 11) Maura Dower, on behalf of the Brain Arts Organization, has applied for a one day wine & malt license on December 14, 2017 at 200 Broadway from 6:00 PM to 9:00 PM for an art show, with 75 people expected.

**Decision:** Granted (3-0).

- 12) Brittany Courier, on behalf of The Cambridge Program, has applied for a one day entertainment license on December 17, 2017 from 6:30 to 9:30 PM and December 18, 2017 from 3:00 to 6:30 PM for a theatrical performance.

**Decision:** Granted (3-0).

- 13) Ben Lavery, on behalf of Mitimco, has requested to extend their Special Noise Variance from January 1, 2018 through January 31, 2018.

**Decision:** Granted (3-0).

- 14) Efthymios Ioannidis has applied for a one day wine & malt license and entertainment license at 77 Mass. Ave. on December 15, 2017 from 9:00 to 11:30 PM and December 16, 2017 from 12:00 AM to 1:00 AM for a party with 150 expected.

**Decision:** Granted (3-0), with the condition that a police detail is required.

- 15) Bill Manley, on behalf of the Harvard Sq. Business Assoc. has applied for a one day entertainment license on December 16, 2017 from 11:00 AM until 3:00 PM for music at The Pit.

**Decision:** Granted (3-0), on the condition that the City permit is obtained and approves the use for the event and hours requested.

- 16) Rachel Roccoberton has applied for a one day wine & malt license at 536 Mass. Ave. from 6:30 -11:30 PM for a dance recital. This is a private event.

**Decision:** Granted (3-0) with the condition that the alcohol must be sold, or in the alternative, there must be an admission charge and a limited number of alcoholic drinks associated with that charge.

- 17) Aceituna Café, LLC is requesting to increase their hours to close at 8:00 PM instead of 6:30 PM.

**Summary & Decision:** The applicant is requesting a closing hour of 8:00 p.m. and to add the same hours on Saturdays (right now closed on Saturdays).

**Decision:** Granted (3-0) extension of closing hour on weekdays to 8:00 p.m., and to open Saturdays with the same operating hours as the weekdays; business remains closed on Sundays.

- 18) Katrin Michel has applied for a one day wine license on December 14, 2017 from 6:30 PM until 9:00 PM at 77 Mass. Ave., with 70 expected.

**Decision:** Granted (3-0) with the condition that the alcohol must be sold, or in the alternative, there must be an admission charge and a limited number of alcoholic drinks associated with that charge.

- 19) Nelson Oliveira has applied for a one day wine & malt license on December 16, 2017 from 8:00 to 10:00 PM at 178 Elm Street for a party with 80 expected.

**Decision:** Denied (3-0) because there is an alcohol license at the club that covers all floors. Cambridge Fire Department also has a long list of repairs to be made before they would approve this.
