MEETING MINUTES

Meeting Started at 3:03 p.m.

Board of License Commissioners Board Members Present: Nicole Murati Ferrer and Gerard E. Mahoney.

Note: All votes were 2-0.

Public Testimony Matters:

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1. Application Tria Cambridge Concessions, LLC d/b/a Freepoint Hotel, 220 Alewife Brook Parkway, holder of Common Victualler All Alcohol License #11569, has applied for a Change of Manager to Jeffrey Sellers.

Present: Andrew Upton, attorney; and Jeffrey Sellers.

Documents Considered by the Board: Application submitted and attachments thereto.

Summary: Mr. Sellers has never been the manager of record of an alcohol license but has extensive experience in the food and beverage industry, and is TIPS certified.

Decision: Granted.

2. Application Season to Taste Catering, LLC d/b/a Season to Taste, holder of a Common Victualler Wine & Malt Beverages License at 2447 Massachusetts Avenue has applied for an Alteration of Premise to remove the outdoor seasonal patio on public property. Proposed new premise description is: Approximately 1,000 square feet with Kitchen and dining room in an open space.

Present: Robert Harris, applicant.

Documents Considered by the Board: Application submitted and attachments thereto.

Summary: The intent of the opening of the patio was to provide an additional amenity/option to the neighbors/neighborhood. However, the patio ended up being underutilized. In addition, the Department of Public Works informed the business that any subsequent sidewalk obstruction approvals would require it to move the patio against the curb. Mr. Harris did not find this a good option as Massachusetts Avenue is too busy and being against it with the smoke of cars would not be too appealing to patrons. Therefore, they decided to remove the patio.

Decision: Granted, pending submission of affidavit of notice to abutters.

3. Disciplinary Hot Pot Boston 1, LLC d/b/a Happy Lamp Hot Pot, holder of a Common Victualler Wine & Malt License at 485 Massachusetts Avenue, for alleged violations of: No crowd manager documentation, blocked exits and other violations of the fire code on 3/17/18, in violation of G. L. c. 138, §§ 23, License Commission Rules 2.3, 2.5, 5.1, 5.7, 8.3, 9.3, and 9.4.

Present: Andrea Boyer, Chief Licensing Investigator.

Documents Considered by the Board: Hearing notice and document attached thereto; and file.

Summary: After a second call was made, at 4:20 p.m., the Board noted the licensee did not appear and proceeded with the hearing. During a Task Force Inspection, investigators found that no one on the premises had the Crowd Control certification or any of the required paperwork. In addition, blocked egresses/exits were found.

Decision: Voting would be deferred to June 6, 2018, to ensure proper notice was given, and if so, violation 2-days suspension.

Note: The next three matters were called together but considered independently.

4. Disciplinary Whole Foods Market, 115 Prospect Street, due to alleged violations that on March 15, 2018 at 6:17 a.m., March 20, 2018 at 6:25 a.m., March 21, 2018 at 6:29 a.m., March 23, 2018 at 4:46 a.m., March 26,2018 at 5:57 a.m., March 27, 2018 at 6:24 a.m., March 29, 2018 at 6:08 a.m., and May 1, 2018 at 10:12 p.m., merchandise was unloaded, and/or a dumpster was loaded or unloaded in the residential zone of Whole Foods in violation of Cambridge Municipal Code 8.16.080(E).

5. Disciplinary Atlantic Waste System d/b/a Casella Waste, due to alleged violations that on March 21, 2018 at 6:29 a.m., March 26,2018 at 5:57 a.m., and March 29, 2018 at 6:08 a.m., a dumpster was loaded or unloaded in the residential zone of Whole Foods in violation of Cambridge Municipal Code 8.16.080(E).

6. Disciplinary E. L. Harvey & Sons, Inc., due to alleged violations that on March 23, 2018 at 4:46 a.m., and April 5, 2018 at 4:58 a.m., a dumpster was loaded or unloaded in the residential zone of Whole Foods in violation of Cambridge Municipal Code 8.16.080(E).

Present: Andrea Boyer, Chief Licensing Investigator; Tyler Bubenik, Assistant Licensing Investigator; Officer Wenzel; Seamus Monahan, Whole Foods; Jack Manning, Casella Waste; Gerald Sjogren, Harvey & Sons; and David Bartch, resident.

Documents Considered by the Board: Hearing notices and attachments thereto; and Investigators' report.

Summary: The lot in which Whole Foods is located straddles residential and commercial zones. The area in which the dumpster is located and where products are delivered fall on the residential zone. On March 15, 20, 21, 23, 26, 27, 29, and May 1, 2018, merchandise was unloaded and/or a dumpster was loaded/unloaded prior to 7:00 a.m. in violation of the Ordinance.

Whole Foods has spoken to its distributors to change the delivery hours and has changed the restocking of the store to the nighttime (at 10:00 p.m., store closes at 10:30 p.m.). There is also a policy that nothing can be delivered/processed until 7:00 a.m. In addition, both waste companies which were unaware of the residential zone until they received the hearing notice, are now aware that the dumpster cannot be loaded/unloaded/handled on weekdays between 9:00 p.m. and 7:00 a.m., and 9:00 p.m. to 9:00 a.m. on weekends or holidays. The resident noted that since the notice of hearing went out, the noise issues seems to have resolved.

Decision: As to Whole Foods, violation, must pay a \$300 fine; as to Casella Waste, violation, \$300 fine to be held in abeyance for one (1) year; as to Harvey & Sons, violation, \$300 fine to be held in abeyance for one (1) year.

7. Application Pemberton Fruit Orchard, Inc., holder of an All Alcohol Package Store License and Common Victualler License at 2225 Massachusetts Avenue, has applied for a Change of Hours to close at 11:00 p.m. Monday through Saturday and 9:00 p.m. on Sunday.

Present: James Rafferty, attorney; and Thomas Saidnawey, licensee.

Documents Considered by the Board: Application and documents attached thereto.

Summary: This is a locally owned business highly engaged in the neighborhood. They have noticed a demand for later shopping hours and later food retail in the area. Their customers demand the option. The requested hours of operation will be: for food – same as current, 7AM-11PM all days except Sundays which have a closing hour of 9PM; and for alcohol – 8AM-11PM all days except Sundays which will be 10AM-9PM.

Decision: Granted pending submission of affidavit of notice to abutters.

8. Application ARE-MA Region No. 50, LLC, has applied for a new Garage with Flammables License at 150 Second Street for 94 parking spaces, 940 gallons of gasoline in the tanks of autos only, 790 gallons of Class 1, and 720 gallons of Class 2 (diesel).

Present: Laura Graziano, applicant.

Documents Considered by the Board: Application submitted and documents attached thereto.

Summary: The 94 spaces are for the sole us of the tenants. The tenants will be charged a fee for the use of the spaces. There is a fuel storage room in the garage.

Summary: Granted.

9. Cancellation Uno Restaurants, LLC, holder of a Common Victualler All Alcohol License #11698 linked to 22 JFK Street for Non-Use pursuant to G. L. c. 138, § 77.

Present: George Herz, general counsel for license holder.

Documents Considered by the Board: Hearing notice, past decisions and file.

Summary: The information provided at the last hearing was that there was a dispute between the landlord and the tenant regarding the terms of the lease. The dispute is still ongoing but they are working to resolve it. There was a summary possession claim instituted. The decision has been rendered. The license holder seeks additional time to resolve its dispute with the landlord and claims there is no prejudice to the License Commission in granting the additional time.

Decision: Vote deferred pending submission of summary possession decision.

10. Application Coffeeshop, LLC d/b/a Upperwest, holder of a General on Premise All Alcohol License and Common Victualer License at 1 Cedar Street, Unit B, has applied for an Alteration of Premise to add an outdoor patio on private property. Proposed premise description is: Approximately 1,140 square feet basement level in two rooms, including kitchen. 900 square foot outdoor patio on private property.

Present: Kim Courtney, applicant; Xavier Dietrich, applicant; Paul Corriveau, UAV representative; Joseph A. Boulanger, UAV representative; James Danila, resident.

Documents Considered by the Board: Application and attachments thereto, and subsequent documents provided after filing of application, including but not limited to updated floor plan, lease, and petition in support of application.

Summary: The applicants state they have a well-established restaurant and want to add the amenity of the outdoor area which has been requested by their patrons and well received. The

applicants pointed out to the various outdoor events licensed during the past summer. The applicants submitted a list of petitioners in support of their application. Mr. Danila, a resident of the area also spoke highly of the current operation and in support of the extension of premises.

The UAV representatives contended that the amount of space delineated in the proposed floor plan does not accurately depict the area for which the applicants have a right to under the lease. The lease, which was provided at the hearing, does not include a floor plan or dimension of the outdoor area. The applicants contended they have a right to approximately 250 square feet, whereas the UAV contended the area is only approximately 160 square feet. The UAV spoke against the granting of the application.

Decision: Vote deferred to June 6, 2018 pending and inspection of area with Licensing Investigator(s), applicant and UAV.

11. Application Jennifer Capelo Silva has applied for a New Cambridge Hackney Driver's License.

Present: Joseph Silva, applicant.

Documents Considered by the Board: Application submitted and documents attached thereto.

Summary: During May 9, 2018 meeting, Ms. Capelo was approved for a new hackney dispatch service license. She intends to own and possibly operate a medallion. She has never been a licensed hackney driver. Her driving history is clear and she has met with Officer Szeto.

Decision: Granted.

12. Disciplinary Rehearing from February 28, 2018. Royal Punjab Enterprises, Inc. d/b/a Royal Punjab, holder of a Common Victualler License #12238 at 251 Cambridge Street due to allegedly operating without a valid license and altering a license in violation of, but not limited to: M. G. L. c. 140 §§ 2, 9, and 20.

Decision: No action – prior to the hearing and upon request of the licensee's attorney, the matter was moved to meeting of June 6, 2018.

Administrative Matters

All the below listed matters are considered and voted upon by the Board without public testimony. Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda.

13. Application Surya Binayak, Inc. d/b/a City Liquors, has applied to transfer the All Alcohol Package Store License at 12 Museum Way held by Museum Market Corp and a Change of Location from 12 Museum Way to 212 Hampshire Street. Binoj Pradhan as Proposed Manager of Record of a premise described as: Approximately 2500 sq. ft. on the first floor in three rooms. Two entrances and two exits.

Documents Considered by the Board: Application submitted and documents attached thereto; letters regarding application; and Affidavit of Binoj Pradhan.

Summary: This matter was heard on April 25, 2018 but the Board deferred its vote because the proposed location has a § 12 liquor license attached to it. The Board considered all the information provided to it at the April 25, 2018 hearing. The Board also noted that since the hearing, the holder of the § 12 license linked to the location has stated the second half payment for the renewal of the license would not be paid further emphasizing there was no intent to continue having the license operate past June 2018. The Board also addressed the receipt of Mr. Pradhan's affidavit which reemphasizes the information provided to the Board through the pending application and at the April hearing – the proposed operation is to be owned, operated and held by Mr. Pradhan not a nationwide retailer.

Decision: Granted with a note to the Alcohol Beverages Control Commission regarding the state of the current license at the location.

Note: The next two matters were discussed simultaneously but considered separately.

14. Application DiDi Ames Street Kendall, LLC d/b/a Dumpling Daughter, has applied for a new Common Victualler Wine & Malt Beverages License at 73 Ames Street. The proposed hours are 11:30 a.m. to 9:00 p.m. Monday through Saturday and 11:30 a.m. to 8:00 p.m. Sunday with seating for 45 inside and 20 patio seats on public property. Nadia Spellman as Proposed Manager of Record of a premise described as: 2,614 sq. ft. ground floor retail space with bathrooms, kitchen and dining area, two entrances and three exits. 1,430 sq. ft. mezzanine space. 213 sq. ft. patio on the public sidewalk.

15. Application Vester, LLC d/b/a Vester, has applied for a new Common Victualler Wine & Malt Beverages License at 73 Ames Street. The proposed hours are 7:00 a.m. to 7:00 p.m. all days with alcohol sales staring after 8:00 a.m. Monday through Saturday and 10:00 a.m. Sunday with seating for 44 inside, 60 total occupancy and 16 patio seats on public property. Record of a premise described as: 1,184 sq. ft. ground floor retail space with kitchen and dining area, four entrances and four exits. 180 sq. ft. patio on the public sidewalk.

Summary: These two applications were heard on April 25, 2018. The Board deferred its vote at the time to get a better sense of the space and evaluate the concept which is to have two separate liquor licenses in the same lot but in different spaces. The businesses would not always operate within the same hours. In addition, the business although at the same address have separate footprints inside. The only "shared" space is the bathroom which is located within the footprint of Dumpling Daughter. There is also an employee/storage room on the mezzanine level of Dumpling Daughter. Both places have separate kitchens and coolers.

Decision: As to Dumpling Daughter – Granted with the condition that there can be no comingling of alcohol funds/profits, merchandise or storage with Vester. Dumpling Daughter's alcohol can only be stored and consumed within the approved footprint operating area of Dumpling Daughter.

As to Vester – Granted with the condition that there can be no comingling of alcohol funds/profits, merchandise or storage with Dumpling Daughter. Vester's alcohol can only be stored/consumed within the approved footprint operating area of Vester. Also, inside seating limited to 40 per zoning. The approval is not to be submitted to the ABCC until the complete three months of financials are submitted.
