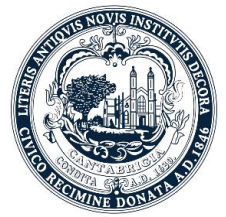

- 1. Continuation from March 16, 2017. Need to change route to get off of sidewalk; need site visit to see what to work through. Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143, for the following: **Albany Street** – Northeasterly form MHC3502 approximately 180 feet southwest of **Portland Street**, a distance of about 265 feet – conduit. This work is necessary to support a service upgrade to M.I.T. Additional underground lines are necessary due to M.I.T. load growth/new buildings (W.O. #2014470).**
