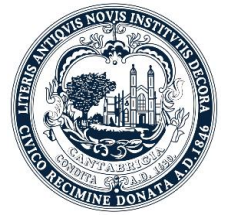

- 1. Continuation from April 20, 2017. Need more information regarding service (what the conduit will service specifically).** Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143, for the following: **Kirkland Street – At Myrtle Avenue** and easterly from MHC858, a distance of about 118 feet – conduit. This work is necessary to supply power to 100 Kirkland Street (W.O. #2180946).

To be refiled with petition for new project so they can be considered together.** Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143, for the following: **Walden Street – Northerly from Pole 697/56** approximately 163 feet west of **Sherman Street**, a distance of about 50 feet – conduit. This work is necessary to supply service to **269R Walden Street** (W.O. #2198355).

9. **Continuation from December 15, 2016. To allow Comcast to get permission from Verizon. Comcast, 426 E. First Street, Boston, MA 02127**, for the following: **Cardinal Medeiros Avenue** - From Pole 687/2, trench 120 feet in the public way southeasterly to BLDG# **286 Cardinal Medeiros Avenue**, installing 1-4" PVC conduit. This will include the removal and replacement of 1 sidewalk panel.

10. **New Petition Comcast, 426 E. First Street, Boston, MA 02127**, for the following: **1607 Massachusetts Avenue** - Place 1 new Comcast Manhole over existing Comcast conduit system on **Everett Street**, 89' east of **Massachusetts Avenue**. Trench 37' northerly to the property line of **1607 Massachusetts Avenue**, installing 1-4" PVC conduit. This will include the removal and replacement of 2 sidewalk panels. HU contractor will complete all street work to City specifications.

11. **New Petition Comcast, 426 E. First Street, Boston, MA 02127**, for the following: **1860 Massachusetts Avenue** – From Pole 2 on **Upland Road**, trench 5' in the public way installing 1-4" PVC conduit. This will include the removal and replacement of 1 sidewalk panel.

12. **New Petition Comcast, 426 E. First Street, Boston, MA 02127**, for the following: **300 Third Street** – From Pole 667/48, trench southerly then easterly, total of 150' on **Linskey Way** to existing private property manhole at the rear of **300 Third Street**, installing 1-4" PVC conduit. This will include the removal and replacement of 2 sidewalk panels.

13. **New Petition Comcast, 426 E. First Street, Boston, MA 02127**, for the following: **29 Highland Street** – From Pole 20/11 on **Appleton Street**, trench 5' in the public way installing 10" PVC conduit. This will include the removal and replacement of 1 sidewalk panel. Homeowner's contractor will complete all sidewalk work to City specifications.

14. **New Petition** Beals and Thomas, Inc., Reservoir Corporate Center, 14 Turnpike Road, Southborough, MA 01772-2104, for the following: Conduit will be laid in the following streets – **West Boulevard, Dawes Street, North Point Boulevard, North Street, North First Street** and **Child Street**. These streets will be privately owned when conduit is to be laid, and will be transferred to municipally-owned at a later date to be determined.

15. **New Petition** Crown Castle NG East LLC, 1220 Augusta Drive, Suite 600, Houston, TX 77057, for the following: **Banks Street** – Extension of the fiber optic network beginning at the untagged pole at the intersection of **Banks Street** and **Mt. Auburn Street** approximately 81’ in new 4” conduit to Verizon Manhole 26/210 on **Mt. Auburn Street**.

**Mt. Auburn Street** – Further extension in Verizon leased conduit from Manhole 26/210 approximately 488’ to Verizon Manhole 26/212 at the intersection of **Mt. Auburn Street** and **DeWolfe Street**.

**DeWolfe Street** – Approximately 18’ in new conduit to a Crown Castle Vault saddling Harvard Conduit then continuing approximately 200’ in Harvard Conduit to a Harvard Manhole at the intersection of **Bow** and **Arrow Streets**, breaking out in new 4” conduit approximately 49’ to Verizon Manhole 26/575.

**Bow Street** and **Mt. Auburn Streets** – Approximately 83’ in 8 new 1 ¼” conduits (two quad ducts) to a proposed 3X3 vault at the intersection of **Mt. Auburn** and **JFK Street**, then continuing approximately 394’ in new conduit along **JFK Street**, and then continuing approximately 251’ in new conduit to a proposed 3X3 vault at the intersection **South Street**, then continuing along **South Street** with two additional 4” conduits terminating at Pole 10 on **South Street**.

\*\*All as shown on plans titled “**Banks Street at Mt. Auburn Street**”, “**Node 44 - Mt. Auburn Street and DeWolfe Street**” and “**Node 44 - Winthrop Street, JFK Street, South Street.**”

**South Street** – Installation of equipment and pole top antenna on Pole 10.
