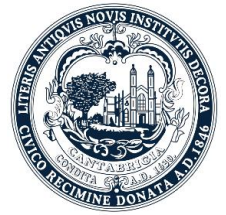

- 1. Continuation from June 15, 2017. Installing pad mount transformers. Double poles need to be removed.** Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143, for the following: **Decatur Street** – Southeasterly from Pole 205/1 approximately 132 feet northwest of **Brookline Street**, a distance of about 72 feet – conduit. This work is necessary to supply service to **125 Brookline Street** (W.O. #2182131).

- 2. New Petition** Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143, for the following: **Albany Street** – At **Massachusetts Avenue** and northeasterly from MHC3498 to MHC3503 a distance of about 479 feet – conduit.

**Albany Street** – At **Massachusetts Avenue** and northeasterly from MHC3499 to MHC3503 a distance of about 560 feet – conduit. This work is necessary to support M.I.T. construction of a new station (W.O. #2014470).

**Marcella Street** – Install one (1) manhole – MH30423.

**Berkshire Street** – At **Marella Street** and northwesterly from new MH30432 a distance of about 75 feet – conduit. This work is at the request of the city of Cambridge due to the King School Renovation (W.O. #2134781).

This work is necessary to supply service to **1607 Massachusetts Avenue** (W.O. #2209790).

7. **New Petition** Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143, for the following: **Prospect Street** – Southeasterly from Pole 567/27-A approximately 178 feet northeast of **Harvard Street** a distance of about 34 feet – conduit. This work is necessary to supply service to **147R Prospect Street** (W.O. #2210165).

8. **New Petition** Nstar Electric Company, 101 Linwood Street, Somerville, MA 02143, for the following: **Concord Avenue** – Northerly form MHC3020 approximately 130 feet south of a new public way a distance of about 792 total feet – conduit. Install two (2) new manholes MHC30238 & MHC30239. This work is necessary to supply power to **75 New Street** (W.O. #2109130).

9. **Continuation from May 18, 2017, to see if there is connectivity to the building.** Comcast, 426 E. First Street, Boston, MA 02127, for the following: **300 Third Street** – From Pole 667/48, trench southerly then easterly, total of 150’ on **Linskey Way** to existing private property manhole at the rear of **300 Third Street**, installing 1-4” PVC conduit. This will include the removal and replacement of 2 sidewalk panels.

10. **New Petition** Comcast, 426 E. First Street, Boston, MA 02127, for the following: **Decatur Street** – From Pole 205/1 on **Decatur Street**, trench northerly 4’ in the public way to the private property line of **125 Brookline Street**. Installing 1 sidewalk vault and 14” PVC conduit. This will include the removal and replacement of 1 sidewalk panel.

11. **New Petition** Comcast, 426 E. First Street, Boston, MA 02127, for the following: **150 Huron Avenue** – From existing Comcast sidewalk vault in front of **150 Huron Avenue**, trench northerly 4’ then turn easterly 4’ to the private property of **150 Huron Avenue**. Installing 1-2” PVC conduit in the public way. This will include the removal and replacement of 2 sidewalk panels.

12. **New Petition** Comcast, 426 E. First Street, Boston, MA 02127, for the following: **Bent Street** – From Pole 259/2.5 on **Bent Street**, trench northerly 43’ in the public way to the private property line of **121 First Street**. Installing 1-4” PVC conduit. This will include the removal and replacement of 2 sidewalk panels.

13. **Continuation from June 15, 2017, for yearly maintenance fee setup and to reach out to other utilities for common trench.** Cambridge Network Solutions, 35 McGrath Highway, Somerville, MA 02143 for the following: **Binney Street** – Starting at private property manhole at **399 Binney Street**, trench 900' +/- in an easterly direction in the public way to Level 3 MH0515-2900 on **Binney Street** at the intersection with **Fulkerson Street**.

14. **New Petition** Harvard University, 1414 Massachusetts Avenue, Cambridge, MA 02138, for the following: **Harvard University Private Property** – Construct approximately 40' of 2-4" Sch 40 PVC conduit, concrete encased duct bank within an existing alley for **53 Bow Street**, off of **Plympton Street**. The duct bank will be constructed from an existing utility pole to the ROW on **Plympton Street**.

**Plympton Street** - Construct approximately 110' of 2-4" Sch 40 PVC conduit, concrete encased duct bank within **Plympton Street** from the utility for **53 Bow Street** to **22 Plympton Street**.

**Harvard University Private Property** – Construct approximately 300' of 4" Sch 40 PVC conduit, concrete encased duct bank on private property for Harvard University. The duct bank will originate within the parking lot of **22 Plympton Street**. The 2-4" duct bank from **Plympton Street** will connect to a new utility manhole that will be located in the north east corner of the parking lot. 1-4" duct bank will be encased with the 2-4" from **Plympton Street** and will connect to the building at **14 Plympton Street**. 2-4" duct bank will travel east out of the manhole between building at **22 Plympton Street** and **9 Bow Street**. A new utility manhole will be constructed in the parking lot of **9 Bow Street**, in the north west corner. The 2-4" duct bank will exit the manhole on the east side and exit the parking lot at the driveway entrance on Bow Street.

**Bow Street** – Construct approximately 30' of 2-4" Sch 40 PVC conduit, concrete encased duct bank in **Bow Street** from the ROW at the driveway entrance to **9 Bow Street** to the east side of **Bow Street** to an existing Harvard University Information Technology (HUIT) underground duct bank system. A new manhole will be constructed on the east side of **Bow Street** across from **9 Bow Street** on the existing duct bank to connect the new duct bank to the HUIT duct bank.

**Arrow Street** – Construct approximately 260’ of 2-4” Sch 40 PVC conduit, concrete encased duct bank in **Arrow Street** from an existing HUIT MH at the intersection of **Bow Street** and **Arrow Street** to an existing Comcast MH adjacent to **1168 Massachusetts Avenue**.
