Item 3: Upcountry Reservoir Report

David Kaplan reported that a \$200,00 grant from the state allowed Cambridge to purchase 2 parcels in Lincoln totaling 8 acres, adding to our watershed protection lands. D. Kaplan also discussed exploratory dam work at Hobbs Brook Reservoir Dam to develop and prioritize recommended repairs. Watershed Supervisory, Jamie O'Connell discussed Watershed Division work with the Waltham Fire Dept hazmat crew to review their procedures near the Upcountry watershed and with Mass DOT to improve the functioning of their stormwater management structures. Frequent water quality monitoring and site monitoring makes sure the water complies with standards. Parcels within the watershed can now be tracked in a GIS system and all field data, reports and meetings can be accessed electronically.

Item 4: CDD Open Space Planning

Gary Chan gave a summary of the current status of CDD's project to review all of the City's open space parcels, its survey of residents and the planning process. The Advisory Board had invited Gary to discuss the unique nature of the open spaces in the Reservations as protected water supply lands. Board members noted the extensive landscape restoration work completed FPMPAB 05-19-22 Meeting Minutes (SSC) Page 1 of 3

and policies established by the 2001 Master Plan. Gary was asked if people he surveyed who used the reservation knew that it was the City's water supply. He said it is not currently something that they ask in the surveys. Gary agreed that he will consult with the Water Department on any open space plans that reference or include Reservation land.

Item 5: Friends of Fresh Pond 2021 Woodlands Project Report

Friends members Elizabeth Wylde and Advisory Board member Candace Young discussed their annual written report distributed to the Board. They are concerned by increased animal destruction of many new and some existing plants. Mountain Laurel was planted but many that were too big to cage have been eaten by deer. Vinnie is working with them to explore deterrents. There was discussion about whether there was a need for special netting for seedlings.

Item 6: Watershed Manager's Report

<u>Huron Pine Forest Study</u>: David Kaplan gave an update and spoke about the existing conditions survey that will extend from the Fresh Pond Parkway edge of the forest to the switchback stairs along Huron Ave. That Phase 1 area encompasses a portion of the Perimeter Road that will have to be reconstructed and the land between the Road and the multiuse path.

The Phase 2 area includes the rest of Pine Forest.

<u>Old Field Birch Grove (OFBG) seating area update:</u> D. Bitsko shared a revised concept plan and presentation. The presentation can be found using the link below.

The benches will be moved back. The area of the concrete pad will be increased, and the fountain will be moved back.

C. Thompson recommended *Cornus Canadensis* (bunchberry) be removed from the planting plan due to climate change pressures.

Members present unanimously approved the revised concept.

<u>Multi-use path status, signage, planting repair along treatment plant swales</u>: The Path is mostly done. A few punch list items remain. CWD is investigating opportunities for wayfinding signs.

The layer of mulch deposited in the swale across from the Treatment Plant will have to be raked out.

<u>DPW's Huron Ave sidewalk, roadway bike lanes & Tree Planting</u>: DPW believes that the Glacken field project will be completed in June. The Huron Ave Chapter 90 bid for the roadway bike lane will be going out shortly.

Landscape Management Report: V. Falcione was not available to contribute..

Item 7: Status of Council Policy Order Reviewing Reservation Golf Course Use Sam Corda reported no new information on this issue.

Item 8: Golf Course Buffer Zone Management Implementation

Status of buffers along ponds and woodland to be moved to a later meeting.

Item 9: Status of Naming Request for Drainage/Community Project Area

Note: The January 20, 2020 Advisory Board letter formally recommended to the Manager that the City "officially rename the above-described restored area of the Reservation after the late Water Board President, Dr. Joseph (Joe) John Harrington, as either Harrington Way or Harrington Gateway."

Sam Corda reported no new information on this issue.

Item 10: Reservation Community Gardens in CP&GC Booklet 2020-2921

J. Burns discussed Community Gardens in Cambridge. Fourteen Gardens in Cambridge, two of which are in the Reservation, are included in the booklet. Detailing in text and color photographs the Club presents the history and current use of each garden. Club members met with Jen Letourneau to gather information on the gardens.
