EXECUTIVE DIRECTOR ELIZABETH LINT:

APPLICATION: IBD Limited $d / b / a$ Darwin's

Ltd., Carrie Richgels, Manager, has applied for a common victualer licensing to be exercised at 313

Mass Ave. Said license, if granted, would allow food and nonalcoholic beverages to be sold, served, and consumed on said premises with a seating capacity of 19. The hours of operation will be Monday
through Saturday from 6:30 a.m. to 9:00 p.m. and Sunday from 7:00 a.m. to 9:00 p.m.
Applicant is also applying for an
entertainment license to include an audio machine
which may play music below, at, or above conversation level.

ATTORNEY JAMES RAFFERTY: Good evening,

Commissioners.

For the record, James Rafferty appearing on behalf of the applicant IBD Limited. Seated to my right is Ms. Carrie Richgels,
$R-I-C-H-G-E-L-S$.

Ms. Richgels is the proposed manager.

IBD Limited is the corporate name of

Darwin's. The Commission may be familiar.

Cambridge currently has two Darwin's.

There's cafes, green grocers, bakeries,
there's one on the Skenderian block on Cambridge

Street, been there about eight years, and
probably now closer to 20 years on Mount Auburn

Street heading out beyond the post office.

They are both neighborhood-based.

Popular cafes. They serve a wide range of food.

And they are really seen as really very treasured
amenities for those people that life around
them.

This is a location on Massachusetts

```
Avenue next to the University Stationery Store
down heading towards Novartis.
    It currently has a CV license for a
Chinese restaurant called Royal. Is that --
CARRIE RICHGELS: I don't know.
EXECUTIVE DIRECTOR ELIZABETH LINT:
```

Royal Bengal.

Attorney JAmes RAfferty: Yes, Royal

Bengal.

Is that still in operation?

EXECUTIVE DIRECTOR ELIZABETH LINT:

I don't know.

ATTORNEY JAMES RAFFERTY: It is the Royal

Bengal space.

And the proposal is to operate a Darwin's
in that location.

Ms. Richgels has been working at the

Cambridge Street location for six years so she's quite familiar with the operation and the

```
requirements associated with running a store.
```

    Darwin's has an exemplary reputation as a
    CV licensee.

They also hold a package store license at their Mount Auburn Street location.

And I think it is fair to say that they
have operated both of those establishments in
exemplary fashion and our expectation is that
this third vision of Darwin's would be as well
received and operated as the existing two.

FIRE CHIEF GERALD REARDON: 19 seats, that's all inside.

Is there a space in front for outside
door seating?

ATTORNEY JAMES RAFFERTY: At the moment
that's not contemplated.

There's an option in a year or two to
take the space next door to expand. And I think
at that time there might be some consideration to
do that.

There will be some cooking on premises.

A prep area. There's sandwiches. And mostly brought-in baked goods.

There's no baking that occurs on the premises.

CARRIE RICHGELS: Just the cookies.

ATTORNEY JAMES RAFFERTY: This is smaller than the other two Darwin's.

But the opportunity exists to expand in a year or two to expand and that's, frankly, part
of the long-term plans of the separation.

FIRE CHIEF GERALD REARDON: Are these
hours similar to the other locations?

ATTORNEY JAMES RAFFERTY: I believe they
are.

FIRE CHIEF GERALD REARDON: And they seem
to work well for you?

CARRIE RICHGELS: Very much.

ATTORNEY JAMES RAFFERTY: This is a block
of Mass. Ave with Flour Bakery.

Novartis is putting a lot more employees
in. Millennium is putting their new building
across the street as part of the expanded Central

Square retail area.

FIRE CHIEF GERALD REARDON: My question
earlier to Ms. Lint was I didn't even know there was a vacancy there.

ATTORNEY JAMES RAFFERTY: Yeah, I have to
confess I'm assuming that -- they ceased
operation but $I$ think the lease presumes that they have.

EXECUTIVE DIRECTOR ELIZABETH LINT:

I don't know.

FIRE CHIEF GERALD REARDON: The
assumption is that you have already a lease lined up.

ATtORNEY JAMES RAFFERTY: Yes.

And we have provided a copy of the lease.

The landlord is an entity associated with
the licensed premises there, the Miracle of

Science ownership, he's the landlord. So
they --

FIRE CHIEF GERALD REARDON: I don't
know how old the equipment is from Royal Bengal
but, again, we do a -- you are going to make sure --

AtTORNEY JAMES RAFFERTY: I have talked
to Mr. Darwin.

It is a complete gut of the kitchen
bringing it up to code. I think any of the
existing equipment is not usable.

The nature of the cooking is very
different too.

FIRE CHIEF GERALD REARDON: How long
before you expect to be up and running?

CARRIE RICHGELS: Construction will
hopefully start in the fall, and then the so slow season.

So maybe January or February hopefully. FIRE CHIEF GERALD REARDON: Any
questions?

POLICE COMMISSIONER ROBERT HAAS: NO
questions.

FIRE CHIEF GERALD REARDON: Any questions
from the public who wish to be heard on this
matter?
(No response.)

FIRE CHIEF GERALD REARDON: Seeing none.

EXECUTIVE DIRECTOR ELIZABETH LINT:

Oh ...

FIRE CHIEF GERALD REARDON: Paperwork in
order?

EXECUTIVE DIRECTOR ELIZABETH LINT: Just
the accessibility issue that Mr. Muehe brought up.

Has he been in touch with --

ATTORNEY JAMES RAFFERTY: Mr. Darwin
reported to me he received a phone call from Mr. Muehe.

And my understanding is that Mr. Darwin's belief is that the current premises are rather confined in terms of the ability to construct a ramp, but $I$ believe he told Mr. Muehe it is his intention, when the premises expands, there would be ample opportunity to improve the access.

This would continue to have the same
access that the current $C V$ license has.

But he doesn't believe there's a -- he would be happy to meet with Mr. Muehe and discuss any suggestions he might have.

FIRE CHIEF GERALD REARDON: So right now he's indicating, Mr. Muehe, it is a 5-and-a-half-inch single step --

ATTORNEY JAMES RAFFERTY: I haven't seen

small-type ramp and it is not a large

    I know Mr. Muehe has been involved and

at the Cambridge Street and Mount Auburn Street,
when there was an expanding there as well.
It is not for lack of willingness, I
would say, on the applicant's part.
We would -- of course the building code
ultimately determines it so we would work with
Mr. Braman in the Building Department around
issues of access.
FIRE CHIEF GERALD REARDON: Anything
further?
POLICE COMMISSIONER ROBERT HAAS: No.

motion to approve the application for Darwin's at 313 Massachusetts Avenue for 19 seats for the hours specified. The applicant is applying for an entertainment license with audio machine which may play at or below conversation level.

which may play music below conversation level and
live musical instruments and/or vocalists without
amplification.

FIRE CHIEF GERALD REARDON: Same thing,
for the record, can you state and spell your name and your position tonight?

IAN GOLDSTEIN: My name is Ian Goldstein.

I-A-N G-O-L-D-S-T-E-I-N.

I'm general manager of Potbelly Sandwich

Shop.

CHRIS MARSZALEK: I'm Chris Marszalek
$M-A-R-S-Z-A-L-E-K$.

And I'm the district manager from

Potbelly Sandwich Shop.

FIRE CHIEF GERALD REARDON: One of you
could probably give us your business plan.

First of all, whose space is this? Is it -- at 820 .

CHRIS MARSZALEK: It used to be Uno's.

IAN GOLDSTEIN: We took the bottom floor.

CHRIS MARSZALEK: The top floor is --

IAN GOLDSTEIN: The top floor is an Asian restaurant.

CHRIS MARSZALEK: We've finished most of the construction. We would like to get opened next week.

The company has been open well over ten
years. There's almost 300 restaurants throughout the country based out of Chicago.
It started out as an antique shop in
1977. We have five open in the Boston market right now and this would be our sixth. And we're looking forward to get it up and running.

FIRE CHIEF GERALD REARDON: You don't have one in Cambridge already?

IAN GOLDSTEIN: We don't have one in Cambridge, no.

The closest one that to that store would be on One Federal.

FIRE CHIEF GERALD REARDON: You've already started?

CHRIS MARSZALEK: Yes. Construction is just about done.

In fact, we were having a hearing last week or the week before, and it got postponed.

We are pretty much all set and ready to go just waiting for permits and hearings.

FIRE CHIEF GERALD REARDON: Inspections.

CHRIS MARSZALEK: Yeah. I don't have it.

I know the general contractors got inspections scheduled for the end of this week.

IAN GOLDSTEIN: I believe the health

inspector is on vacation this week. And he's
back from in vacation now and we'll have an
inspection next week.
    FIRE CHIEF GERALD REARDON: Did you put
in much a kitchen at this location?
    IAN GOLDSTEIN: We don't cook anything.
It is just reheating and a slicer.
    CHRIS MARSZALEK: No fire or grease or
gas.
    FIRE CHIEF GERALD REARDON: And it is 43
seats inside, and 22 seats seasonal and that's
private property?
    CHRIS MARSZALEK: That's correct, yes.
    IAN GOLDSTEIN: Yes.
    FIRE CHIEF GERALD REARDON: AnY
questions?
    POLICE COMMISSIONER ROBERT HAAS: You
serve any alcohol in your Boston location?
    IAN GOLDSTEIN: No. None of our

locations do.

EXECUTIVE DIRECTOR ELIZABETH LINT: Do
you have the green abutter notifications?

CHRIS MARSZALEK: We turned those in with
the -- to --

EXECUTIVE DIRECTOR ELIZABETH LINT: I
just have the receipts.

CHRIS MARSZALEK: -- to Christopher.

I just turned in the receipts into him.
(Referring to Ian Goldstein): Did you
get any green back in the store yet?

IAN GOLDSTEIN: I believe -- I haven't
received our mail yet.

CHRIS MARSZALEK: There were only five or
six sent out. And $I$ gave him the receipts but I
don't think we got any of the cards back.

Blue does that make sense?

EXECUTIVE DIRECTOR ELIZABETH LINT: Well,
let's see what --

POLICE COMMISSIONER ROBERT HAAS: What is going on with the rest of the space?

IAN GOLDSTEIN: The upper space they are working on, they are going to make an Asian restaurant on the top part, which has nothing to do with us.

FIRE CHIEF GERALD REARDON: There was an up and down?

IAN GOLDSTEIN: Right. There was a
stairwell. It's gone.

FIRE CHIEF GERALD REARDON: Still waiting

    EXECUTIVE DIRECTOR ELIZABETH LINT:
    DISCIPLINARY: United Waste Management, LLC, and
Jet A Way for failing to renew their waste hauler
license.
Since no one is here, what $I$ would
suggest is $I$ will have a staff member make some
phone calls to see if they are no longer
operating in the city.
FIRE CHIEF GERALD REARDON: I'm not sure
about Jet A Way but $I$ don't know about United
Waste Management. I think I have seen them
around but $I$ could be wrong.
So you are going to check to see if (A)
they still exist and (B) if they are operating?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

If they are operating we can issue them a cease and desist.

FIRE CHIEF GERALD REARDON: If they were operating without a license, do you need a vote tonight or a fine?

EXECUTIVE DIRECTOR ELIZABETH LINT: You can't.

FIRE CHIEF GERALD REARDON: Put this down
as a continuation?

POLICE COMMISSIONER ROBERT HAAS: We can vote to authorize, if you do, in fact, find them operating, you can, in fact, issue a cease and desist order.

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

POLICE COMMISSIONER ROBERT HAAS: I make
a motion on that.

FIRE CHIEF GERALD REARDON: I'll second
that.

## All in favor?

POLICE COMMISSIONER ROBERT HAAS: Aye.

FIRE CHIEF GERALD REARDON: Aye.

CHRIS MARSZALEK: Excuse me. Sorry to barge in.

The CV license was okay? But the entertainment license, was that part of it too?

POLICE COMMISSIONER ROBERT HAAS: Yes.

CHRIS MARSZALEK: Thank you very much.

EXECUTIVE DIRECTOR ELIZABETH LINT:

POLICY: The Commissioners will discuss interim livery regulations.

I'm actually calling this emergency
interim regulations.

FIRE CHIEF GERALD REARDON: Can you give us a summary on it? Or do you want to give us a summary on it quickly?

EXECUTIVE DIRECTOR ELIZABETH LINT: We
both can.

I think just at the outset, the immediacy
for this is that we have been receiving many
phone calls both from taxi drivers and the
general public saying there are cars around the
city that look very much like taxicabs and
then low and behold they find out that they are not.

Two in particular that are white vehicles
that say Classic Car Service with the exact logo
of our classic cabs, plus on the back they have

OO and O1, which looks like it would be a
medallion number.

And one of the vehicles has a taxi light
on the roof.

COREY PILZ: Corey Pilz, P-I-L-Z,

Consumer Information Specialist.

Just to give a little bit more to the
process.

The License Commission is in the process of revising our for-hire vehicle regulations, which is currently applicable to the livery and limousine licenses in the City of Cambridge.

The goal of revising the regulations is,

No. 1, to modernize them.

And also to adapt our current regulations
to reflect and address the realities of the
industry, especially considering the innovation
that's occurred in the way that people are now utilizing technology to contract with these livery vehicles.

As we conduct an extensive public input process, we feel it is best to put these two emergency regulations into place to maintain
public peace and public safety.

And just to give you a little bit
background, to start with, the second regulation
that Executive Director Elizabeth Lint touched
upon, this would be a completely new regulation designed to guide the exterior livery vehicles. As the regulation is written, it says "no
license livery vehicle shall bear designs,
markings, or exterior lights that makes said
vehicle resemble a taxicab. No livery shall
place exterior markings that contain the words
taxicab or cab on the vehicle."

Generally, just besides consumer
confusion, there's an issue where someone thinks
they are hailing a taxicab and get into it and the vehicle itself doesn't have a meter and the passenger gets badgered into paying some amount of money which doesn't necessarily have a rate or a fare to it.

FIRE CHIEF GERALD REARDON: Well, there's
also a difference also in licensing for the drivers of course.

FIRE CHIEF GERALD REARDON: For public safety purposes, there's rules and regulations and licensing of cab drivers in the city for purposes of making sure that they work within the guidelines and have safety consideration, as prescribed by the taxi portion of the License Commission, and a livery driver wouldn't be in that same category, so $I$ guess -- I guess, in my opinion, this is false advertising under the pretense that they are a cab versus being a livery.

EXECUTIVE DIRECTOR ELIZABETH LINT: Well,
that's exactly our concern with it because it
looks exactly like our taxicabs.

And since they are not -- they are not
licensed by us, but I am aware that they are
registered in the city, so they have should have applied for livery licenses.

FIRE CHIEF GERALD REARDON: Now, would
this regulation apply to any livery operating in the City of Cambridge whether they are licensed or not?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

They cannot appear to be taxicabs.

It is incredibly misleading to the
general public.

FIRE CHIEF GERALD REARDON: Looking at a
picture of one, it has the same two-tone color
and striping and $I$ don't think the normal person would notice this.

EXECUTIVE DIRECTOR ELIZABETH LINT:

Exactly.

FIRE CHIEF GERALD REARDON: Commissioner?

POLICE COMMISSIONER ROBERT HAAS: No
questions.

COREY PILZ: The second regulation that
we have proposed clarifies how a livery can
contract with a passenger.

```
    Currently the standards we have is a
minimum charge of $40 for all fares/passengers
and also an eight-hour advance notice on all
reservations. And given the current times, this
doesn't seem to be a reasonable standard.
    The regulation that we have proposed is
"no livery vehicle shall solicit passengers for
transportations services on any public way, nor
shall a livery vehicle be parked on any public
way for a time longer than is reasonably
necessary to accept passengers as a result of a
called service.
    No passenger shall be accepted for any
trip in such vehicle without previous engagement
at a fixed charge."
One of the things we do intend to do in
the public input process is to define what a
prearrangement and fixed charge may be given the
way the current livery industry is operating.
```

```
    However, we do think it is important to
continue to draw a reasonable distinction of what
makes a livery vehicle and what makes as taxicab
vehicle. Meaning what is a prearranged
transportation service and what is an on-demand
or hail-type transportation service, which will
be the taxicabs.
                    FIRE CHIEF GERALD REARDON: Although I
wasn't here when this was done, it did come up
years ago and it was an issue, then it was
prearranged for the hotels and motels the night
before, usually the hotel would arrange for a
limousine for someone, and that's where this, I
think, eight-hour commitment came in.
    But it is not feasible probably in this
day and age.
    COREY PILZ: The issue simply is that we
have more people utilizing livery vehicles on a
day-to-day basis.
```

```
    It is no longer just, as you said,
staying at a hotel and getting you a car to go to
the airport or even contracting ahead of time.
    People are taking these back and forth
between meetings and they have become more
accessible to the public with the introduction of
the smart phone applications.
    POLICE COMMISSIONER ROBERT HAAS: It sayS
that they can't park on any public way for any
period of time for the purposes of soliciting
passengers.
    What does that mean in terms of being
parked in the driveway of a hotel?
    COREY PILZ: And that's why we included
```

that.
What we have seen is there are some
livery vehicles, especially at night, that will
just park in Harvard Square outside a couple of
our fine establishments and they crank down the

```
window, as they see a group of people leaving,
and they'll say, Hey, you want a ride? Come on
in, get in and it is more talking the place of
what an taxicab would normally do.
    EXECUTIVE DIRECTOR ELIZABETH LINT: They
are also sitting in the cab stands.
    POLICE COMMISSIONER ROBERT HAAS: And the
taxi drivers are putting up with that?
    EXECUTIVE DIRECTOR ELIZABETH LINT: No.
```

We get complaints constantly.
POLICE COMMISSIONER ROBERT HAAS: So when
you get a call, do you send someone down there
to investigate? Or do you just take the
complaint?
EXECUTIVE DIRECTOR ELIZABETH LINT: What
I have been doing on days when Officer Zeto
(phonetic) is in the office, he'll go down and
check it out.
I have also spoken with Lieutenant Riley

```
and he's put it out to the officers that are on
patrol and in the high traffic areas to make sure
they know they can move them along and ticket
them.
```

    I also spoke with Wayne Amirault to make
    sure the CPOs were moving them along or ticketing
them, instead of ticketing the cabs that's trying
to get on the stand, where they belong, and they
can't get on because there's a livery vehicle
there.
POLICE COMMISSIONER ROBERT HAAS: So when
you do get an active complaint, will you call
911? Or the ECC to dispatch an investigator?
EXECUTIVE DIRECTOR ELIZABETH LINT: I
call 3300.
I would never call 911 to move a livery
vehicle out of a cab stand.
COREY PILZ: Unless it was on fire.
EXECUTIVE DIRECTOR ELIZABETH LINT: Yeah.

Yeah, then $I$ would.

FIRE CHIEF GERALD REARDON: So the
question before us tonight is the two emergency
interim regulations and they would be in place
immediately, today, tonight?

COREY PILZ: That would be the goal.

FIRE CHIEF GERALD REARDON: And these
would be interim emergency in place in that the city's License Commission would have public
information forums to discuss this for a
permanent solution and upgrade of the rules and
regulations regarding livery?

COREY PILZ: The public information
forums are geared towards specific questions that we designed. One of them is prearrangement.

After we have the public information
forums, we intend to draft the regulations and go
through the normal hearing process for
rulemaking.

So these will be put before you again for any modifications that may be appropriate based on public input, industry input.

But I actually think the industry will
welcome at least the first regulation because they have had some confusion with the $\$ 40$ and the eight-hour advance notice because they simply can't do it anymore.

FIRE CHIEF GERALD REARDON: Anyone from
the public wish to be heard on this?
(No response.)

FIRE CHIEF GERALD REARDON: Seeing none.

Anything further, Commissioner?

POLICE COMMISSIONER ROBERT HAAS: NO
further questions.

FIRE CHIEF GERALD REARDON: I'll make the
motion to approve the two emergency regulations as outlined to the License Commission for one, solicitation of passengers prohibited, and the

```
second one exterior of livery vehicles to be
added to the rules and regulations effecting
livery vehicles, and that regulation should be
effective immediately.
```

    POLICE COMMISSIONER ROBERT HAAS:
    Seconded.

FIRE CHIEF GERALD REARDON: All in favor? POLICE COMMISSIONER ROBERT HAAS: Aye. FIRE CHIEF GERALD REARDON: Aye. EXECUTIVE DIRECTOR ELIZABETH LINT: Any other business?

FIRE CHIEF GERALD REARDON: Ratifications or anything?

EXECUTIVE DIRECTOR ELIZABETH LINT: No.

Want me to go find some?

FIRE CHIEF GERALD REARDON: No.

Motion to adjourn.
