Agenda Item

1. ARBORIST UPDATE (provided by Dave Lefcourt)

- Number of trees getting removed this fall is 34
- Approximately 2/3rd are being removed for poor condition, 1/3rd being removed for design development
- Of the street trees, majority were stunted/not thriving (most are Lindens)

Questions/Concerns:

SE: inquired about species list for River Street Project that CPP looked at during the Oct 2021 meeting; Kevin Beuttell said he'd send the list/schedule out to the group via email. It is attached at the end of minutes.

EC: inquired about fate of the 5 large crabapple trees at Carl Baron Plaza; Response was that they are too large to be transplanted, so will be removed; Tree hearing for this project is next Thursday (11/17/22).

- 2. TREE PLANTING UPDATE (by David Lefcourt)
 - 13 trees will be planted by DPW as of 11/9/22
 - 166 trees were planted by Leahey Landscaping (tree plating contractor) as of 11/9/22
 - 429 trees were planned for planting this fall; 389 are right of way trees; 6 back of the sidewalk trees, 34 are park trees
 - warm weather has been good for newly planted trees
 - watering by contractor will terminate 11/9/22 as per contract

3. OTHER DPW UPDATES:

a. Young Tree Training Program is a new program that went out to bid, Barrett Tree Services got the bid, is a 3 year contract.

- b. A second Miyawaki Forest was planted this past weekend (11/5/22) at Green Rose Park (Dickinson Street x Broadway); 900plants were planted, more than 40 species, S.Fairbanks inquired if existing trees were damaged, A.Putnam replied yes, so they were removed before Miyawaki was planted.
- c. Kevin Beutell announced the meeting for Liner Park Design is scheduled for next Wednesday (11/16/22) & will be held virtually. Kevin will share link to CPP via email. Nov 16th meeting will be more comprehensive meeting sharing preliminary design.

M.Booz: Will Citywide Design Guidelines committee have teeth to make action happen? G. Chan responded that is will be more of an advisory committee that creates suggestions for City Council; M.Booz suggests a CPP/DPW member be on the Design Guidelines Committee.

- M. Booz inquired about how Tree Ordinance impacted # trees saved on public property since it
 was instated; A.Putnam will put together tree removal application stats for next meeting
- CPP member inquired if a follow up process was in place for Tree Ordinance Program as comp for removal; Response is yes, DPW checks in at end of each planting season and photos of new trees are required.
- C.Smith inquired when CPP meetings will go in person, possibly January, Sophia will do a poll to gauge preferences.
- C. Smith inquired about status of planning for trees along Memorial Drive, S.Fairbanks answers that it's waiting on new plan and possible change in staff with new Governor
- S.Fairbanks suggests CPP connects with new director at Mt Auburn Cemetery and asks them to present at upcoming CPP meeting
