2. City Updates

Debrief Oct. 25: City Council hearing:

- Power point of presentation was shared in 10/26 email from Mike
- policy order was assigned to look at single use plastics in retail and miniature liquor bottles

• focus on jumping into the zero waste master plan and getting as much community input as possible

Outreach brainstorming for next 3 months:

• Postings on Reddit and Nextdoor - there is a Cambridge MA subgroup on Reedit

• Continue writing articles. The department's article on composting pumpkins was picked up by some news outlets. We had 13 tons of food waste collected this past Monday (after Halloween), usually see 10.5 on Mondays.

• Reach out at upcoming community events. Check library calendars, CFF (Center for Families), public school events....

• Attend Food for Free's School Markets happening monthly at certain Cambridge schools.

• Zoom event, sharing our waste services to bring attention to the recycling center.

Tour of the newly renovated Casella facility is happening on Dec 4, (10 am-12:30) for RAC and city staff. There are only a limited number of spaces. Let Mike know if you want to go.

3. Discussion with Cambria Ung, Stormwater Program Manager. She also deals with yard waste.

• focus is on monitoring quality of water that flows through stormwater pipes into Mystic River through Alewife Brook, and the Charles River for the southern portion of the city.

• About half the city has separate waste and storm water pipes and half has single set of pipes for waste and storm water.

• Homeowners are technically responsible for clearing snow, ice and leaves as far out as the middle of the street in front of their homes. City supports with street cleaning and plowing.

• Street cleaning debris goes to a landfill. Much better if leaves are raked up and placed in yard waste.

• Key pollutants city is focusing on are phosphorus, oil, grease and sediment

• Green infrastructure work is done in conjunction with reconstruction road/sidewalk work.

• Tree Box Filters – looks like a tree in a little square planted in the sidewalk. Under the sidewalk is extra space, soil, and rocks, to allow storm water to pool

• Porous pavements

• Rain gardens – looks like a landscaped area – Cambria will share locations of rain gardens in Cambridge. One is by DPW on Hampshire St. We will investigate the possibility of a tour of rain gardens.

Working with residents on improving water quality

- Asking residents to collect leaves before they get in storm pipes
- Put articles in DPW newsletter about storm drain care

• Include storm drain care in zero waste master plan

• Get message out to use See Click Fix if you notice something other than rainwater around storm drain.

4. Continue conversation on goals of Zero Waste Master Plan

• Consultant has been selected. They will be brought on by the end of this month. Mike will share who they are once they sign a contract.

- A lot has happened since the initial report was written 6 years ago
- The importance on focusing on a succinct list of goals

• Possible hybrid pay as you throw plan: you would buy bags for trash beyond what fits into your trash cans. Some complications could be that bags attract rats, there is an equity issue around affording bags, people might choose to dump garbage elsewhere.
