## What's New

Motorola Portables - In mid August, **Tech Services** started issuing companies new XTS 5000 Motorola portables to replace the older HT 1000's that are no longer serviceable by Motorola. The new portable radios were bought using a federal grant through the Urban Area Security Initiative to increase our inter-operability with other public safety agencies in the Boston area. Division 1, Division 2 and Headquarters companies were issued the first radios on a trial basis. The rest of the companies received their new radios shortly afterward.

Labor Day/ Local 30 MDA Fill-the-Boot report – Unfortunately the Local 30 Fill-the-Boot campaign was not active this year and the Cambridge Fire Department was not represented - between losing the MDA representative and some family difficulties of Chairperson **FF Howie Smith** (Ladder 1, Group 1). They hope to be out in full force next year!

Actor **Randolph Mantooth** (also known as FF/Paramedic John Gage from the 1970's television show Emergency) stopped by fire headquarters on Thursday October 29, 2010 and said hello to members of Group 1 – many of whom had no idea who he was.

The department placed a 2010 Ford Van into service as the new Squad 2 replacing the 2005 model.

Twelve new recruits will be joining the department in November 2010 and will start the Mass Fire Academy Recruit program in January 2011.

## All Companies Working

**August 9, 2010 Box 789** was struck for a fire in a closet at **2 Washburn Terrace**. Engine 4 arrived and stretched a line but used a water can to extinguish a small fire in the closet. The fire was set by a 6 year old girl that lived in the apartment. Group 1 on duty.

**August 23, 2010 – Mutual Aid to Somerville Box 219** for a 3 alarm fire at 34 Houghton Street. The fire was in an approx. 70 x 30 two and a half story attached row frame. Cambridge Engine 5 was first due and found heavy fire on the second floor, extended to the cockloft in the middle of the row. Group 4 on duty

**August 23, 2010 – W/F, Box 742, 2161 Mass Ave** – Engine 4 and Ladder 4 dispatched to a central station fire alarm. Engine 4 requested Box on discovering smoke on floor 1. Engines 8 and 1, Ladder 1, Division 2, Squad 4, Squad 2 filled out the assignment. The main body of fire was located in the basement and was extinguished. Working fire truck was Ladder 2 and used as RIT and Engine 9 covered Engine 8. Group 4 on duty. A/ Deputy Fire Chief Blake was in command.

**August 27<sup>th</sup>, 2010 – Box 68, 3 alarms 68 Hubbard Ave** - At 18:21 Cambridge fire alarm struck box 68 for a possible building fire with smoke from the roof of 48 Hubbard Ave. The 1st alarm assignment was Engines - 4,8,1 Ladders 4, 1 Rescue Co. 1, Squad 4 and Division 2. First arriving Squad 4 reported smoke showing. Acting DFC M. Cunningham (Div 2) reported two 2.5 story wood frames with heavy exterior fire. He quickly ordered a 2nd and 3rd alarm. The 2nd alarm brought (WF) E-9 L-2 Sq. 2 Div 1 (2ND) E-5, E-6 L-3 (3RD) E-3, E-2 Somerville E-3 and Somerville Tower 1. Two Additional ladder companies were requested bringing Boston L-15 and Waltham L-2. The fire was quickly cut off by the first arriving engine companies using multiple 2.5 inch lines. Group 2 on duty. A/Deputy Fire Chief Cunningham was in command

**November 2, 2010 – Box 495, W/F, 12 Adams Terrace** – fire on third floor of a three story wood-frame structure. Adams Terrace is a dead end of Roberts Road. First due companies were Engine 5, Engine 1, Engine 6, Ladder 1, Ladder 3, Squad 4, Rescue 1, Division 1, directed by Deputy Chief Turner. The W/F response included Engine 8, Ladder 2, Squad 2 and Division 2.

### **Through the Lantern Lens**



**Through the Lantern Lens**

On the city line between Cambridge and Somerville (at the intersection of South Street and Willow Street) is a firefighter memorial dedicated to two Somerville firefighters killed in the line of duty at a fire back in 1974. Although, they were not Cambridge firefighters, their story merits some interest and has local ties.

On June 10, 1974 at 8:20 pm, Box 21 was sounded for a fire in the Arrow Paper warehouse on Harding Street in Somerville. Firefighters Joseph Reilly and Robert Brickley, both members of Engine Company 2, died in the line of duty when the rear (north side) wall collapsed. Engine Company 3 (from Union Square) the assigned first due company, was covering Cambridge Engine 5 at the time because Cambridge had a fire going on already. (Editor note: had they not been at a fire in their own city, Cambridge Engine 5 would have responded to Somerville on a line box.)

At the time of their deaths, Firefighter Reilly was one of the most senior members of the department and Firefighter Brickley was one of the youngest (with just 4 months on the job).


A memorial to the two fallen firefighters was dedicated on June 6, 1999, marking the Twenty-Fifth Anniversary of the Supreme Sacrifice made by Firefighters Joseph Reilly and Robert Brickley. Members are encouraged to visit the memorial and remember the sacrifices brother and sister firefighters from all departments make.

Another interesting note about Firefighter Reilly is that there is also a plaque (with photo) aboard the decommissioned battleship the USS Massachusetts which is now moored at Battleship Cove in Fall River, Massachusetts (as a museum) honoring Joseph Reilly for his service to the United States Navy aboard the USS Massachusetts.

Dear Chief, I wanted to write this letter to thank members of your Department for their assistance on July 10. We had what was almost a critical incident in the McGrath Highway tunnel. A woman was rescued from the top of her car. WE still had four cars submerged in the tunnel. I called the State Police and Cambridge dive teams to the scene to conduct a search. Deputy Chief Paul Sheehan and FF Ed Oliver responded with members of the dive team. FF Paul Morrison suited up with a Sergeant from the State Police and conducted a search of the submerged vehicles. Thankfully no victims were found. I'm sorry but I do not know the other members of the dive team who responded.

I was impressed by the professionalism of all your members who responded and I am personally thankful for their service.

*The following letter was written on July 21, 2010*

Dear Chief Reardon,

July 6, 2010 Saugus Fire Alarm received a call reporting a missing boater in the vicinity of the public boat launch on the Saugus River. The man's boat was found adrift in the vicinity but his pickup truck and trailer was missing from the parking lot. The Cambridge Fire Department Dive Team was called to the scene. Their response was very quick. Deputy Chief Mahoney conferred with the Saugus Incident Commander and the dive team went to work. A search pattern was established and the victim was located, secured and removed from the water.

It should be noted that the Saugus River is well known for its swift tidal currents and it's almost impossible visibility. The skill and professionalism of the Cambridge Fire Department Dive Team was remarkable. Their dogged efforts in this difficult waterway gave a family closure on what could have been a very long missing person search. On behalf of the deceased's family, the citizens of Saugus and the Saugus Fire Department, please convey my sincere thanks to this dedicated team of professionals.

Dear Sirs,

We recently had to call on the Cambridge Fire dive team to help find a motorist who lost control of her vehicle and plummeted into the Pines River on the Revere, Saugus line of Route 107. The team made a remarkably fast response and was in the water conducting a search in no time. The river is very swift and dangerous in this area as it funnels through a narrow bridge. It is also a dumping spot for tossed shopping carts, old bikes, truck and car parts. In short it is a very hazardous environment and affords near zero visibility. The professionalism and team effort of the entire Cambridge Dive Team under very dangerous conditions is a tribute to the training and dedication of these dedicated firefighters. On behalf of the citizens of Saugus, The Saugus Fire Department and the family of the deceased motorist, please accept my sincere thanks for mitigating a very difficult and dangerous recovery.

## **America's Heroes**

### **Medal of Honor – Carl L. Sitter - Korean War**

Rank: Captain United States Marine Corps, Company G, 2nd Battalion, 1<sup>st</sup> Marines, 1<sup>st</sup> Marine Division (Rein). Place and Date: Hagaru-ri, Korea, 29 and 30 November 1950

Citation reads: For conspicuous gallantry and intrepidity at the risk of his life and above and beyond the call of duty as commanding officer of Company G, in action against enemy aggressor forces.

Ordered to break through enemy infested territory to reinforce his battalion the morning of 29 November, Capt. Sitter continuously exposed himself to enemy fire as he led his company forward and, despite 25 percent casualties suffered in the furious action, succeeded in driving through his objective.

Assuming the responsibility of attempting to seize and occupy a strategic area occupied by a hostile force of regiment strength deeply entrenched on a snow-covered hill commanding the entire valley southeast of town, as well as the line of march of friendly troops withdrawing to the south, he reorganized his depleted units the following morning and boldly led them up the

steep, frozen hillside under blistering fire, encouraging and redeploying his troops as casualties occurred and directing forward platoons and they continued to drive to the top of the ridge.

During the night when a vastly outnumbering enemy launched a sudden, vicious counterattack, setting the hill ablaze with mortar, machinegun and automatic-weapons fire and taking a heavy toll in troops, Capt. Sitter visited each foxhole and gun position, coolly deploying and integrating reinforcing units consisting of combat team and instilling in every man the will and determination to hold his position at all costs.

With the enemy penetrating his lines in repeated counterattacks, which often required hand-to-hand combat, and, on one occasion infiltrating to the command post with hand grenades, he fought gallantly with his men in repulsing and killing fanatic attackers in each encounter.

Painfully wounded in the face, arms, and chest by bursting grenades, Capt. Sitter staunchly refused to be evacuated and continued to fight on until a successful defense of the area was assured with the loss to the enemy of more than 50 percent dead, wounded and captured. His valiant leadership, superb tactics, and great personal valor throughout 36 hours of bitter combat reflect the highest credit upon Capt. Sitter and the U.S. Naval Service.

***Editors note: This year marks the 60<sup>th</sup> anniversary of the Korean War that started on June 25, 1950.***
