#### What's New

**Squad 4** – The new Squad was placed into service on Sunday, 8 April 2018. This 21st century paramedic, firefighting, tech-rescue, and "all-hazards" apparatus is a 2017 Ford F450 four-wheel-drive, 4-door cab, diesel, body built by Fire One of Mendon.

Squad 2 already received their similar unit in February 2018. These will replace the vans.

**New Apparatus** – The new Ladder 1 is being built at Pierce and is expected in early August. It will be a 2018 Pierce Ascendant. The current Ladder 1 will be reassigned to Ladder 4. Also the City Council appropriated \$575,000 for a new pumper.



**Bike Team** – the CFD Bike Team has been in service for several months now and has been used at several events recently. See the write-up further in the newsletter where FF Marrache and FF Burke were instrumental in making quick access to an ALS patient at the MIT commencement.

**Firehouse Renovations** – The City supported a policy put forth by Mayor Marc McGovern and co-sponsored by councilors Mallon & Toomey to improve the living conditions of our eight firehouses. The Council is committed to improving our living conditions. Local 30 thanks the Cambridge City Council and we look forward to working with the City Council and City Manager addressing the long term goal of renovating all eight firehouse. Preliminary estimates show \$2,000,000 earmarked for work on some of the stations that need rehabbing. More to follow!

#### All Companies Working

March 14, 2018 – 1 Alarm Fire, 80 Ames Street – fire in wood enclosure on high rise under construction.

March 18, 2018 – 1 Alarm, Box 7511, Alewife Brook MBTA station – MBTA personnel called for heavy smoke in the station. Trash fire on the tracks closer to Davis Square, Somerville FD worked on their end to extinguish the fire.

March 18, 2018 – 1 Alarm Fire, Box 52, 17 Hilliard Street – caller reported burning smell and warm wall behind a clothes dryer. Companies found clothes in a dryer caught fire.

March 19, 2018 – 1 Alarm Fire, Box 45, Peabody Terrace/10 Akron Street – Companies arrived with smoke showing. Upon further investigation, found leaves on fire in a grate on ground level next to building.

March 21, 2018 – 1 Alarm Fire, 928 Mass Ave, Pammy's Restaurant, Box 436 – ECC received calls for a building fire. Ladder 3 arrived, fire on the roof from rooftop unit. Ladders opened, up, power was cut and fire extinguished.

March 21, 2018 – 1 Alarm Fire, Box 7762, 130 CambridgePark Drive – fire alarm sounding, on arrival companies found water flow as a result of a sprinkler head on 5<sup>th</sup> floor, Small fire in the apartment, one occupant with burns refused treatment

March 24, 2018 – Water Rescue, Charles River – witnesses saw a person jump from the Mass. Ave Bridge. Companies worked with Mass. State Police and Boston. CFD Dive team recovered the victim who was removed at the dock.

March 29, 2018 – Mutual Aid, W/F Somerville, Box 33, 17 Dartmouth Street – Engine 5 and Ladder 1 responded to Somerville and covered during their W/F

- **April 1, 2018 Mutual Aid, W/F Somerville, 47 Fremont Street** Engine 5 and Ladder 1 covered in Somerville during their W/F.
- **April 2, 2018 1 Alarm Fire, 55 Essex Street, Box 4241** tenant reported a fire in their apartment on the 4<sup>th</sup> floor of an 8 story apartment building. Building was evacuated, searches conducted while fire knocked down.
- **April 2, 2018 Water Rescue, Museum of Science –** a motor boat overturned and operator had to be pulled from the water at the rear of the Museum of Science
- **April 8, 2018 1 Alarm Fire, 76 Vassar Street, Box 273** alarm activation at the location. Companies found smoke in the building and filled the assignment. Found a small fire in the middle of a lab. Not a dangerous atmosphere.
- **April 13, 2018 Mutual Aid, Somerville, 34 Bay State Ave** Rescue 1, HazMat 1, Squad 4, and Division 1 mutual aid to Somerville for a hazardous materials condition
- April 20, 2018 Working Fire, Box 29, 165 Tremont Street rear porch fire required lines to be stretched by Engine 5 and Engine 2. A box was struck by Somerville Fire Alarm also.
- April 29, 2018 Gas Leak, 555 Tech Square, Draper Labs A tent spike pierced a gas line near the building. Building evacuated, air levels checked until Eversource could turn off the leak
- May 2, 2018 2<sup>nd</sup> Alarm, 1815 Mass Ave, Lesley University fire in food court. Engine 4 stretched a line and Ladder 4 forced entry through roll up security gate. Sprinklers were working, but one closest to fire failed.
- May 2, 2018 1 Alarm, 158 Prospect Street, Box 285 Koreana Restaurant had a fire in an air handling unit on roof. On arrival, Engine 2 found employees on roof trying to extinguish fire.
- May 2, 2018 Mutual Aid, Somerville, Box 252, 269 Washington Street, 2<sup>nd</sup> Alarm Engine 5, Ladder 1, Engine 4, Squad 2 and Division 1 responded to their fire.
- May 2, 2018 Mutual Aid, Chelsea, 6<sup>th</sup> Alarm 10 John Street Engine 5, Engine 4, Squad 2 and Division 1 responded to a fire in three 3 deckers.
- May 3, 2018 Mutual Aid, Belmont Ladder 1 covered at Belmont Headquarters during an extended incident.
- May 3, 2018 1 Alarm Fire, 253 Elm Street, Box 291 a shed fire in the backyard was ignited by a nearby gas grill. Owner attempted to extinguish the fire with a garden hose.
- May 4, 2018 Mutual Aid, Arlington, 2<sup>nd</sup> alarm, 434 Mass Ave Engine 4, Squad 4 and Division 1 responded to the fire.
- May 5, 2018 Mutual Aid, Somerville, Box 751, 3<sup>rd</sup> Alarm, 11 Teele Ave Engine 4, Engine 5, Ladder 1 and Squad 4 responded to a fire in a 2-1/2 story wood-frame residence
- May 6, 2018 Motor Vehicle Accident, Alewife Brook Parkway @ Route 2 single car accident with driver in cardiac arrest

- May 8, 2018 1 Alarm Fire, 1 Gerrys Landing Road, Box 563 an outside fire extended to the building at the Buckingham, Brown and Nichols Boathouse.
- May 12, 2018 Mutual Aid, Boston, 1210 VFW Parkway, Box 2883 Three Cambridge engines covered in Boston during their 6 alarm fire. Engine 2 covered Engine 33, Engine 5 covered Engine 10 and Engine 9 covered Engine 7. At the time of this fire, Boston also struck Box 1741 for 2 Alarms on Groom Street for a multi-story brick apartment with people in windows. Both boxes were in Division 2.
- May 15, 2018 Haz Mat, 21 Ames Street Leaking CO2 cylinders on 12 floor of MIT building. Companies entered with PPE and stopped leak. Gas was not sufficient to displace oxygen levels.
- May 18, 2018 1 Alarm Fire, 799 Main Street, Box 275 fire in a rooftop HVAC unit on the roof of Bertucci's
- **June 1, 2018 Medical/Haz Mat, 35 Quincy Street** a worker was injured during asbestos abatement. Members had to enter the building wearing PPE and respiratory protection.
- June 2, 2018 1 Alarm Fire, Box 7111, 1899 Mass. Ave, Porter Square MBTA station Fire on the tracks outside the outbound platform. 125-150 passengers had to be evacuated from the station.
- **June 6, 2018 W/F, 11 Russell Street, Box 72** Engine 4, Squad 4 arrived and investigated odor of smoke in rear of building. Found fire in interior partition on 2<sup>nd</sup> floor. A Somerville FF (responding on the line box), was injured and suffered a leg injury.
- **June 8, 2018 Water Rescue, Charles River at River Street –** overturned boat in the Charles River. Local rowing outfit removed the party from the water. Boston and Cambridge responded.
- **June 10, 2018 Water Rescue Mass. Ave at Memorial Drive** Engine 2 and Ladder 3 removed a victim out of the water and treated for hypothermia.
- **June 10, 2018 Medical Assist, Washington Elms** a 9 year old child was bit in the face by a dog
- **June 10, 2018 Car Fire, Box 195, Gore Street** @ **Rufo Road** Call for a car fire next to the building. Division 1 found a car on fire in the parking lot, not next to building. Companies engaged in extinguishment and response downgraded.
- **June 11, 2018 Mutual Aid, Belmont, 655 Trapelo Road, Box 4655** Ladder 1 covered during their fire in an apartment building
- **June 11, 2018 Car Fires, Brattle St. at Fresh Pond Pkwy** 2 cars on fire, Engines 9 and 8, Ladder 4, and Division 1 responded. (group 3)
- **June 12, 2018 Mutual Aid, Somerville, W/F, Box 72, 102 Conwell Ave** fire on rear porches, Engine 4 covered Somerville Engine 2 and Ladder 1 covered Somerville Ladder 3
- **June 14, 2018 Motor Vehicle Collision, Mass. Ave @ Vassar Street** car struck the memorial to MIT Police Officer Sean Collier doing significant damage.






#### July 4th

With July 4<sup>th</sup> right around the corner, we thought it was important to share some display tips for our Nation's flag. We see improper displays more and more frequently which show a disrespect for "the colors." (Non-intentional, but a disrespect nonetheless.) Here are some of the more frequent mistakes:





#### **Uniform patches:**

The regulation states that when authorized for application to the proper uniform the American flag patch is to be worn, right or left shoulder, so that "the star field faces forward, or to the flag's own right. When worn in this manner, the flag is facing to the observer's right, and gives the effect of the flag flying in the breeze as the wearer moves forward. The appropriate replica for the right shoulder sleeve is identified as the 'reverse side flag'."



"It's something my family's been a part of for years and years and I'm excited to finally become part of something that they've been doing," said Smith.

Smith says he's always been inspired by the firemen in his family and growing up he was sure he wanted to be a hero, too.

"There was never any doubt that he wanted to be a fireman, wearing the outfits, stealing my clothes," said Smith's father, Howie.

While his family knew all along Smith was destined to carry on his family's legacy, the workplace environment has changed as the risks he'll face are much more different than those of past generations.

"Now, let's face it, with drugs and other stuff it's a whole different world," said Smith. "We have terrorism and stuff that I never considered when I joined the job with the fire department. We have bulletproof vest on the fire apparatus now, I never imagined that 10 years ago."

Nevertheless, the patriarchs of the Smith family couldn't be prouder, not just because of his drive to serve his community but also the work he's put into getting to where he wants to be.

Smith was one of just 20 candidates accepted to a residency program while he gets his fire science degree from Southern Maine Community College.

Throughout his college career, Smith will be working and living in a firehouse in Cumberland, Maine, protecting lives while he earns his diploma.

"I'm just very proud, I've watched him grow up its always been something in the back of his mind he's always said he wanted to be and now he's pursuing that," said his grandfather. "I just wish him the best of luck."

For Smith, it's a dream come true to be able to carry on the family tradition.

"They're like mentors to me, they're my idols, I always grew up visiting them at the firehouse, as long as I can remember. I was that little kid who wanted to be like dad and grandpa," said Smith.

The program Smith is enrolled in will complete his entry-level training. Then, he will go on to learn about hazardous materials, drones and new technology used in firefighting.

#### **From the Archives**

Anyone who has ever been on the third floor of Headquarters at 491 Broadway has seen the mural on the wall of what is now the fitness area. This mural was discussed in a previous Feederline issue - Issue 79 (in 2016) as follows:

There is a large mural on the wall in the current fitness room on the 3rd floor at fire headquarters. It was painted by Cambridge FF Ed Bradshaw. FF Bradshaw also did gold leaf and lettering work.

According to **Deputy Chief Ralph Chapman; Retired**: "Bradshaw was on LHD (light house duty) and it was around 1934 shortly after Headquarters was opened. It was in this era that Seagrave Pump's 5 and 8 were delivered. Shortly thereafter Ladder 4 - tractor with 85' wooden aerial hydraulically raised was delivered by Pirsch."

Journal entries from the Rescue Company on Tuesday March 7, 1939 read "Pvt Bradshaw detailed to paint shop".

Dear Chief Mahoney,

On behalf of City of Chelsea and the members of the Chelsea Fire Department, I thank you for the assistance provided at the 6 alarm fire on John Street on the afternoon of May 2, 2018.

All metro area companies that responded on mutual aid worked extremely well together in containing this fast moving fire. The end result was the total loss of two three story wood frame dwellings, with radiant heat damage to several others. However, the collective effort of all of our members under extreme conditions prevented what could have easily been a much worse outcome.



## Safety - Building Construction

We all may be familiar with brick veneer in regards to building construction – a faux finish that looks much like real bricks that can confuse us during size-up. Recently, someone noticed this finish at Harvard University building in a mechanical room.

The first photo looks much like concrete block construction but is actually a veneer. You can make out the thin veneer in the 2<sup>nd</sup> photo.

There is a slim chance that a concrete wall would need to be breached, but if it did, there is a very thick slab of poured concrete on the other side that would prevent any breaching. This was a new one on us and just worth the share!







