Procedure to Apply for a Garage, Flammables or Garage with Flammables License

The following must be submitted in order to be scheduled for a hearing:

 Completed Garage application signed by the Fire Chief. Please call the Division of Fire Prevention: (617) 349-4918. On this application you should include only what you are applying for with this application.

If you are applying to **amend** a license, please <u>do not</u> include on the application that for which you are already licensed. However, you must include a copy of your current year license.

- 2. Floor plan*, **each page** must be stamped approved by the Fire Department, on 8 ½" X 11" size paper *only*, showing:
 - Street address, nearest cross street and abutting properties;
 - Show installation date, size, and location of present tanks, if any;
 - Indicate tanks to be removed, if any, and the capacity of these tanks;
 - Indicate proposed new tanks and designate their capacity.
 - Indicate number of vehicles to be kept on the premises.
 - Indicate amount and location of all inflammables to be licensed.

*Please contact the Fire Department, in advance at (617) 349-4918, to determine their requirements for this plan.

- 3. Zoning approval from the Zoning division of Inspectional Services (617) 349-6100, on the Licensed Premises Inspection Approvals form.
- 4. Traffic, Parking and Transportation approval (617) 349-4700 on the Interdepartmental Parking Facility Registration form. This is required only when a garage is involved.
- 5. Stamped Articles of Organization, if a Corporation; LLC Agreement if a Limited Liability Company; Partnership Agreement if a Partnership.
- 6. A Business Certificate or D/B/A Certificate from the City Clerk's Office, first floor of City Hall (617) 349-4260.

8. Copies of all applicable permits issued by the Cambridge Fire Department.

9. Completed Garage and Gasoline Coversheet.

Once **ALL** of the above is submitted, you will be scheduled for the next available hearing. Hearings are usually held on Tuesday evening starting at six o'clock. We will send you written notification of the hearing date. We will also place an advertisement in The Cambridge Chronicle, which is published on Thursday.

10. Once the ad is published, you must notify abutters. Contact the City Assessor's Office at (617)349-4343 for the list of abutters. You will copy the legal ad from the paper and mail it within three days of publication to the abutters by certified mail, return receipt requested. You will then sign the affidavit and have it notarized by a notary public. Attach the white receipts to this form and submit to our office prior to the hearing. The green cards may be turned in at the hearing.

The following may be submitted after you apply but must be received in our office *BEFORE* the hearing:

11. A signed lease or letter of intent from the landlord.

Please note that the Fire Department will automatically do a premise inspection before the hearing.

If you are approved for the license, the following must be completed *BEFORE* you are allowed to operate:

- 1. Approval from the building division of Inspectional Services on the Licensed Premises Inspection Approvals form (or electronic approval).
- 2. A check, made payable to the City of Cambridge, for the license fee. (The license fee is calculated on a sliding scale).

License Commission approvals are only valid for six months from the decision date and you **MAY NOT** operate until we issue the license to you.
