<u>APPLICATION FOR SPECIAL NOISE VARIANCE</u> (Cambridge Municipal Code Chapter 8.16.090)

Special Variances may be granted if the applicant shows that to bring the source of noise into compliance would constitute an unreasonable hardship on the applicant, community or other persons. Special variances are not granted to accommodate an applicant's work schedule. A public hearing on an application may be held. To obtain a special variance, you must at least **fourteen (14) days prior to the requested scheduled activity**: (1) send notice to abutters (those on adjoining property) detailing the work to be performed during the proposed date(s) and time(s) of the variance (consider providing them a copy of your application); (2) complete the following application with an Affidavit of Notice to Abutters; (3) attach a site map; and (4) submit the application, affidavit and non-refundable \$75.00 application fee to the License Commission and \$100.00 permit fee after approval.
