#### 1. Introduction of new Board members

### 2. Review/acceptance of April 8, 2013 meeting

President Cobham requested a suspension of approval of previous month's meeting. All members present are newly appointed and not able to vote on approval. Review/acceptance will be requested at June 2013 meeting.

### 3. Reports

#### **COA Executive Director**

- Susan welcomed Emma back from her medical leave!
- An offer and acceptance has been made to candidate to fill position of Director of Client Services. Formal announcement cannot be made until final approval by City Manager.
- There are currently four staff people attending a Mental Health First Aid Workshop; Vincent McCarthy, Geoffrey Kotowski, Lisa Castagna and Julie King. Today is the last of a 4 part series.
- Susan presented on the budget. The COA city budget is \$1,343,760 for FY 14. The breakdown is as follows:

LEADERSHIP \$106,135

SUPPORT SERVICES \$436,710

N. CAMBRIDGE SENIOR CENTER \$125,945

SENIOR CENTER MEALS \$267,125

SENIOR CENTER ACTIVITIES \$43,910 CITYWIDE SENIOR CENTER \$363,935

- COA also receives Formula Grant from Executive Office of Elder Affairs (EOEA) \$101,710. This grant funds SCM Transportation contract; Substance Abuse contract; weekend coordinator; center office aide/receptionist; meals assistant; instructors and other smaller operating expenses.
- The only other grant COA receives is from Project Bread \$7,225 for support towards the pantry.

- The Formula Grant is based upon 2010 census of current individuals age 60 living in Cambridge, paid at \$7 per elder. Current census: 14,530.
- Mass Councils on Aging are advocating for increase of \$8/elder. There has not been an increase since 2009.

### **Citywide Senior Center**

- Emma reported that this was her first day back following her medical leave. She is very glad to be back!
- Emma reported on the efforts of Geoff Kotowski and Lisa Castagna regarding the roof deck garden. Geoff and Lisa have been busy building raised flower beds and planting herbs. These herbs will be distributed in the pantry.
- Emma reminded everyone that the Mayor's Luncheon at MIT is scheduled for Wednesday, 5/15.
- Also starting today, Managing Difficult Emotions. This program will be led by Cambridge Health Alliance staff and it will be a 6-week program.
