Copies of these materials may be made, unless restricted by federal copyright law and any collection-specific stipulations, for a charge of .50 cents per page that enables the archives to offer this service. Fees are payable in advance of processing order. In compliance with the copyright law, the Cambridge Room limits the number of copies of each item to one. The Cambridge Room reserves the right to restrict the use or reproduction of rare, valuable, or fragile items.

### Warning Concerning Copyright Restriction

The copyright law of the United States, Title 17, U.S. Code, governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of the specified conditions is that the photocopy or reproduction of copyrighted material is not to be "used for any purpose other than private study, scholarship, or research" (17 U.S.C. § 108).
