WHEREAS: If 5.8 acres of land were to be reconveyed to Cambridge Redevelopment Authority, based on present zoning as many as 144 to 288 dwelling units and a full size soccer field could be developed; and

WHEREAS: It is proposed that a minimum of 30% of the housing units be developed for low and moderate income families and individuals of which 25% would be for low-income families; and

WHEREAS: Residential development is compatible with Kendall Square development and will contribute to the achievement of a mixed-use district; and

WHEREAS: The reconveyance of this under-utilized land would not negatively impact the federal jobs or the private sector jobs now at the Volpe Center; and

WHEREAS: 8.5 acres of land would remain in the Federal ownership allowing development of additional building space and which would permit NTSC to expand its present facilities, and continue the operation of a national center for new transportation technology and research; and

WHEREAS: In addition to the federal land, NSTAR Services Company (ComGas) is the owner of a 3.9 acre tract of land located on Parcel 1, which is under-utilized as well; and

WHEREAS: If this parcel were to be acquired by the Authority by negotiated sale, based on present zoning, 285 to 570 additional housing units could be developed; now therefore be it
