BOARD OF ELECTION COMMISSIONERS MEETING

Minutes of meeting April 29, 2015

The meeting of the Cambridge Election Commission was called to order at 5:30PM at the Election Commission Office, 51 Inman St. Present were Commissioners Ethridge King, Larry Ward, Polyxane Cobb, Peter Sheinfeld, and Assistant Director Lesley Waxman.

A motion to accept the minutes of the April 1 meeting was made by Commissioner Cobb, seconded by Commissioner King and accepted by the board with a 4-0 vote.

There was no Executive Director's report.

Assistant Director Waxman reminded the board of the upcoming budget hearings on Thursday, May . She directed the board to be at the Commission office at 9:00 AM to await the possibility of reporting to the hearings for review of the department budget.

Commissioner Cobb reported that 58 Rindge Av. was an invalid address.

Commissioner King reported that the Executive Director and all 4 commissioners had attended the City Council hearing on immigrant suffrage at their April 13th meeting.


