**Great News! No Water Rate Increase for the 4<sup>th</sup> Consecutive Year**

May 5, 2014

Dear Water/Sewer Customer:

The City administration and City Council continue to recognize the importance of minimizing increases in water and sewer rates. Therefore, I am pleased to announce, the approved FY15 0% increase in the water consumption block rate and a 5.2% increase in the sewer use block rate, resulting in a 3.7% combined rate increase for the period beginning April 1, 2014. This is the fourth consecutive year that the City has been able to produce a 0% increase in the water rate. This accomplishment is due to our planning process which includes conservatively estimating our water and sewer revenues and controlling expenditure growth, including debt issuance. The increase in the sewer rate is primarily due to increases in the pay-as-you-go capital budget, MWRA assessment, debt service account, and the sewer component of the Public Works Budget. Debt service on sewer bonds and the MWRA assessment account for 88.1% of the total Sewer Budget.

The following block rates will commence with the water/sewer usage as of April 1, 2014, and you will see the changes in bills issued as of July 1, 2014.

All rates are per CcF. CcF is an abbreviation of 100 cubic feet. One CcF is approximately 750 gallons.

### Senior Discount Program

The City offers a 15% discount, not to exceed \$90, to residents 65 years of age or older who own and occupy their one, two or three family homes. *An application form is on the reverse side of this notice.* Any resident who was granted a Clause 41C elderly exemption on FY2014 real estate taxes will receive a 30% discount, not to exceed \$180 per year. The City automatically grants this discount where applicable.

## **SENIOR DISCOUNT WATER/SEWER PROGRAM**

Because of the impact the water and sewer rate increases may have on senior citizens, the City offers a Senior Discount Water/Sewer Program. All residents 65 years of age or older who own and occupy their one, two or three family home are eligible for a 15% discount on water/sewer charges, not to exceed \$90 per year. To qualify, you must be 65 years of age or older on July 1, 2014. **If you are currently receiving the discount, you will continue to receive it and you need NOT reapply.** To begin receiving the discount, complete the application form below if you qualify for this program. Any resident who was granted a Clause 41C elderly exemption on FY14 real estate taxes will receive a 30% discount, not to exceed \$180 per year. The City automatically grants this discount where applicable; therefore, you do not need to apply for it.
