Part I Total Crime

Serious crime in Cambridge has remained relatively unchanged for the first eleven months of 2015 when compared with the same time period last year. There have been just ten additional Part 1 index crimes reported in the City between January and the end of November of 2014. When measured against the 5-year average for the first 47 weeks of the year, a sizeable 12% reduction has been recorded.

Further analysis of the overall statistics for the first eleven months of this year indicates that violent crimes rose 2% with six additional incidents above the same time period last year. Property crimes, with just six additional incidents when compared with the 2014 numbers, remained unchanged.

The property crime of burglary has been the one statistical aberration to the relatively stable serious crime index. Burglary has incurred a 51% increase with 135 additional breaks reported. The surge in burglary this year should be tempered by the fact that the 2014 totals for this property crime in Cambridge were at their 50-year nadir.

Part I Property Crime

Analysis of property crime totals for the first eleven months of 2015 indicates an unchanged statistical scale when compared with the 2014 totals and a 11% drop below the 5-year average. The most significant fluctuation for this year is the 98% increase in the commercial burglary category. We are attributing this increase in commercial breaks to an upsurge in regional activity over the first six months of 2015. This trend appears to be reversing after declines of 57%, 43%, and 50% in commercial burglaries were recorded for the summer months of June, July, and August. The warm weather months typically are plagued with numerous larceny from motor vehicle and larceny from the person series. There was not a pattern for these crimes identified in Cambridge during the Summer of 2015. Larceny from the person (-40%) and larceny from MVs (-33%) have registered significant percentage declines below their 5-year averages.

Part I Violent Crime

The five-year weighted average for violent crime in Cambridge for the first eleven months of 2015 was projected to be 330 incidents. Through November 30th of this year, there were 274 violent crimes reported in the City, 56 serious violent crimes under the total forecast for this period (-17%) and 6 additional incidents above the 268 reported in 2014.

There have been five additional street robberies reported in Cambridge this year when compared with the same time frame in 2014, which translates to a 12% increase. The 5-year average for street robbery in Cambridge for the first eleven months of the year is 79 incidents. As of November 30th in 2015, 48 street robberies have been counted, which translates to a 39% decrease below the projected total. The street robbery total in 2014 was the lowest in Cambridge in 50 years.

There have been three murders in Cambridge during the first eleven months of 2015 as compared to two during the same time period last year. Rape has dropped by two incidents over the first eleven months of 2015, down from 30 in 2014 to 28 so far this year. There have been four more aggravated assaults this year than in the same time period of 2014 to produce a 2% rise.

MURDER

No Patterns

- There have been three murders in Cambridge during the first 11 months of 2015:
- On April 14th, 2015, Carlos D. Colina was arraigned in Middlesex District Court and was charged with the murder of Jonathan Camilien, 26, of Somerville. This was the first murder of 2015 in Cambridge. Colina was indicted in Superior Court on June 11th, 2015, on charges of murder and improper disposal of human remains after the victim's dismembered body was found in Kendall Square in April.
- On August 24th, Roosselin Altidor, 25, of Medford was arraigned in Cambridge District Court on a charge of murder in connection with a homicide in Cambridge on Wednesday, August 12. Rasaun Nichols, 31, of Cambridge, was killed by gunshots while in a vehicle in the area of Newtowne Court. This incident was the second homicide of 2015.
- Antwan Gonsalves, 33, of Cambridge was arrested on September 24th and charged with murder in connection with a homicide that involved a stabbing in Central Square on the night of September 12, 2015. This incident was the third homicide of 2015 in Cambridge.

Update on 2009 Murder Conviction: Clyde Howard, 71, was convicted by a Middlesex Superior Court jury on first-degree murder and gun charges in February 2011 for killing co-worker Maurice Ricketts, 33, of Malden, during a workplace dispute on Jan. 28, 2009. In October 2014, the Supreme Judicial Court overturned the murder conviction on appeal, but left the prosecution the option of a retrial. On October 1st, Howard once again was convicted on the charge of first-degree murder, the second time he was convicted for the crime.



Unsolved Murders: 1999 to 2015

Colin Burton, 30, of Dorchester, was shot and killed outside of Hi - Fi Pizza on Mass Ave in Central Square on September 18th, 1999. Burton was talking with the occupants of a Ford Explorer when the subject in the passenger seat fired through the window. Two suspects fled the scene. The case remains under active investigation.

Ian Gray, 19, of Mattapan, was in an argument outside of the Rhythm & Spice restaurant that spilled out onto Mass Ave. A suspect that had left the scene returned with a group of people and a fight ensued. A knife was produced during the altercation and four gunshots were fired, fatally wounding Gray. This case remains open.

On June 17th, 2002 at 7:00PM, **Ricardo Williams**, 27, of Malden, was found in the driver's seat of a motor vehicle suffering from a gunshot wound to his face. Williams was taken to CCH where he was pronounced dead. This case remains open.

Unsolved Murders: 1999 to 2015

Jason Ellcock, 33, of Malden, formerly of Cambridge and father of three, was found with multiple gunshot wounds in front of the driveway to 364 Rindge Ave at 3:05 AM on the night of June 16th, 2009. He was pronounced dead at the scene. This incident remains under investigation.

James Lauture, 30, of Cambridge, was sitting in a vehicle near Brookline and Watson Streets just after midnight on Saturday, March 12th, 2011, when an unknown gunman opened fire. The occupants in the car were able to drive to Central Square. Lauture died from multiple gunshot wounds. The other man in the vehicle survived. This case remains open.

On June 3rd, 2012, **Charlene Holmes**, 16, of Cambridge, was shot while sitting on a porch on Willow St. She later succumbed to her wounds at the hospital. The investigation into this incident remains active, but no arrests have been made to date.

On July 3rd, 2014, at 10:00 PM, **Kensley David**, 22, suffered a single gunshot wound to the head while on Windsor Street. Investigators believe that the incident was not random. This case remains under investigation

RAPE

No Patterns

- There were 28 rapes reported in Cambridge during the first 11 months of 2015, two fewer than the 30 incidents that were reported over the first 11 months of 2014.
- The following is the breakdown of Rape classifications in Cambridge so far in 2014: one stranger-to-stranger, fifteen involving acquaintances, six contact situations, one domestic sexual assault, two blitz scenarios, and two incidents that are still under investigation and have yet to be classified.
- The only stranger-to-stranger incident reported so far in 2015 involved the following case: there was a blitz attack reported in the early morning hours of 7/24/15. A woman reported that she was the victim of an attempted sexual assault in West Cambridge. The victim was walking home from a friend's house alone. The victim was able to fend off the attacker and the suspect fled the area. Cambridge Police Department detectives are actively investigating this incident. A citywide alert was issued in response to this incident.



AGGRAVATED ASSAULT

No Patterns

- When comparing the total of aggravated assaults for the first eleven months of 2015 with the same time frame last year, there has been a small increase of 2% registered, with 4 additional incidents. The total of 172 aggravated assaults reported so far in 2015 is 27 incidents below or a 14% decline from the 5-year average of 199 crimes for the time period of January 1st to November 30th.
- Aggravated Assaults dropped from 21 incidents in October down to 9 violent crimes during October. The nine aggravated assaults during October included: two fights at the time of bar closings in Central Square; four domestic assaults in the lower half of the City; two road rage incidents centered around parking issues in Harvard Square; and two incidents that were categorized as unprovoked.
- Domestic assaults, which typically make up from 35% to 40% of the aggravated assault total in Cambridge, are accounting for 28% of the total thus far in 2015.



ROBBERY

No Patterns

- The five-year average for overall robbery in Cambridge for the first 11 months of the year is 102 incidents. From January 1st to November 30th of 2015, 71 robberies were recorded, which indicates to a 30% decline below the projected total and a slight increase in the numbers (+4%) when compared with the 68 reported during same time period last year.
- Commercial robbery has dropped 8% when measured against with the first 11 months of 2014, with two fewer incidents reported. The robbery on 6/1 at the East Cambridge Savings Bank in Porter Square was the first bank heist in Cambridge in 363 days. Since that incident there have been eight additional bank robberies recorded in the City. The suspects in seven of these crimes were note-passing robbers. Arrests or warrants have been issued in six of the bank robberies.
- The five-year average for street robbery in Cambridge for the first 11 months of the year is 79 incidents. Between January 1st and November 30th of 2015, 48 incidents were reported, revealing a 39% decline below the projected total. The street robbery total in 2014 was the lowest in Cambridge in 50 years.
- In June of 2015, there were 11 street robberies in the City. Four street robberies were then recorded during July. The astonishingly low total of one street robbery was reported in Cambridge for the month of August. September brought eight eclectic, unrelated robberies with no street robbery patterns identified during the entire Summer of 2015. There were 3 scattered and unrelated street robberies in Cambridge during October. Another exceptionally low total with only two street robberies in the City during November.



Three of the six street robberies in the City during September & October involved homeless robbing other homeless in the 500 to 600 blocks of Mass Ave in Central Square. Arrests were made in two of the incidents. In one of the robberies, the victim was wheelchair-bound. There was also a bike - jacking on Magazine St on 9.9.15.



Burglary

Continuing Patterns

- After recording a historic 50-year low watermark in 2014, the property index crime of burglary, the combination of residential and commercial breaks, has climbed upward 51% when measured against the first 11 months of 2014. Much of this rise can be attributed to a surge in commercial breaks from 47 incidents in 2014 to 93 between January and November 30th of 2015.
- The five-year average for overall burglary in Cambridge for the first 11 months of the year is 369 incidents. From January 1st to November 30th of 2015, 398 burglaries were recorded, which translates to an 8% increase above the projected total.
- Commercial break trends identified in 2015 consist of a series of construction site breaks in February, and a clustering of incidents in Porter Square, Huron Village, and Central Squares that have abated since the middle of March. There had been a sharp increase in thefts from offices in Central and Porter Squares during April and May of this year. No distinctive commercial burglary trends or patterns have been identified over the past 6 months.
- Housebreaks increased by ten incidents when comparing the totals from October and November. The majority of this increase can be traced to a series of daytime breaks in Mid-Cambridge over the second and third weeks of the month. There have been no new additions to this pattern of forced front door entries over the final eight days of November.






Geographic Breakdown of Housebreaks: 1.1.15 to 11.30.15



- **Larceny through the first 11 months of 2015 is down 7% (or 129 incidents) when compared with the same time frame in 2014.** The total of 1816 larcenies reported year-to-date remains 15% below the 5-year weighted average of 2142 incidents.
- **Larcenies from motor vehicles through November have decreased by 79 crimes, or 17%, from the number reported during the same time frame in 2014.** There are currently no patterns anywhere in the city.
- **Larcenies from the person continue their downward momentum. Through the first 11 months of 2015, this crime type is down 20% when compared with the same time frame last year, and is 40% below the 5-year average.** Only 12 incidents were reported citywide in November. Central Square, Harvard Square, and the Galleria Mall each experienced 3 incidents this month.
- **There have been 312 larcenies from buildings reported through November of 2015.** This is 7% (24 incidents) below the 336 incidents reported in 2014 and 11% below the 5-year average of 349. There are no patterns or trends of this crime type anywhere in the city at the present time.
- **Larcenies from residences continue to be on the rise, registering 21% (41 incidents) higher through November of 2015 than during the same time frame last year.** Just over 50% (121) of the 239 incidents to date have involved package thefts from residences. Thirteen thefts occurred in October and another seventeen were reported in November, which is up from previous months and is not surprising as the holiday season approaches and package deliveries increase. Year-to-date, Mid-Cambridge has seen the most by far with 33, followed by Cambridgeport with 18 and North Cambridge with 17. Thefts have been most prevalent on Monday, Wednesday, and Thursdays afternoons.
- **Year-to-date, there have been 349 bikes reported stolen in Cambridge, up 9% from the 320 reported through the first 11 months of 2014 and 1 incident above the 5-year average.** Despite the year-to-date increase, bike thefts saw a decrease from October to November, with 7 fewer incidents reported this month. However, the 22 bike thefts reported over the past four weeks is still relatively high for November, thanks to milder-than-normal temperatures. Mid-Cambridge saw the most activity in November with 5 incidents.





LARCENY From MV

No Patterns

- Larcenies from motor vehicles slipped from 455 thefts over the first 11 months of 2014 down to 376 incidents at the end of November of this year to register a 17% decline. The 5-year average for larceny from MVs in Cambridge through November 30th is 564 incidents. The 376 LMVs so far in 2015 translates to a 33% decline below the projected total.
- The Summer of 2015 was exceptionally quiet for a target crime that usually peaks during the warm weather months. The combined total of 63 LMVs in Cambridge for the months of July and August was an astonishingly low number. Warm weather weekends in Cambridge usually produce ten thefts from cars in the City. That number fell to an average of three incidents per weekend during the Summer of 2015. This trend has continued into the fall throughout the weekends of September, October, and November.
- While certain motor vehicle parts, such as tires, airbags and catalytic converters, have been targeted in surrounding communities in Greater Boston in 2015, few such thefts have occurred in Cambridge this year.
- There was a one-night spree in Area 4 during late October where a number of vehicles were entered by smashing windows. See the next slide for a surveillance photo of a possible suspect who was riding a bicycle and stealing loose items from glove compartments.
- Small clusters of thefts from unlocked vehicles at night were identified in Mid-Cambridge and West Cambridge during October.





Larceny of MVs: 1.1.15 to 11.30.15

At the present time, there are no operational patterns, series or hot spot concentrations involving larceny from motor vehicles in Cambridge. The Summer of 2015 was exceptionally quiet for a target crime that usually peaks during the warm weather months. The combined total 63 LMVS in Cambridge for the months of July and August is an astonishingly low number. Warm weather weekends in Cambridge usually produce ten thefts from cars in the City. That number fell to three incidents per weekend during the Summer of 2015. This weekend trend of little LMV activity has continued throughout September, October and November. Only 53 reported LMVs in the City since 10.1.15.

Close to 70% of the LMVs Citywide between January and April were in North Cambridge & Peabody. Over the next five weeks, directed patrols and the arrest of a pair of suspects from Somerville interdicted this activity. However, over the past six weeks activity has increased in this area.

During the first eleven months of 2015, there have been 64 LMVs in Cambridgeport: **11** in January, **4** in February, **9** in March, **9** in April, **8** in May, **6** during June and **7** in July. However, there were only **2** in August, **3** in September, **4** in October, & **1** in November. The majority of incidents have been on weekend nights with unlocked cars targeted.

On 10/23/15 at 5:30 AM, pictured suspect was observed breaking into six MVs on Washington St by smashing the right front windows, rummaging through MV contents, and fleeing on a bike.



- Larcenies from the person are down 40 incidents through the first 11 months of 2015 when compared with the same time frame in 2014. The total of 165 incidents reported thus far in 2015 is 111 incidents, or 40%, below the five-year average of 276. Incidents have decreased over the last four weeks when compared with the previous four weeks, with 9 fewer reported. All business areas throughout the city saw similar activity in November with the East Cambridge area, Harvard Square, and Central Sq reporting 3 larcenies each and Alewife reporting 2 incidents.
- Very little pattern activity was seen in 2014, and this trend has continued throughout 2015. In past years, much of the larceny from person activity was reported at bars and restaurants in the Squares (known as "dipper" activity). In October, there were six dipper incidents reported citywide, but in November only four incidents were categorized as such, with two taking place in Harvard Sq and one each in Porter Sq and Central Sq.
- Another trend we saw during the warmer months this summer were thefts at parks while victims' belongings were left unattended. No patterns developed.
- There was one arrest made in Harvard Square in October of a female who stole items from a patron's purse while she left it outside a dressing room, per store policy. No arrests were made in November but suspects were developed in two of the incidents.





LARCENY: of Bicycle

No Patterns

- Through the first 11 months of 2015, there have been 349 bicycles reported stolen citywide in Cambridge. This is 29 incidents above the 320 thefts reported during this time frame in 2014 (+9%) and 1 theft above the five-year average of 348.
- Due to the record-breaking snowy and cold winter earlier this year, our numbers were understandably low prior to May. In fact, likely because of the weather, not a single bike theft was reported in February, and only 4 were reported in March. With the turn of the weather, numbers jumped to 14 thefts in April, to 40 each in May and June, and reached a peak of 72 in July before taking a turn in August, slipping to 63 reported incidents. Bicycle thefts fell to 43 incidents in September and slipped another 13 incidents in October to post a total of 30. This trend has continued with November seeing 22 thefts. Neighborhoods that saw most bike thefts this month were Mid-Cambridge with 5, followed by Area 4, East Cambridge, Inman, and North Cambridge with 3 each.
- Hotspot areas can be found around Harvard, Porter and Central Squares.
- 71% (249) of the **349 bicycles stolen year-to-date in 2015 were locked at the time of the thefts.**





AUTO THEFT

No Patterns

- The projected 5-year weighted average for auto thefts through the first 11 months of the year is 120 incidents. With 121 thefts reported year-to-date, we are 1% above the average and 2% (two incidents) below the number reported during this time frame in 2014.
- There were 13 auto thefts reported in the past four weeks, which is up 3 incidents or 30% from the previous four weeks.
- As temperatures heated up over the summer, so did the thefts of scooters and motorcycles. From June 1st to August 3rd we had 35 auto thefts, and of those 35, only 7 were automobiles. The highest ranking neighborhoods for two-wheeled thefts during this time were Cambridgeport with 6, and Area 4 and Mid-Cambridge, each with 4. However, quite surprisingly, only 1 scooter was reported stolen in August. We would normally expect this decline to continue as the weather changes but September's numbers show that about half of the 12 thefts involved mopeds or motorcycles. October and November reports show that the scooter trend has finally ended with only four reported stolen during the past two months.
- Since the beginning of the year, the following neighborhoods have recorded the top number of auto thefts: Cambridgeport (18), North Cambridge (17), and each of the following have reported 13 thefts: Area 4, Inman/Harrington, and East Cambridge.
- Of the 121 cars stolen thus far in 2015, 70 (58%) have been recovered to date.




