

# Construction on Sidewalk/ Street Improvements to Meacham Road, Woodbridge Street, Shea Road, and Locke Street

## Construction starts the week of August 20, 2012

Dear Neighbors:

The City has awarded a contract for the reconstruction of Meacham Road, Woodbridge Street Shea Road and Locke Street to the Tasco Construction Company.

The contractor will begin to mobilize for construction during the week of August 20, 2012. Major construction activity will continue for approximately 3 months, with additional finish work to be scheduled for next spring, following a winter construction moratorium.

## What to expect during construction

General work hours will be 7AM to 4 PM, Monday-Friday. "No Parking" signs will be posted at least 24 hours in advance of construction; please be sure to check posted signs for exact dates and times. When work occurs directly in front of driveways or entryways, the contractor will coordinate access directly with residents.

### **Project Design**

The plans for this project, which incorporate neighborhood input received at a December 14, 2011 community meeting, include:

- Reconstructed sidewalks, pedestrian ramps, and roadways on all four streets;
- A new curb extension and a crosswalk on Meacham Rd at Locke St to better define the intersection;
- A curb extension on Locke St at Woodbridge St, which addresses existing access concerns, minimizes impacts on residential on street parking, and provides an opportunity for additional plantings;
- New "No Parking Here to Corner" signs at intersections; and,
- Additional street trees.

## **Sidewalk Material Selection Form**

It is the City's policy to replace existing sidewalks with the same material (concrete with concrete, brick with wire cut brick). However, during this project, homeowners will have the option of changing their sidewalk material as described in this form.

In considering the options for sidewalk materials, please be informed that concrete is the material most frequently used in the city and provides a relatively inexpensive, durable and easy to maintain accessible sidewalk.

*** Property owners may choose to have wire cut brick sidewalks instead of concrete sidewalks. However, this will cost the property owner \$ 135 per square yard in order to cover the difference i cost between concrete and brick. Payments can be made by cash, check, E-check, MasterCard or Discover. A 2.5% convenience fee applies to credit and debit card transactions and a \$2.00 flat fee applies to E-check transactions.
Please sign below before returning the form. In so doing, you affirm that:
I am the owner of the property in question and I understand that the cost of upgrading to brick is \$ 135 per square yard. If I have selected this option the City will calculate the cost based on the square footage and present the costs to me; I will indicate my acceptance by paying the full cost within 14 days of the date of the invoice. If my payment is not received by then, the City will replace my sidewall with the existing material.
