
First Phase of Construction Begins October 2012 Design Process for Future Phases Continues

## **Project Overview**

The Alewife Sewer Separation Project is a series of three contracts: Huron A, Huron B, and Concord Avenue, that are part of a court-ordered clean up of the Boston Harbor. These projects will eliminate the combined sewer overflows from each neighborhood to the Alewife Brook.

## What this means for your neighborhood:

- Improvements to stormwater quality discharges to Alewife Brook
- Upgrades to city and private underground utilities including sewer and drain, water, and gas
- Street and sidewalk improvements
  - New paving
  - Accessible sidewalks
  - Enhanced pedestrian safety

**Residential streets included in this project are:** Grozier Road, Hawthorne Park, Lakeview Avenue, Larch Road, Lexington Avenue, Malcolm Road, Poplar Road, Standish Street, Vassal Lane (Lakeview to Standish), and Worthington Street.

Construction on the Huron A project will take approximately 2 years to complete.

Pre-construction activities, including test pits, surveying, and mobilization of equipment will begin in October.

**Tree Hearing: Thursday, October 11,** 5:30pm, Cambridge Department of Public Works, 147 Hampshire Street As part of the Huron A Contract, 140 new street trees will be planted. There are unfortunately 5 existing street trees that are in declining condition and are being considered for removal. If removed, each of these locations will be replanted. Tree locations are: 117, 136, 147 Lakeview Avenue and 41, 49 Grozier Road.



#### HURON AVENUE CONCEPTUAL DESIGN

- Bicycle lane with buffer to parked cars
- New crosswalks added, safer business district crossings
- Vassal Lane Plaza to get Hubway and landscaping
- Elimination of some bus stops, moving other bus stops
- Minimal loss of parking along the corridor
- Changed parking regulations at the business districts
- New crossing islands at two locations, Lakeview signal removed
