NOTICE OF PUBLIC HEARING

The Planning Board of the City of Cambridge

will hold a public hearing on **Tuesday, May 7, 2024 at 7:00 p.m.**

held remotely (see below for instructions to participate)

on a Zoning Petition by Khalida Griffin-Sheperd, et al.,

to amend the Cambridge Zoning Ordinance in Section 11.206.1 "Affordable Housing Trust," Subsections 11.206.1 "Board of Trustees" and 11.206.2 "Receipt and Use of Funds and Property"

with the intent of adding two explicit additional purposes for the Trust's funding, requiring reporting of Trust business to the City Council, requiring payment of stipends for Trust members, requiring the Trust to include members affected by housing instability, and expanding the Trust board from 9 to 13 members.
