Harvard University requests a 5-year extension to the Temporary Certificate of Appropriateness for temporary office trailers and shed at 41 Winthrop Street, approved first in June 2012 and then extended in October 2014. These trailers are essential as work space for field staff and A/E teams supporting the ongoing renewal of the undergraduate dormitories in Harvard's River House area. To date, Harvard has successfully completed 5 House Renewal projects. The 6th project is a phased project currently in progress, anticipated for completion in late 2023. The shed continues to serve as necessary landscape equipment storage. Subsequent to the removal of the trailers and shed, Harvard will ensure that the fence and lawn at this site are restored to their pre-existing condition.
