Based on normal room insulation, average number of sun exposed windows and two person occupancy.

- 1. If heavily shaded, reduce cooling Btus required by 10%
- 2. If very sunny, increase cooling Btus required by 10%
- 3. Add 500 Btus per person for more than 2 people
- 4. Add 4,000 Blus if the area is a kitchen
