In application for a Certificate of Appropriateness, you will find enclosed in this document materials supporting the construction of an enclosed four-season patio at 98 Winthrop St. Cambridge, Ma.

COVID-19 and the underlying recession have erected an impassible obstacle in the continued operations of the local hospitality industry. In March, we started preparations for the inevitable difficulties the Fall to Spring seasons will bring to our business. At this time, we investigated all options for maintaining operations, with our only feasible solution being an increase to our enclosed seating footprint. In June, we consulted the Historical Commission, along with our Architects to explore the feasibility of enclosing the patio surrounding the restaurant.

This project targets 3 key considerations:

- 1. Providing continued business profitability
- 2. Improving the historical presence of the property
- 3. Providing a safe environment for patrons

Ultimately, we found replacing the current partially enclosed area was not finically viable and a fully enclosed patio is the only option for continued operations. In order to improve the historical presence of the property, we have engaged multiple architectural firms to design enclosures that are transparent, as to not obstruct the original structure, and to enhance the buildings presence without diluting its historical features. The enclosed patio will result in adequate spacing to adhere to social distancing guidelines, as well as eliminate the current and unflattering seasonal structures that are presently on the patio.

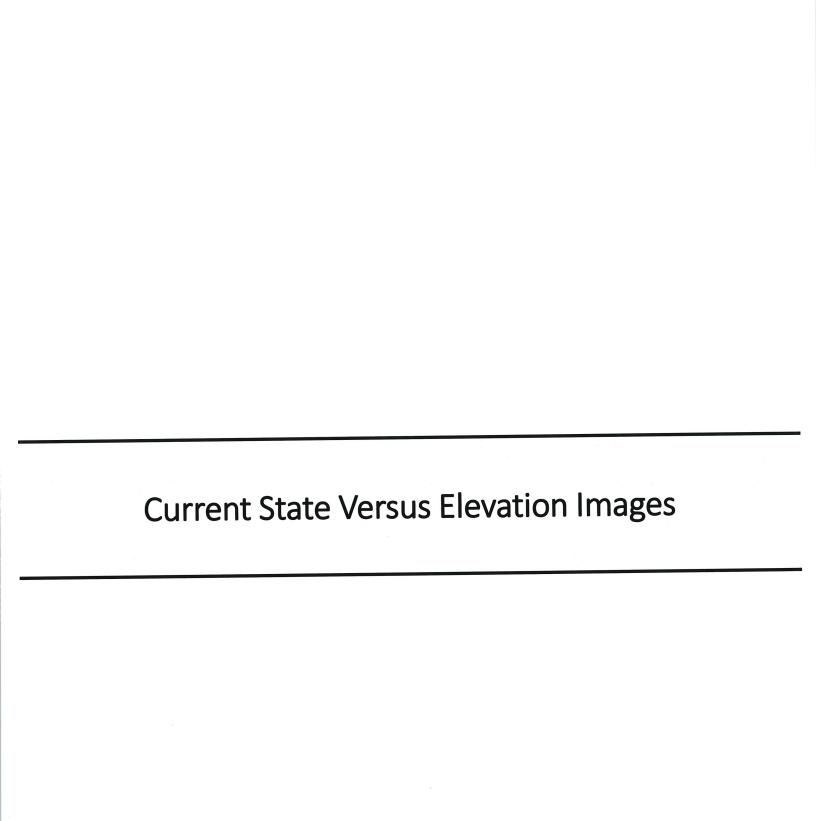


Fig 1 – The Red House Restaurant – Front View, 98 Winthrop - (*Present Day*)
