MARKA QALDAN EE LOO SHEEGO GURYAHA LA HELI KARO: Maamulaha hantida, milkiilaha, ama wakiilka hantida maguuraanka kuu sheego in abarmanka, guriga, ama kondomiiniyaha aan la heli karin iyadoo la heli karo.

MARKA LA DIIDO IN LA KIREEYO AMA LA IIBIYO: Marka maamulaha hantida ama aqoonyaanka hantida maguuraanka kuu diido in uu kaa kireeyo ama kaa iibiyo adiga.

MARKA LALA KULMO TAKOORKA QODOBADA IYO SHARUUDAHA: Marka adiga lagu siiyo qodob ama sharciyo ka duwan kuwa la siiyo dadka kale.

MARKA LAGUU DIIDO GURYAHA MACQUULKA AH: Marka maamulaha hantida kuu diido ka-dhaafidda sharciga ama siyaasadda taasoo qofka itaalka darran siin doonto siinaa uu ku isticmaalo kuna raaxeysto abarmanka.

MARKA LALA KULMO TAKOORKA: Marka lagaa hor istaago in aad dalbatid ama heshid deynta guriga, ceymiska milkiilaha guriga ama ceymiska kireystaha.
