**INVITATION TO BID**

The City of Cambridge, Massachusetts, the Awarding Authority, invites sealed bids for the project:

**Little Fresh Pond Shoreline Reconstruction**

**Nature and scope of work:** The major components of this work include, but are not limited to:

1. The project area is located at the south end of Little Fresh Pond adjacent to Fresh Pond within Fresh Pond Reservation. Access is adjacent to the Walter J. Sullivan Water Treatment Facility off of Fresh Pond Parkway north of the Huron Avenue intersection.
2. Southeastern shoreline access reconstruction includes:
  - a. Surface reconstruction for drainage and ADA compliance, including replacement of existing flexible porous surfacing (approx. 850-sf).
  - b. Access reconstruction includes replacement of existing cedar steps with terraced black locust timber stairs with footings and a granite ramp.
  - c. Timber and mesh fencing replacement (approx. 265-lf).
3. Reconstruction of approximately forty-eight (48) linear feet of granite curb at Kingsley Park, located adjacent to the Sullivan Water Treatment Facility (Add Alternate).

The estimated project value is: **\$195,000.00**

**Sealed general bids** will be received at the Purchasing Department, 5 Bigelow Street, Cambridge, MA 02139 during normal business hours prior to **2:00 PM on Thursday, August 17, 2023**. All general bids will be publicly opened and read aloud at City Hall 795 Massachusetts Ave, Ground floor Conference room, Cambridge, MA 02139.

**Sealed general bids being delivered via USPS** may be mailed to: City Hall 795 Massachusetts Ave, Cambridge MA 02139 Attn: Purchasing.

**Bids not delivered directly to the Purchasing Department** may be dropped off to a grey locked drop box labeled "Purchasing" located at the rear entrance of City Hall. The box will be checked at the scheduled submission deadline.

All general bids shall be accompanied by a bid deposit in the form of a certified, cashier's

or treasurer's check (**NO CASH**) issued by a responsible bank or trust company made payable to the City of Cambridge or a bid bond, in an amount not less than five percent (5%) of the value of the bid.

The successful general bidder will be required to furnish a Performance Bond, a Labor and Material (Payment) bond each for one hundred percent (100%) of the contract sum. Bonds shall be obtained from a surety licensed to do business in the Commonwealth of Massachusetts and the form shall be satisfactory to the City of Cambridge.

The City of Cambridge reserves the right to reject any or all bids if it is in the public interest to do so.

No less than the prevailing wage rates as set forth in the schedule contained in the Contract Documents must be paid on this project.
