1. A sign-in sheet was distributed. A copy is attached to these minutes.

- 2. Cambridge Water Department (CWD) and CDM Smith attendees were introduced. The Prebid Meeting Agenda (attached) was reviewed.
- 3. Key bidding dates are specified in the contract documents and in the Agenda. The project is being bid under Ch. 149, requiring an Electrical DCAMM certified contractor to act as the General Contractor. There is one Add Alternate for improvements to the Dissolved Air Floatation (DAF) Control System. There are no filed sub-bids.
- 4. The objectives of the project were discussed:
 - a. The Walter J. Sullivan Water Purification Facility (WPF) SCADA system has not been updated since initial installation in about 1999, when the WPF was first placed online. The work includes the addition of a SCADA Room and upgrades to control panels throughout the facility.
 - b. The SCADA Room is to be constructed within the existing Control Room and with a dedicated air-conditioner.
 - c. Every main Control Panel system is being upgraded as part of the Base Bid project except for the Ozonation system and the Plate Settler system. Upgrades to the Control Panel of the DAF system is being bid as an Add Alternate. Improvements to the subject systems are for communications only.
 - d. Discussion on MOPO (maintenance of plant operations) included the following:
 - i. Section 011216 outlines the criteria, sequencing, and constraints to allow Maintenance of Plant Operations (MOPO).

- ii. The drinking water supply to the City must remain operational during this project. Temporary downtime from the facility's online hours can be requested using the approach outlined in the specifications. Downtime should be limited and requires coordination with the Owner.
- iii. For PLC conversions, Rockwell's conversion chassis system is to be used to reduce downtime and errors.
- e. The construction period is 24 months.
- 5. The meeting was followed by a tour of the WPF.

4. Maintenance of Plant Operation (MOPO):

- Contractor is required to develop a workplan for phasing of project as part of Maintenance of Plant Operations (MOPO) required in Section 011216 Construction Sequences and Constraints.
- Owner will occupy project site building(s) during entire construction period. Cooperate with Owner during construction to minimize conflicts.
- On-Site Work Hours: 7AM-3PM, Monday through Friday, unless modified hours are approved by Owner.
- Downtime defined as reduced treatment or pumping capacity from normal operations of 24MGD or inability to operate the facility from SCADA in automatic mode.
- Downtime shall not last more than 8 hours in a 24-hour period and must take place no more than once in a 24-hour period after Notice of Need is approved.
