#### EVENTS & MEETINGS

- **Developing Resiliency** – September 11, 11:45 am to 1:30 PM, Brown Rudnick, One Financial Center, Boston. The Boston Chapter of the Urban Land Institute will present two new reports. One is titled *Developing Resilience: Living with Water Strategies for Greater Boston*, which is a follow up to *The Urban Implications of Living with Water* report released last year. The other is *Advancing Resiliency in East Boston*, which is a technical assistance panel report prepared in partnership with the Neighborhood of Affordable Housing (NOAH) and the Kresge Foundation. - **Net Zero Police HQ in Cincinnati** – September 15, 8:30 to 10:00 am, 50 Milk Street, 15<sup>th</sup> floor, Aristotle Conference Room, Boston. ## NEWS

- **Citywide Plan Consultant Selected** – Utile Architecture & Planning has been selected as the lead consultant for the Citywide Plan, which will kick off this year. Utile will lead an interdisciplinary team. [[Cambridge CDD news release, 8/21/15](#)]
- **State Climatologist Office Created** – This year's state budget establishes the Office of the State Climatologist with \$200,000 of funding. The Legislature overrode Governor Baker's veto to bring this initiative to fruition. It was one of the elements of Governor Patrick's climate change adaptation strategy. Massachusetts is one of only three states in the U.S. not to have a state climatologist. The State Climatologist will advise state and local government about the Commonwealth's climate and its implications for the economy, natural resources, and population. - **Mapdwell Solar System Expands to New York City and San Francisco** – The Mapdwell Solar System platform, which first developed as an interactive solar tool for Cambridge, has expanded to New York City and San Francisco. Mapdwell is the most accurate rooftop solar modeling tool available. It enables users to estimate the amount of solar photovoltaic potential a roof can host taking into account weather, building orientation, roof pitch, shading, and other factors. The tool also provides a detailed cost estimate taking incentives into account and other outputs such as environmental benefits and comparisons to other investment options. In addition to modeling of individual rooftops, the platform also provides aggregated results. The New York City version found that over 1 million buildings in the city have over 11 gigawatts of solar energy potential and could generate more than 13 million megawatt-hours of electricity annually. The Mapdwell tool grew out of research at the MIT Sustainable Design Lab. In addition to the two new cities, the Mapdwell platform is available in Boston and Orleans, Massachusetts; Washington County, Oregon; Washington, DC; Boulder, Colorado; and Vitacura and Lo Barnechea, Chile. ## RESOURCES & IDEAS

- **Job: Associate Energy Planner** – The City of Cambridge is seeking candidates for an Associate Planner position in the Community Development Department, who will work on implementing key elements of the Cambridge Net Zero Action Plan. - **Understanding Energy Use in Cities** – US Department of Energy [Cities Leading Through Energy Analysis & Planning \(Cities-LEAP\) project](#) provides a tool for a sample of 20 large cities, including Boston, to understand building energy use to inform strategy and planning.
- **FEMA and Climate Change** – Interesting [article from the New England Center for Investigative Reporting](#) about how FEMA continues to treat climate as being static in their emergency response and planning.
- **How Cities Can Beat the Heat** – [How Cities Can Beat the Heat](#) is an article in *Nature* about how cities are trying to address vulnerabilities to rising temperatures, but also how some actions may be getting ahead of the science.
- **U.S. Heat Exposure Could Quadruple** – According to the National Center for Atmospheric Research, the exposure of the U.S. population to extreme heat could quadruple by mid-century. The study looked at the number of days the population would be exposed to 95 degrees or higher. The analysis doesn't seem to taken humidity into account and it doesn't assess whether those exposed are vulnerable to health effects. [[NCAR news release, 5/18/15](#)]
- **Cambridge Climate Change Vulnerability Assessment** – The City is working on preparing a vulnerability assessment that will serve as the foundation for a climate change preparedness plan that will follow. The

- **Cambridge Solar Map** – The [Cambridge Solar Tool](#) provides a web-based interactive tool to find out the potential for installing solar photovoltaic systems on rooftops in the city. The tool also evaluates the financial feasibility of installations and makes comparisons to alternative investments. The tool is designed by Mapdwell and based on the research of the [MIT Sustainable Design Lab](#) led by Dr. Christoph Reinhart. The City's [Cambridge Energy Alliance](#) program can assist interested property owners with finding installers and understanding the financial aspects. The Mapdwell tool was upgraded in September 2015 and can now be viewed in Spanish.
- **Opt Out of Unwanted Mail** - Do you get unwanted mail from retailers, credit card companies, or cable/phone companies? You can opt out of mailings from over 4000 companies with Catalog Choice and help reduce waste. For example, you can stop getting weekly circulars from Global Direct, they will honor opt-out requests, so add them to “your choices”. Just register for FREE at <https://cambridge.catalogchoice.org> to create an account to start cleaning out your mailbox. To date, over 3700 Cambridge residents have signed up and opted out of nearly 25,000 different unwanted mailings!
- **MBTA Rider Tools** – The MBTA has a number of [rider tools](#) that help riders to anticipate arrival times of buses, subways, and commuter trains and to receive alerts of delays. These tools can be used on iPhones, Android phones, text messages, emails, and the Web. There is also a trip planning tool.
- **Cambridge Energy Alliance** – The [Cambridge Energy Alliance](#), a program of the City of Cambridge Community Development Department helps residents, businesses, and organizations to obtain energy efficiency and renewable energy services. You can sign up for energy audits and ask questions through the energy advisor service.
