- Speed hump pilot program starting this fall:
 - Dover Street 1 speed hump between City Line and Mass Ave
 - Lakeview Avenue 2 speed humps between Malcolm Rd and Worthington St
 - Field Street and Garden Street (near Universal Playground) 2 speed humps on Field St between Fern St and Alpine St and 1 speed hump on Garden Street near Alpine Street
 - Reservoir Street 1 speed hump between Huron Ave and Vassal Lane
 - Walden Street 2 speed humps between Vassal Lane and Concord Ave
 - Click here to request speed humps
- Participatory Budgeting:
 - Idea collection for participatory budgeting concluded October 12
 - In the proposal development stage
 - Voting will occur in March 2026

Transportation Planning Division Projects

- <u>Linear Park</u> will begin construction soon:
 - Finalizing topics with the contractor schedule
 - Finalizing work plan approvals with the MBTA
- Pedestrian and Bicycle Bridge over the Fitchburg MBTA rail
 - Received \$500,000 in additional design funding during the <u>10/9/2025 MPO meeting</u>
- Bluebikes
 - Station updates:
 - Vassal Lane Second VLUS station (new station installed!)
 - MIT at Mass Ave / Amherst St (returning imminently with +4 docks)
 - 125 Cambridgepark Drive (new station launching TBD)
 - Craigie St at Brattle St / Sparks St (new station proposal being considered by the Cambridge Historical Commission at the public hearing portion of the 11/6 meeting)
 - Mt Auburn (temporarily relocated; return TBD)

Street Management Division Projects

1. Broadway (Portland St to Quincy St)

- Section A (Portland St to Columbia St) is mostly complete with green and bike symbol markings ongoing
- Section C (Quincy St to Ellery St) open house Dec 2025

2. Aberdeen Ave

- New lines have been installed
- Bike symbols, green, and flex posts over next few weeks

3. Cambridge St (Prospect St to Second St)

- Utility and pavement assessment ongoing to inform design
- Section A (Prospect St to Willow St) to begin in spring 2026 with open houses winter 2026
- Project Working Group Meeting held August 27, materials are on project webpage

4. Main St (Central Sq to Portland St, Tech Sq to Albany St)


Bike symbols and green over next few weeks


Public Works Projects

Timeline and considerations

- Current terms expire February 26, 2026
- Terms start and end in February
 - March 2026 is the first meeting of the next iteration of the Bicycle Committee



Current member interest & new member need

mid October – mid November Application promotion, collection, & review

mid November – mid February Interviews & member selection

February - March

New member onboarding

March 2026 - onwards

Next steps

- Determine the need for a call for new members:
 - Who is eligible?
 - Any existing member who has not served 5 consecutive 2-year terms (10 years)
 - What other considerations?
 - Regular attendance is required to maintain membership
 - Members must have an approved leave of absence if absent more than three consecutive meetings
- Seek new member applications, if needed:
 - Open to anyone with an active interest in biking issues in Cambridge and must live or work in Cambridge
 - CamDOT staff work with Community Engagement Team to encourage applications. We strive for a diverse committee by demographics and home or workplace geography

Scope for a future discussion with CPD

- General notes from last month's meeting:
 - Goal of random enforcement, red lights, bike lane blocking, etc.
 - Training officers about crashes involving bicyclists
- Request drafted during this meeting:
 - Request for recurring CPD presence in monthly Committee meetings, including recurring monitoring of select locations
 - Data request for how frequently officers are assigned for motor vehicle or bicycle enforcement
 - What more can be done about motor vehicles parked in bike lanes? For example, submitting photos, etc.
 - Response time and officers' role in responding to bike crashes, including assigning fault
 - Provide an overview of training materials and practices to guide enforcement




