

## Cambridge Department of Transportation Project Updates

## **Transportation Planning Division Projects**

- Linear Park construction anticipated for August
  - Temporary park and path closure from Russell Fieldhouse to the city boundary behind the bus yard. Park will re-open in mid November 2025.
  - Additional temporary closure anticipated for early spring 2026. We'll share more information in early 2026 through the Linear Park newsletter.
- Fitchburg Railroad Pedestrian and Bicycle Bridge
  - City awarded \$2 million in design pilot grant funds from the Metropolitan Planning Organization
  - Funds were appropriated at the <u>June 23, 2025, City Council meeting</u>

## Street Management Division Projects

#### 1. Broadway (Portland St to Quincy St)

- Paving work is complete (Portland to Columbia).
- Section A Installation begins Monday, June 30th (<u>installation updates</u>)
- Working Group Meeting 4 on July 29, 2025, focusing on two potential plans for Section C (Ellery to Quincy)

#### 2. Aberdeen Ave

- Paving delayed; installation TBD
- 3. Cambridge St (Oak St to Second St)
- Prospect St to Willow St open house TBD

#### 4. Main St (Central Sq to Portland St, Tech Sq to Albany St)


- Paving work is complete. Installation tentatively to begin we July 7<sup>th</sup> (<u>installation updates</u>)
- Final community meeting and open houses took place midto-late April. Materials posted to the website.

#### 5. Waverly St, Brookline St

- Adding buffers and flex posts to sections of the street leadir and from BU Rotary (<u>final plans</u>)
- Installation began this week

#### 6. Vassar St (Memorial Drive to Amherst Alley)

Installation late summer 2025



## Cambridge Department of Public Works Project Updates


**Public Works Projects** 

#### 1. Harvard Square Kiosk and Plaza

- · No change since May update
- Ongoing plaza work through November 2026
- 2. River St (Memorial Dr to Mass Ave)
- No change since May update
- Ongoing utility work
- Full-depth roadway reconstruction begins June:
  - River St: Mass Ave to Franklin St
  - Green St: River St to Pearl St
  - Magazine St: Green St to Franklin St
- Carl Barron Plaza: installation of subsurface tree irrigation and aeration continues

#### 3. Mass Ave Partial Construction

- Began sawcutting and median removal from Shepard St to Waterhouse St
- 4. Garden St Gas Main Replacement
- Gas work wrapping up in 4-5 weeks
- Paving to be coordinated with any Garden St design change:



## Public Works Projects, cont.

#### 5. Chapter 90 Contracts 24 & 25

- Chestnut St Raised intersection at Magazine St. Detour in
- Maple Ave curb and sidewalk work
- Dana St water main work

#### 6. Chapter 90 Contract 26

- Community meetings are complete
- Phasing of the eight streets between 2025 and 2026 still bei discussed

#### 7. Port Infrastructure Improvements

- Phase I Utilities/Streets/Sidewalks to begin construction Fal (Multi-year project – more details to come)
- Clement Morgan Park Reconstruction to begin fall 2025

#### 8. Broadway (Galileo Galilei to Third St)

- Broadway interim conditions between Galileo Way and Third to utility work through 2026:
  - Walking: detour on south side
  - Biking: 2-way bikeway on the south side
  - Driving: one-way eastbound only on the south side

## Safety Study the City

Purpose Why this topic?	Walking in Cambridge is generally good, but many walks are negatively affected by a particular trouble spot
Outcome What is the end goal / deliverable?	An inventory of trouble spots to share with City staff to improve safety and efficiency of walking in the city
Process How will the subcommittee get there?	Solicit input from committee members on locations and challenges. Systematic review and improvement of trouble spots. Flag locations and challenges with City staff. Track outcomes.
