seeking special permits pursuant to Amendment of previously approved special permits for Project Review Special Permit (19.20) and provision of required residential parking off-site (Section 6.22.2)

for a proposal to Amend PB-301 to update the shared parking between PB-118, PB-189 and PB-301 to lease up to 250 parking spaces in the existing garage at 303 Third Street for commercial use.
