## NOTICE OF AFFORDABLE HOUSING OVERLAY ADVISORY DESIGN CONSULTATION PROCEDURE

The Planning Board of the City of Cambridge

will hold an advisory design consultation on **Tuesday, January 4, 2022 at 6:30 p.m.**  
located at Remote participation on Zoom (see details below)  
on affordable housing overlay case AHO-1  
for the property located at **52 New Street**  
for which the developer is Just A Start  
pursuant to Section 11.207 Affordable Housing Overlay  
for a proposal to Construct a six-story building with 129,230 square feet of Gross Floor Area that includes 107 affordable apartments and 3,000 square feet of commercial space with 43 off-street parking spaces, 112 long-term and 12 short-term bicycle parking spaces.

The Planning Board will hear a presentation of the proposal from the developer and comments from the public. Comments may be sent in advance in writing or made at the meeting (see instructions below).

The purpose of the advisory design consultation is for the Planning Board to comment on the proposal in relation to Section 11.207 of the Cambridge Zoning Ordinance and the City's development guidelines and objectives. This will be the second of two required advisory design consultation meetings.
