



Figure 1L.6b: Block Guidelines - P1
 Healthpeak PUD Master Plan | Cambridge, MA






Figure 1L.7a: Block Guidelines - C1





Figure 1L.7b: Block Guidelines - C1





Figure 1L.8b: Block Guidelines - C2
 Healthpeak PUD Master Plan | Cambridge, MA




Figure 1L.9a: Block Guidelines - C3





Figure 1L.9b: Block Guidelines - C3




Figure 1L.10a: Block Guidelines - P2





Figure 1L.10b: Block Guidelines - P2




Figure 1L.11a: Block Guidelines - C4





Figure 1L.11b: Block Guidelines - C4
 Healthpeak PUD Master Plan | Cambridge, MA




Figure 1L.12a: Block Guidelines - C5





Figure 1L.12b: Block Guidelines - C5




Figure 1L.13a: Block Guidelines - C6






Figure 1L.13b: Block Guidelines - C6





Figure 1L.14b: Block Guidelines - R1




Figure 1L.15a: Block Guidelines - R2





Figure 1L.15b: Block Guidelines - R2
 Healthpeak PUD Master Plan | Cambridge, MA




Figure 1L.16a: Block Guidelines - C7





Figure 1L.16b: Block Guidelines - C7





Figure 1L.17b: Block Guidelines - C8




Figure 1L.18a: Block Guidelines - P3
 Healthpeak PUD Master Plan | Cambridge, MA





Figure 1L.18b: Block Guidelines - P3
 Healthpeak PUD Master Plan | Cambridge, MA






Figure 1L.19a: Block Guidelines - R3





Figure 1L.19b: Block Guidelines - R3
 Healthpeak PUD Master Plan | Cambridge, MA




Figure 1L.20a: Block Guidelines - R4





Figure 1L.20b: Block Guidelines - R4
 Healthpeak PUD Master Plan | Cambridge, MA




Figure 1L.21a: Block Guidelines - R5





Figure 1L.21b: Block Guidelines - R5




Figure 1L.22a: Block Guidelines - R6
 Healthpeak PUD Master Plan | Cambridge, MA





Figure 1L.22b: Block Guidelines - R6
 Healthpeak PUD Master Plan | Cambridge, MA






Figure 1L.23a: Block Guidelines - P4





Figure 1L.23b: Block Guidelines - P4
 Healthpeak PUD Master Plan | Cambridge, MA






Figure 1L.24a: Block Guidelines - R7





Figure 1L.24b: Block Guidelines - R7





Figure 1L.25a: Block Guidelines - R8





Figure 1L.25b: Block Guidelines - R8
