Qorshe Samaynaya



Cusboonaysii xidhiidhada dugsiga: xaqiiji inaad haysato macluumaadka saxda ah ee kala xidhiidhka ee dhawr qof oo aad aaminsantay si ay canugaaga uga soo qaadaan dugsiga hadii aanad awoodin. U sheeg dugsiga aad rabto inaad "ka-baxdo," ee ku jira diiwaan macluumeed kasta oo uu dugsigu galiyay si looga saaro oo loo ilaaliyo macluumaadkaaga.

Ku diwaangeli dhalashada ilmahaaga qunsuliyadaada ajaanibka ah: haddii ilmahaagu rabo inuu u safro ama u guur wadankaaga hooyo, way fududaanaysaa hadii dhalashadooda hore looga sii diiwangaliyay qunsuliyada.

Baasaaboorka u dalab canugaaga: dawladaha badankoodu waxay u baahanyiin in labada waalidba ay bixiyaan ogolaansho si canugoodu u helo baasaaboorka. Haddii aad haysato haynta sharciga ah ama amar maxkamadeed oo gaar ah uma baahnid ogolaanshaha waaidka kale.

Who can give me advice and represent me in an immigration application or case?



An **attorney (lawyer)** with a valid license to practice law.



An “**accredited representative**” working for a nonprofit organization who has received training and special authorization from the US government to help people with immigration cases. You can look for the organization and the individual on the government’s [listing](#) of accredited representatives.



Notary publics (or “notarios”) are not lawyers in the US and cannot provide legal advice.



Other people like interpreters or tax preparers. Interpreters can help translate important documents sometimes needed for immigration cases and preparers can fill out the form with only the information provided by the applicant, but they cannot provide legal advice.^{3,4}
