#### **Instructions for Providing Public Comment During CCPD Meetings via Zoom**

Anyone wishing to address the Cambridge Commission for Persons with Disabilities (CCPD) during the Public Comment section of the agenda may indicate that by "raising their hand" virtually within the Zoom platform. The host (CCPD staff) will call on members of the public to speak in the order in which their hands were raised. Please note that while you may raise your hand at any point during the meeting, you will not be called on to speak until the Public Comment period of the meeting.

#### To raise your hand:

- On a Mac or PC:
  - Click "raise hand" in the webinar control panel
  - Alternatively, you may you the keyboard shortcut to raise and lower your hand:
    - Windows: press "Alt+Y"
    - Mac: press "Option+Y"
  - When you are called on by the host to speak, you will be prompted to unmute your microphone (you must unmute yourself, as the host does not have the ability to unmute individuals).
  - After you have spoken or once your 3 minutes are up, your microphone will be muted by the host
- If you are calling in by phone:
  - Press \*9 to raise and lower your hand
  - When you are called on to speak during the public comment period, you will need to press \*6 to unmute yourself (press it again to mute yourself)
    - Note: your phone number will be visible to only the host of the meeting (CCPD staff). Because your name will not be displayed, we will call on you when it's your turn to comment by using the last four (4) numbers of your phone number to identify you. For example, "The person calling in from the number ending in ####, you may now provide public comment."
    - After you have spoken or once your 3 minutes are up, your microphone will be muted by the host

Once they have the floor, members of the public are asked to identify themselves, and each speaker is limited to not more than three (3) minutes. Although the public comments should, whenever possible, address one or more items on the agenda for that particular meeting, if time permits, the Chair may allow a speaker to comment on matters that may not directly address an item on the agenda, but do concern the Commission.

### Minutes for Thursday, August 14, 2025 CCPD Meeting

Online via Zoom

Meeting was called to order at 5:43pm

#### **Present:**

#### **Announcements:**

Rachel announced that Keisha has resigned from the Board. We are grateful for Keisha's energy and
contributions and also appreciate that Danielle has stepped up as Acting Chair. Nominations to fill Danielle's
previous role as Secretary will open up at the September CCPD Board meeting and elections will take place at
the October meeting.

#### **Approval of Minutes:**

- The May CCPD meeting minutes were unanimously approved.
- There were no June minutes because we did not have quorum for our June meeting.

#### **Retreat Debrief:**

Rachel Tanenhaus reported:

- The CCPD Board had a wonderful retreat in May at Dan's office facilitated by consultant Ora Grodsky—see the attached retreat notes for more information. The two main goals of the retreat were:
  - Improving meetings
  - Designating working groups for special projects
- The CCPD Board voted to approve the following three working groups, which were determined at the retreat:
  - Resource sheets working group
  - Cambridge Participatory Budget (CPB) working group
  - New member welcome packet working group
- Discussion of who would participate in which working group was postponed because several Board members were not present at this meeting
- At the retreat, Board members suggested that the Board move to hybrid meetings as soon as possible. A member asked when that might be feasible. Rachel is not sure when the 2<sup>nd</sup> floor conference room at 51 Inman Street will be available for hybrid meetings, but she will continue to keep the Board updated as she has more information.

#### **Chair's Report:**

• None.

#### **Staff Report:**

Rachel Tanenhaus reported:

- Reiterated thanks for Keisha's valuable work with the Commission and noted that three members' (Avril, Dan and Loring) term limits are coming up. Rachel reminded the Board that terms last for three years and members can serve up to two terms:
  - Once their second terms expire, Board members are permitted to stay on the Board until successors are appointed—Loring and Avril have confirmed they can stay on; Dan will let us know—Rachel emphasized how thankful we are for their work.
  - These Board members are welcome to join working groups until their successors are appointed.
     Working groups will continue even once their members drop off the Board as new members can join these groups as well—the groups/projects won't change but the people on them will.
  - We will have a total of 5 vacancies and are putting out a call for new Board members—once we get applications in, Emma has agreed to help interview candidates. The interview and selection process will likely take a few months.
- Rachel will not be at the September meeting (Maya and Kate will)—staff from the Cambridge Participatory Budgeting initiative will present.
- In June, CCPD participated in Cambridge Riverfest—both current and former board members attended so CCPD was well-represented! We also had a presence at Boston's ADA Day in July—the disability pride flag was raised over Boston City Hall for the first time ever, and we participated in a street march and a rally.
- In July, we did a social media campaign on disability featured on the City's social media accounts. Our posts
  received great engagement and we plan to continue to use the City accounts for our social media campaigns so
  they can reach a larger following.
- CCPD is involved with (not hosting) a disability pride event that will most likely take place on Saturday, October 4<sup>th</sup> from 11am-2pm at Joan Lorentz park in front of the library. The event will feature a silent disco, art by folks with disabilities, and food--more details TBA.
- Rachel gave a presentation for the Cambridge library staff about how libraries are a key resource for people with disabilities, and how librarians can better accommodate the disability community. The presentation was very well received!
- Mount Auburn hospital is hosting their <u>annual community benefits public meeting</u> on Thursday, September 18 from 3:30-4:30pm. They will provide updates on what the hospital is doing to benefit the surrounding community, featuring a presentation from Waltham Community Farms and the hospital's midwifery team, and celebrating their 2025 Community Health Needs Assessment.
- The <u>city's Cambridge Works program</u> is looking for people 18-35 who have struggled to find employment to apply for their next cycle, which starts in mid-September. Cambridge Works offers a 3-month paid internship placement at a local organization and well as coaching and job-search support to find permanent employment.
- Rachel participated in a focus group for Spaulding Hospital's Community Health Needs Assessment—Rachel
  provided perspective on the importance of meeting the healthcare needs of the disability community,
  something that Spaulding prioritizes given their work as a rehabilitation hospital.
- Rachel provided testimony regarding a Massachusetts Architectural Access Board (MAAB) variance request from the Sheraton Commander—Rachel felt some parts of the variance were reasonable while others could be addressed without variance, specifically concerning modifications to some of their rooms and the entrances to their restaurants.
- Rachel has been involved with the Massachusetts Emergency Management Agency (MEMA) Access and Functional Needs Working Group, as well as with a working group focused on heat resilience for people in Cambridge since climate change impacts people with disabilities most immediately.

• CCPD is in the process of transferring the reasonable accommodations process for City employees to the human resources (HR department). CCPD will continue to collaborate with HR and support this process, and Rachel feels very confident that the new HR leadership will prioritize the needs of employees with disabilities.

#### **Public Works Update:**

None.

#### **Public Comment:**

A member of the public expressed gratitude that the city has programs for adults and children with disabilities. They discussed feeling personally connected to CCPD's mission because they have loved ones with disabilities and asked about volunteer opportunities with CCPD. Rachel told them that while CCPD does not have direct service volunteer opportunities, we are putting out a call for new board members soon and passed along CCPD's email address. Additionally, Rachel noted there are local nonprofits serving people with disabilities that may offer more direct volunteer opportunities.

Meeting adjourned at 6:44pm.

# Participatory Budgeting

An Approach to Community-Led Decision Making and Engagement



### What is Participatory Budgeting (PB)?



Participatory Budgeting is a process where community members decide how to spend part of the City's budget to improve Cambridge.

PB gives real **people**, real **power**, over real **money**.

Cambridge residents have set aside over \$10.5 million to pay for 79 PB projects since the first PB Cambridge cycle in 2014.

### **PB12 Timeline**

Idea Collection

9/2025 - 10/2025

Cambridge community members brainstorm ideas for projects that improve the city.

Volunteer PB Delegates work to review, research, and develop submitted ideas to create the final ballot.

> **Proposal Development** 10/2025 - 2/2026


**City-wide** Voting! 3/2026


