TRC Environmental Corporation (TRC) performed daily ambient air monitoring at the above-referenced location on March 2-6, 2026, in accordance with the Massachusetts Department of Environmental Protection (MassDEP) approved Non-Traditional Asbestos Abatement Work Practices (NTWP) plan (MassDEP approval NNT25189). Monitoring for airborne fibers was conducted at eight (8) fixed ground level (breathing zone height) perimeter locations and two (2) elevated mobile locations. Monitoring at each mobile sampling location was performed at various heights from mobile aerial lift equipment located in the general proximity of the demolition activities on each monitoring date.

Samples were collected on 25-millimeter mixed cellulose ester filters in 3-piece cassettes in the open face configuration using vacuum pumps. A calibrated rotameter was used to determine air flow rates at the beginning and end of each sampling period.

Sample analysis was performed in accordance with the NIOSH 7400 Method, Issue 3, 06/14/19, Phase Contrast Microscopy (PCM). The analytical results indicate that airborne fiber concentrations at all the fixed and mobile air monitoring locations were less than 0.010 fibers per cubic centimeter (f/cc), which is the MassDEP approved acceptance criteria for this project and is also the Massachusetts Department of Labor Standards (DLS) PCM clearance criteria for asbestos response actions.

The daily air monitoring results, which are transmitted electronically to the MassDEP daily, are attached.
